Para 1.20	In 2021, One Acre UK continued its efforts to prevent and relieve poverty among Africa's chronically hungry smallholder farm families. The charity achieved this objective by raising donations from UK individuals and institutions to invest in the programs of One Acre Fund in Africa; which provide high-quality farm inputs and training, among other activities, to improve farmers' crop yields; which farmers in turn use to reduce hunger and poverty in their households. In 2021, the farmers reached by One Acre UK increased their farm yields and incomes by over 40% compared to farmers not enrolled in the program. Additionally, through its trustees, One Acre UK also provided important strategic advice to management in Africa to improve the effectiveness and efficiency of its programs and broader operations.
