## **Bliss Cavalier Rescue Annual Report Of The Trustees Year End 31<sup>st</sup> October 2021**

### **Charity Objectives**

Bliss Cavalier Rescue was established in July 2018. We are a breed-specific dog rescue for Cavalier King Charles Spaniels, and we additionally offer support and education to owners of the breed. Our core activities are directed toward improving the lives of Cavalier King Charles Spaniels by putting the health and welfare of the dogs in front of everything else.

Bliss Cavalier Rescue became a registered charity (no 1193078) on the 12<sup>th</sup> of January 2021.

Our services cover England and Wales and our online education work extends to Cavalier owners all around the world. We promote responsible ownership and adoption and ensure our adopters are supported throughout the dog's life.

We are in an unenvied position of caring for one of the unhealthiest dog breeds currently in existence due to the vast number of Cavaliers bred without any regard for their health, temperament, or welfare. The majority are bred on puppy farms or by breeders that don't health test or register their litters.

The Cavalier King Charles Spaniel commonly suffers from an extremely high occurrence of hereditary conditions including excruciatingly painful neurological conditions such as chiari malformation and syringomyelia. The Cavalier also has a very high prevalence of mitral valve disease, pancreatitis, hip dysplasia, luxating patella, dry eye, eye ulcers, ear infections, and brachycephalic airway obstruction syndrome (BOAS), and deafness. Cavaliers are also more likely to suffer from pyometra a life-threatening uterus infection, renal dysfunction, masticatory muscle myositis (MMM), flycatcher's syndrome, and Cushing's disease than other breeds. The Cavalier breed is susceptible to more than 25 inherited disorders.

### **The Bliss Standard of Care**

The Bliss Cavalier Rescue team are extremely experienced in the breed and continues to learn with monthly training, working closely with specialists in different fields, working with behaviourists and experiencing the many breed-specific conditions over and over.

We wholeheartedly believe that adopters of the dogs must be given the best chance of success by ensuring all health conditions are well managed and/or diagnosed prior to adoption, rather than any nasty surprises putting the adopter into extreme difficulty both emotionally and financially. By operating in this way dogs are not returned to rescue and adopters are not put into financial difficulty or distressing situations.

Every dog that arrives at Bliss Cavalier Rescue receives a high standard of veterinary care from breed-experienced vets. The health problems suffered by the breed are difficult and expensive to manage due to a high level of poor breeding practices and lack of health testing. Cavaliers are very expensive to purchase as puppies which makes them an attractive prospect for breeders, especially those that are not breeding with health or behaviour in mind.

We feel very passionately about the breed and are increasingly concerned by the multiple, very serious hereditary health problems the breed suffers from. We are a non-selective rescue and frequently take Cavaliers into rescue that other rescue organisations will not take due to poor health or behavioural problems.

We have a strict no-kill policy. We are extremely proud to report that no dogs have been put to sleep due to health or behaviour upon arrival in rescue.

### **Foster homes**

Our charity has a network of foster homes, Cavaliers would not do well at all in kennels. Fosterers check in daily with us and are given training and support throughout their foster journey.

Every dog is assessed for the best possible home following any veterinary treatment needed, training and rehabilitation. This can take time to achieve but we ensure each dog is as healthy as possible at the point of adoption to ensure adopters are set up for success.

We have discounts with the veterinary practices that we use and overall, their charges are very reasonable. Sadly, the reason our veterinary costs are high is due to the plethora of health conditions that Cavaliers have and the amount of ongoing care that they need. Thankfully we do get fantastic outcomes for the dogs and work very hard to fundraise for their care.

The Cavaliers are groomed in-house by volunteer groomers, so we have minimal grooming bills for the charity to pay. This saves many thousands of pounds throughout the year, and we are very grateful for this.

Bliss Cavalier Rescue has an amazing, dedicated team of supporters and fundraisers. We are incredibly lucky. Owners know how difficult it is for our charity, with many being Cavalier owners and their own dogs suffering from the same expensive health problems that the rescue dogs have.

### **Staff and volunteers**

We have one part-time employee that carries out administration and communicates with the public. We have a total of 34 volunteers helping with fostering, administration, events, home checks and adoption assessments and transporting dogs. We are extremely grateful to everyone that volunteers to help us, we could not achieve all that we do without their hard work and support.

We have a volunteer transport team that often steps up to transport Cavaliers into rescue, often with little notice. We are very thankful to the transport team for helping.

The charity is hoping to employ another member of staff very soon to help with the day-to-day care of the dogs in foster.

### **Achievements**

For the period 1<sup>st</sup> November 2020- 31<sup>st</sup> October 2021 there were 92 Cavaliers that came to the rescue. Many of the dogs were from owners that couldn't afford to keep their dogs due to their health problems, some were from breeders that were retiring their breeding dogs. The number of dogs surrendered was down compared to the pre-pandemic period. Many of these dogs were very challenging and were either extremely poorly, palliative or suffered from severe behavioural issues.

During this period, we rehomed 96 Cavaliers, some had been in rescue for an extended amount of time due to the pandemic. The 2020-2021 period was an incredibly difficult time for rehoming. The lockdowns meant we could not carry out any rehoming for long periods of time and this, in turn, increased our overall costs.

We also had many long-term dogs to care for due to their health or behavioural problems in this period. More information on our Forever Foster scheme is below.

We cared for a total of 122 Cavaliers in this period.

The average length of stay for dogs that were adoptable was 52.09 days in foster. This is considerably longer than in previous years due to the rise in dogs presenting with more medical and behavioural issues, combined with fewer members of the public wanting to adopt such difficult dogs.

Many members of the public were contacting us throughout the pandemic wanting to rehome a dog. There was exceptional demand but fewer dogs coming into the rescue. We were also concerned that several applicants would be returning to work soon, so the pre-adoption checks were tightened up and we requested proof from all applicants stating they were to continue to work from home long term.

Bliss believes in responsible ownership and that knowledge is power. We actively encourage all adopters to remain in contact with us so that we can support them with any teething problems. We also encourage adopters to purchase a lifetime pet insurance policy and ensure they have the means to care for the dogs they wish to adopt, especially those that have pre-existing conditions that will not be covered by pet insurance.

We also encourage each applicant to do extensive research into the health of the breed and the financial implications prior to adoption.

Our interview and home check process are extremely thorough, ensuring the right home for each dog. We carry out our own pre-adoption checks ensuring nothing is overlooked and applicants are encouraged to ask questions. For this reason, the percentage of Cavaliers that were returned to rescue in this period was less than 2%.

### **Forever Foster Scheme**

Due to a large number of very elderly, poorly, palliative, or aggressive Cavaliers that come into rescue the charity set up a 'Forever Foster' scheme to ensure the long-term safety of these dogs that cannot be rehomed. The public is not willing/able to adopt some of the Cavaliers that we have in rescue due to the financial expense of significant health issues, the number of veterinary visits required, the emotional strain of losing a palliative care dog, or safety around behaviour issues. For this reason, some of the rescue Cavaliers need to remain in our foster homes.

The Forever Foster scheme is greatly supported by the public, many donate monthly by standing order to pay for the long-term dog's vet bills and food. We are incredibly grateful to our fosterers for caring for these extremely challenging dogs and of course the public for donating to their care.

The long-term Cavaliers have a wonderful quality of life with very experienced volunteer carers.

During the 2020-2021 period, we cared for 26 long-term foster Cavaliers with complex issues.

### **Cavalier Fat Club**

In 2019 a study by PFMA in the UK showed that 51% of dogs are overweight or obese. Very sadly we noticed that a high number of the rescue dogs were overweight upon arrival into rescue and it was significantly impacting their health. There are many overweight Cavaliers which can mean dire consequences if not managed. Weight adds strain to their hearts and joints and very sadly in some cases causes premature death.

We set up Cavalier Fat Club for members of the public to join with their dogs with a monthly weigh-in and 'Loser of the Month' trophy and prize to provide encouragement. The group is assisted by nutritionists at Burns Pet Nutrition and our volunteers. We have more than 1,000 members of the group and a great community spirit.

### **Fundraising and sponsorship**

Most of our fundraising is completed online via social media platforms. We are fortunate to have a large following and we run fundraisers for individual dogs that may need significant veterinary care.

We also have a very successful online auction group which generates a large amount of income for the rescue. Usually, we carry out numerous fundraising events throughout the year. Sadly, due to the pandemic, we were only able to carry out one event in 2021. We had a very well-attended meeting at Yorkshire Sculpture Park which included a dog show, stalls, a raffle, tombola, and health information. A great day was had by all.

Monthly sponsorship for the Forever Foster dogs by the public continues to increase which is helping so much.

We received a grant towards the cost of a vehicle from Battersea this year and have purchased a van.

We have also received generous donations from the Cavalier King Charles Rescue and Welfare charity throughout the year, for which we are extremely grateful. These funds are used for our general practice veterinary bills.

### **HQ Building Work and Paddocks**

The rescue has undoubtedly grown since it was opened in 2018. Although we do have our network of foster homes, we needed our own building to grow into.

We needed an all-encompassing space for numerous activities such as assessing dogs, isolation areas, grooming, feeding, storage of items such as food, bedding and auction and shop items, training, adoptions, administration and of course space for the dogs in foster and long-term dogs.

We were fortunate to have a 1600+ square foot space to rent and convert into Bliss HQ. The building is almost complete now and is looking fantastic, we have a space that is multi-purpose and perfect for the rescue. Everything at HQ is very Cavalier-centric and homely for the dogs with much-needed air conditioning, perfect for the many dogs with heart and breathing problems. The floors are all non-slip to help dogs with arthritis, syringomyelia and orthopaedic issues.

There is a utility area with a shower, washing machine, tumble dryer, grooming table and dog bath. We tend to do the majority of grooming ourselves, so this area is brilliant.

There are also 2 secure paddocks so that the dogs can run free off lead, one a larger paddock and a smaller paddock mainly for the palliative dogs so that they can plod around at their own pace. Of course, also brilliant for anxious or aggressive dogs. Over time we hope to enhance the paddock area by creating a dog sensory garden for enrichment.

We are planning foster training and activity days in the near future and are really looking forward to using this space we so desperately need.

Animal Friends Insurance very kindly donated the funds for us to purchase CCTV for our buildings. This makes us all feel much more secure considering the recent spate of dog thefts in the UK.

### **Public Education**

We receive hundreds of emails and telephone calls each year from owners that are having problems with their Cavaliers for various reasons. We offer advice, literature and support to these owners and usually help them overcome their issues so that they can keep their pets rather than relinquishing them to rescue.

Bliss Cavalier Rescue is very successful in helping educate the public via social media platforms including Facebook, Instagram, and Twitter. We frequently feature our dogs' stories from beginning to end and the public very much enjoys the journey with us.

Part of our responsible ownership work is creating content to support 'would be' Cavalier owners on the ups and downs of owning one. Sadly, also many owners did not research the breed prior to purchasing and are now struggling with financial difficulty and behavioural problems. Our overall aim is to prevent Cavaliers from needing to come to the rescue via public education. Our campaigns to raise awareness are very effective but it remains a work in progress.

We took part in an episode of BBC Look North to highlight the issues surrounding puppies purchased during the pandemic. We had recently taken numerous sickly puppies from the public, so this was a great opportunity to spread the message about unscrupulous breeders.

The rescue attended Blenheim Palace 'All About Dogs' event and used the opportunity to raise public awareness of the breed's hereditary health problems.

### **Research**

We actively take part in veterinary studies where possible and are currently taking part in a brachycephalic study with Cambridge BOAS Research Group. We have also taken part in a trial for a medication to help manage Syringomyelia symptoms with animal neurologist Professor Clare Rusbridge.

### **Partnerships**

We are very fortunate to receive another year of sponsorship from Burns Pet Nutrition. Every month we receive dog food to help feed the rescue dogs from Burns, we are extremely grateful for this.

As of October 2020, Bliss Cavalier Rescue is a Battersea Animal Partnership Breed Specific Rescue. The partnership will help Cavaliers that need a breed-specific rescue space due to not coping in kennels or having challenging health or behavioural problems. We have successfully rehomed a Cavalier with behavioural issues from Battersea this year.

### **Volunteer and employee training**

Our fosterers take part in frequent training sessions relating to first aid and assessing for health and behaviour problems. These sessions have been carried out using Zoom during the pandemic.

We have used a qualified first aid trainer for training sessions and our volunteers hold certificates. We carry out monthly CPD sessions in behaviour, health, and pain management to ensure we are always up to date with training our team.

### **Increasing our impact**

Undoubtedly social media gives us our biggest audience possible; we intend to use our voice to further promote responsible ownership. We feel that if we can help to educate the public not to continue to buy puppies from unscrupulous breeders then longer-term there will be fewer dogs needing to be in rescue.

We also will carry on raising awareness of the breed health problems to relieve the suffering of the dogs that are not fortunate enough to have their conditions managed.

We plan to carry out more events in the coming year for our volunteers and supporters to attend with their dogs. We hope that there will be no further lockdowns or movement restrictions so that we can increase our volunteer numbers back up to the pre-pandemic level.

### **The year ahead**

During the 2020- 2021 financial year we have set the charity up for a stable future now that we have our building to use. Those costs have been covered so now we can focus all funds on vet bills, dog sundries and medication, and employing another member of staff to help with the day-to-day care and the transport of the dogs.

There are some concerns in the wider community that veterinary costs could increase in the near future due to large corporations purchasing clinics. We are fortunate to have a very reasonably priced first opinion veterinary practice that we use for most of the dogs with a discount. However, the overall cost increases could become an issue in the future.

We feel it is possible that some of our volunteers will need to return to work imminently and we are currently preparing for how we will recruit more volunteers. One area that can be very difficult for the rescue is transport, we intend to begin recruiting more transport volunteers as a priority. Often dogs are surrendered from homes that are many hours away from our foster homes, so we are working on improving our transport network.

As mentioned above we intend to continue with our responsible ownership work with the public, both in person (if possible- pandemic dependant) and online via our website and social media channels. We feel this is a high priority currently, especially with the high level of unlicensed and unscrupulous breeders operating in the UK. Most puppies sold currently are not registered and there is no breeder contract in place.

We are hoping to carry out our own research into Cavalier ownership costs and how we can help the public further.

We are concerned that members of the public that are currently working at home may need to return to work soon and will not be able to care for their dogs. We hope to grow the number of foster homes that we have and spend time individually training each foster carer at HQ. Fosterers within our team are well supported and are so important to us.

We hope to increase our volunteers' dog behaviour awareness and training further, this will likely be completed with online training soon. There is also a large group of volunteers booked onto first aid training in the new year.

Fundraising will continue in the same manner as in previous years with a combination of our very successful monthly online event '£1 Friday', increasing the volume of the auction group sales, raffles, Amazon Wishlist donations and the Forever Foster sponsorship scheme.

We can also soon reclaim gift aid which will make the world of difference.

### **Thank you from the trustees**

The charity remains extremely grateful for the support we receive from donors, ultimately, we could not achieve the fantastic outcomes that we do without that help. We continue to care for some very poorly and complex dogs that need a vast amount of time and care to become happy and well.

Finally, we would like to thank all our wonderful volunteers and fosterers for giving up so much time to help the rescue Cavaliers. We really could not do this without you all, please know that the time that you give up so kindly means the Cavaliers receive the best standard of care and welfare we could hope for.

We hope you enjoy your individual achievements as part of our team. Alone we can do so little, together we can do so much.
