THE TWO HUNDRED AND EIGHTH ANNUAL REPORT OF COUNCIL, BEING FOR THE YEAR ENDED 31 DECEMBER 2021

At the end of 2021 the Society of Antiquaries of Newcastle upon Tyne had 582 individual members, 87 institutional subscribers, and exchanged its journal with 39 other institutions.

As 2021 drew to a close there were encouraging signs of some return to normality following a long period in which the restrictions imposed by the coronavirus pandemic have prevented all our face-to-face meetings. Members were able to enjoy a social occasion and fascinating tour of St Nicholas' Cathedral by David Heslop, and we were able to resume our lecture programme on a regular basis in a room in Newcastle University from the end of September – with live streaming for those unable to attend in person. We are all deeply grateful to Marta Alberti and the rest of the Activities Committee team for their hard work in improvising a series of lectures on Zoom up to now, and for planning for the future. There will be inevitable teething troubles as we feel our way into providing both a live and live-streamed experience for our members at the same time, and we hope members will continue to be patient and supportive, as they have been throughout the pandemic, as those who on an entirely voluntary basis organise these events find the best way of doing things.

Maintaining communication with members through the pandemic has been a key priority, and Sue Ward has risen to this challenge, keeping members informed and entertained with both the regular and extra issues of the News Bulletin. It is gratifying that we have continued to attract new members, partly because of the publicity surrounding the virtual activities that the pandemic has forced upon us.

Our editor Don O'Meara and production editor Roger Fern have striven to catch up with the publication schedule of our journal *Archaeologia Aeliana* with the 2019 and 2020 volumes arriving in members' hands in short succession, and preparation of the 2021 volume now well advanced. They and the publication committee have also been hard at work developing proposals for a new series of *Archaeologia Aeliana* to commence from 2022 (the present, fifth series reaches its fiftieth volume this year).

With the gradual easing of the coronavirus situation the Society's collections in the Great North Museum (GNM) are now open to the public once again. Unfortunately the Society's library in the GNM has remained out of bounds to members and other visitors throughout the crisis, but towards the end of 2021 Tyne & Wear Archives & Museums appointed a Library Co-ordinator, Tamsin Bapty, to replace recently retired Librarian Ian Bower, and at the time of writing the Library has become accessible once more – check the revised opening times on our website. Thanks in part to the Society's intervention, a proposal to remove the University's Cowen Library books from the GNM to the Robinson Library, which would have diminished the integrity of the GNM collections as archaeological library, is not now to be implemented.

After our first full year in our new structure as a Charitable Incorporated Organisation (CIO) (a recently created charity structure which has the advantage that the Charity Trustees (Council) can act as a corporation rather than having to nominate individual

‘holding trustees’ to enter into legal agreements or contracts), it is pleasing to report that the transition has gone smoothly, thanks principally to the unstinting efforts of our Treasurer, Simon Pallett, and that the society remains on an essentially sound financial footing. As ever, our future financial well-being, and with it our ability to look after our collections and library and continue the publication of *Archaeologia Aeliana*, will depend to a large extent on our ability to attract new members and to engage them in our activities. We must take every opportunity to make more transparent the way the Society operates – particularly how Officers and Council are elected – and also to publicise the fact that the members are entitled to put themselves forward for office or Council and to help shape the direction of the Society. In this way we hope to widen the base of participation and take advantage of the talent and experience of members.

THE LIBRARY

Year 2 of the Covid Pandemic found the library only open for short periods and then mostly for “click and collect”.

Our professional Librarian, Ian Bower, retired in March but his successor, Tamsin Bapty, only took up her post in November.

The honorary librarians were unable to work in the library for most of the year under the Covid rules in place and had accumulated about 300 books, journals and pamphlets in the office awaiting processing.

The Society received large bequests of books from Dorothy and Trevor Hardy, both former volunteers at the Black Gate and Beryl Charlton, former President. These items have still to be dealt with. During the year in addition to the above and the regular serial publications, 72 items were received and went on the shelves in the early New Year and are now listed on the SANT Website. In addition to those noted above there were donations from L Allason-Jones, M Barke, D Breeze, D Brough, P Chapman, R Collins, E Gould, M Maddison, D Peel and P Thirkell. We have expressed the thanks of the Society to these members.

Several members have asked if the Society would like their collection of *Archaeologia Aeliana* (AA) to be added to the library. Following the bequest of the 3rd, 4th and 5th Series of AA by Beryl Charlton the Library is not now in a position to receive any more. These volumes from Beryl will be used to replace old and well-handled volumes of AA on the borrowing shelves.

Many of our exchange journals from County Societies are now available online and some of these societies no longer wish to exchange printed copies with us. The Library committee, which has not met during the pandemic, will be considering the implications of this development when it next meets.

The big find of the year was a bookbinder who was able to repair 20 volumes and complete the work in a reasonable time, and as funds allow further books will be sent his way. The number of books on the open shelves of the Society sporting white bandages has been reduced to almost nil and it is anticipated that in future books on these shelves will be repaired very much more quickly.

My colleague, Howard Cleeve, has closely monitored the borrowing and return of books during the “Click and Collect” periods. He has been reminding members of the four days per week opportunity to return the books they have borrowed - some for a considerable time. Indeed, one volume was returned which had been found in a loft and was noted as missing over 40 years ago.

35 books were borrowed in the academic year 2020-21 compared with 137 the previous year pre Covid and so far, this year to Christmas, 16.

I wish to thank Howard Cleeve, Peter Nicol and Mike Barke for their help during these troubled times.

Collections Committee Report 2021

This has been a quiet year for the Society's collections as many museums have been closed due to Covid-19 and many researchers have had to delay their visits to museums, archives and libraries.

We were sorry to say goodbye to Caroline MacDonald when she resigned from her post at The Great North Museum. We are grateful for her support of the Society and for the care of its collections in the Great North Museum over her tenure of office.

Seven of our Roman altars became the subject of the innovative exhibition 'Roman Britain in Colour'. This uses coloured light projection on a group of altars in the Hadrian's Wall Gallery to demonstrate how they might have looked when originally painted. The projection also includes extra material that either says something about the deity the altar was set up to, translates the inscription or gives an insight into the way the altars were used as a focus for sacrificial offerings:

The GNM dealt with 15 academic enquiries relating to SANT collections. These included:

Dr Boris Burandt (University of Frankfurt) was interested in the ivory gladiator knife handle from South Shields; Clare Millington (PhD candidate, Kings College, University of London) re an altar from Risingham (NEWMA : 1842.21); Dr James Gerrard/Dr Diana Briscoe (Study Group for Roman Pottery) who required a photograph of John Gillam from our archives; Dr Louisa Campbell (University of Glasgow), who required a photograph of Mary Hurrell painting inscriptions in the old Museum of Antiquities.

Various loans have been requested and processed: Seven Stories wished to borrow the cast of the applique of a smith god from Ponteland (1956.2.14) and an altar from Byker (*RIB*1314: Acc.No.1884.10). The Laing Art Gallery requested that the Nunykirk Cross (1976.9). and the Rothbury Cross shaft (1956.234.2) be loaned for their 2022 exhibition about The Lindisfarne Gospels. All the loans were authorised, with the exception of the Rothbury Cross shaft, as concerns were expressed about conservation issues and a conservator's report has been asked for before the loan is agreed.

The Sill borrowed a polished stone axe from Beamish (1814.11), a cup marked stone from Otterburn (1982.38), a rubbing stone from South Shields (1956.361), and an arrowhead from West Denton (1961.4). This loan to The Sill was supervised by Rob Collins and the objects were now back at the GNM.

Several Treasure Trove matters were brought to our attention and the following acquired for our archaeological collection:

2020 T521 Medieval silver mount from Corsenside (NCL-847A23).

2018 T728 Roman coin and object hoard from Bellingham area

2014 T621: Bronze Age gold 'hair' ornament from Kirkhaugh found during excavation.

Due to government restrictions, Northumberland Archives closed to the public for the second time on 5 November 2020 re-opening again with a limited service on 19 May 2021. Document usage was restricted to twelve visitors per day with users able to pre-order a maximum of six documents per day. Productions of records of the Society are therefore lower than under normal operating conditions but nevertheless 108 SANT documents were produced for users during the period May 2021 to December 2021. The collection has had regular usage by two gentlemen who are volunteers on the Cresswell Pele Tower project – see <https://cresswellpeletower.org.uk/>.

Work has continued on the re-packaging of the SANT glass photographic collection. This project started in 2018 and has focussed on the small glass negatives. Each of the 6611 small glass negatives have been placed in an acid free photographic wrapper that is a perfect fit to the item. Each negative was then individually numbered with labels adhered to the wrapper and then placed in conservation grade storage boxes. The reference numbers of the box contents were then recorded on a label that was placed on the outside of each box. The boxes are stored in the Archives' photographic strongroom. The re-packaging materials have been purchased with funding provided by SANT.

Northumberland Archives receives conservation advice from Durham County Record Officer and the Durham conservator came on site in late 2021 to look at the larger glass images and advised that they need to be stored horizontally, buffered with acid free corrugated boarding between each plate, wrapped individually and stacked a few together in more robust boxes. Northumberland Archives are about to start an audit of these larger items that will allow for a calculation of the quantities of materials required to undertake this second stage of the project.

There are clear benefits to this re-packaging programme – conservation grade packaging slows the physical deterioration of the negatives; the new boxes are easier to handle and can be stored more efficiently allowing better use of our storage space. The project has allowed the collection to be audited and ensures that the negatives are stored in the correct reference order.

The first draft of a list of the Society's collections has now been completed and several digital copies have been secured in different places for safety. Much work on refining this list is needed before it can be widely disseminated, but it has already proved helpful in answering enquiries.

Archives: Following on from the Pilgrimage of Hadrian's Wall, Myles Richardson, a descendant of John Collingwood Bruce, has donated a letter from Bruce to his grandson

William Philipson, dated 1883. This has now been deposited at Northumberland Archives.

Report of the Committee for 2021

Covid-19 restrictions had a major impact on the Society's activities, as in 2020. The main aim of the committee, since March 2020, was to keep monthly meetings going. These continued online using Zoom, until face-to-face meetings returned in August 2021. After a shaky start at St Nicholas's Cathedral the Society was able to use rooms in Newcastle University again from September 2021. It is vital to continue broadcasting the lectures to the many members of the Society around the UK, and indeed across the world, so

meetings are hybrid, with lecturers speaking to members able to attend in person and many others watching and participating via Zoom. Hybrid meetings require considerable effort to organise and deliver, and the committee is immensely grateful to Marta Alberti for managing this. It is rewarding to see combined face-to-face and online attendances of over one hundred (and one hundred and fifty in some instances). It is notable that new members continued to join the Society throughout the Covid restrictions, with the online lectures providing a much-valued benefit to membership irrespective of members' location.

It is regrettable that Covid prevented many of the Society's usual group activities such as summer visits and walks. The Summer Social was held in St Nicholas's Cathedral; many thanks to David Heslop for delivering a fascinating tour of the refurbished interior. Members were encouraged to contribute to and enjoy online seminars, including the very successful 'Afternoons on the Tyne' talks organised by Sue Ward in February 2021. Katie Mountain organised two online 'Coffeehouse seminars' in February and June 2021 with student and early career researchers as speakers, part of our plans to provide opportunities for new researchers. Thanks also to Sue for the regular news bulletins highlighting activities across the region. Katie and Marta used social media to keep members and the public informed of our activities and, very successfully, to attract new student members to the Society.

The Activities and Membership Committee continued to meet on Zoom throughout the year. Geoff Woodward revised the committee handbook and risk assessments, ready for new activities in 2022, when the Society will be participating in many events to mark Hadrian's Wall 1900, as well as a renewed programme of visits and walks.

Archaeologia Aeliana

2021: The volume is progressing and will be out by mid-2022.

News Bulletin

The News Bulletin has continued with its regular six-monthly publication schedule, with printed and electronic versions appearing together in June and December. As reported to the November Council meeting, Sue Ward will be giving up editor-ship after the December 2022 meeting, and the Society needs to find a new editor. We warmly thank Sue for all her hard work, not only on the newsletter, but for her many contributions to the work of the Committee.

Website

There is another issue of succession for the Committee – the future retirement of the web-master, Roger Cornwell. Discussions on the specification for the work will follow the easing of Covid restrictions.

Digitising Society publication

The committee hopes to be able to digitise Colm O'Brien's monograph on excavations on the Newcastle Quayside, published in 1988 and long out of print, using a commercial company that charges only a modest fee. The digital version would be hosted on the Society's website. If this is a viable solution, other, out-of-print volumes could follow. The Society is still pressing ahead with the long delayed digitization and free public

access to its now defunct but historically important *Proceedings*, following the success of the similar project for the historic run of *Archaeologia Aeliana*.

New Publications

1. Friaries Book; there has been progress on proposals for re-development of the Blackfriars quadrangle, and Eric Cambridge is progressing with his very extensive research on the wider Dominican community, and how Blackfriars would have fitted into this.

2. *African Lives in Northern England*; we have worked in partnership with the independent project team responsible for this booklet, six hundred copies of which have been sold. Our Treasurer, Simon Pallett, has assisted with managing the finances, for which Beverley Prevatt Goldstein, the Editor, has expressed much thanks.

As usual, the chairman wishes to express thanks to all of the members of the committee. Sue's contributions have been mentioned; with special thanks to Sue Ward for her work on the website and News Bulletin, to Don O'Meara and Roger Fern for steering our widely respected journal to publication in a very difficult year, and to Katie Mountain and Adam Leigh for helping with social media..

Trustees' Report

The trustees present the annual report together with the financial statements and auditors' report of the charity for the year ended 31 December 2021.

Structure, governance and management

Nature of governing document

The Society of Antiquaries of Newcastle upon Tyne (a registered charity, number 1188638) is constituted as a Charitable Incorporated Organisation (CIO). It was entered into the Register of Charities on 19 March 2020, but took over the assets of the former unincorporated association (registered charity number 230888) on 1 January 2021 using a Vesting Declaration dated 23 September 2020 signed on behalf of the holding trustees of the old unincorporated association and on behalf of the trustees of the CIO. The unincorporated association has, following the notification of the merger to the Charity Commission, been removed from the Register of Charities.

The financial statements show the 2020 results of the unincorporated association as comparative numbers in the interests of transparency and because the work of the Society has continued unchanged regardless of the change in legal status.

Recruitment and appointment of trustees

The trustees of the Charity are the members of Council, who will be appointed by election at the Annual General Meeting in April each year. The initial charity trustees were named in the constitution and all the initial trustees will stand down at the April 2022 AGM, although they are eligible to stand again for office. They are "the persons having the general control and management of the administration of the Charity". During the year Council meetings have taken place on-line using Zoom up until November, but have continued as scheduled.

Arrangements for setting key management personnel remuneration

The Council of the Society does not consider that there are any key management personnel other than the Members of Council (trustees) themselves, who receive no remuneration.

Policies

The Trustees have a policy on Conflicts of Interest and have set up a Register of Interests for Members of Council. The Trustees also have a Risk Management Policy and have established a Risk Register, which is subject to annual review by the Trustees.

Trustees' Report

Objectives and activities

Objects and aims

The objects of the Society are the study, investigation, description and presentation of antiquities and historical records in general and those in Northumberland, Durham and Newcastle upon Tyne in particular. The Society pursues its objects through:

- its collection of antiquities in the Great North Museum, the Morpeth Chantry Bagpipe Museum and other museums, where they are available to the public.
- acquiring appropriate items for its collection, its archives and its Library in the Great North Museum.
- the publication of its refereed journal *Archaeologia Aeliana* which makes a significant contribution to scholarship.
- making all but the most recent five years of *Archaeologia Aeliana* available without a paywall via Archaeology Data Service. In due course Proceedings will be made available in the same way.
- other publications, especially its definitive Handbook to the Roman Wall.
- publishing leaflets about local architecture (eg. Capital Newcastle).
- newsletters for members in print and electronic format.
- its Library in the Great North Museum, which is freely open on a reference basis to students and members of the public, and for borrowing to members.
- allowing access to its archive which is held with the Northumberland County Archives at Woodhorn.
- making material of historical interest available on its website for all to use.
- making small grants for research purposes and to support events and publications.
- making grants to the Great North Museum, Morpeth Chantry Bagpipe Museum and Northumberland Archives, which hold most of the Society's collection of artefacts and documents.
- running a monthly lecture series for members and guests, as well as other events aimed at a student audience.
- offering at least one public lecture each year, open to all.
- running other events such as concerts and research days, and
- offering walks and visits to members

Fundraising disclosures

The Society is required to report how it deals with fundraising from the public. The Society does not use a professional fundraiser or commercial participator to raise funds. Any monies received direct from the public are raised in accordance with the guidelines set by the Charity Commission and UK law in every respect. The privacy and contact preferences of all public donors are respected.

Public benefit

The Trustees have referred to the guidance on public benefit issued by the Charity Commission and designed the programme of activities so as to ensure a substantial public benefit. Council has considered how to make the Society more attractive to students and has offered additional evening sessions via Zoom aimed at this audience. In addition students can join as electronic members for as little as £5.00 per annum and there is also a concessionary rate which includes a copy of *Archaeologia Aeliana*. The Trustees are satisfied that the Society provides considerable public benefit, as is clear from the list of activities above.

The Trustees confirm that they have complied with the requirements of section 4 of the Charities Act 2011 to have due regard to the public benefit guidance published by the Charity Commission for England and Wales.

Trustees' Report

Achievements and performance

The Society's normal programme of activities has inevitably continued to be seriously disrupted by the Coronavirus pandemic. Face to face lectures only resumed in September. The Summer Social had to be cancelled in 2020, but an event did take place in the Cathedral in September 2021. Before September, the Society had run a series of lectures on-line which have attracted a good audience, including members from all over the UK and abroad, thus showing that the enforced use of online technology has some real benefits. Archaeologia Aeliana 2020 has been successfully produced and distributed, albeit subject to some delay, and excellent progress has been made on Archaeologia Aeliana 2021, which the Society hopes to be able to distribute to members early in 2022, thus getting the production schedule back into line.

Work on digitising Archaeologia Aeliana was completed in 2019 and all but the most recent five years are digitally available through the Archaeology Data Service at the University of York. Work on getting the Proceedings of the Society of Antiquaries of Newcastle upon Tyne online continues, although delayed by the Pandemic. This work was supported by the Marc Fitch Fund and the Sir James Knott Trust.

The Society's collection of antiquities continues to be on public display in the Great North Museum, while its collections of historical items are on loan to other public museums in the region and elsewhere in Britain. Its extensive archive collections are housed at Woodhorn Museum and Northumberland Archives, where they are publicly accessible. The Society also continues to invest in its Library, in both journals and books, which are available for public reference, and also in preserving its archive at Woodhorn. However, the Pandemic has resulted in the temporary closure of our museum partners at some times and restricted access at other times, although in autumn 2021 things have started to open up again.

During the year the Society has supported the African Lives in Northern England project and managed its finances. This is shown in Restricted Funds.

The Society decided to increase its research funding temporarily, funding this from reserves, as a way of supporting the sector during the Pandemic. Some very high quality projects gained funding from the enlarged budget.

Financial review

In 2021 the Society made an operating deficit on unrestricted funds of £11,030. There are a number of reasons for this, many linked to the Pandemic. The main ones are greatly reduced investment income and the conscious decision to increase the research grants on offer in order to provide a boost to the sector at this difficult time. To some extent this was offset by savings from the enforced move to online operations. The biggest impact of the Pandemic has been the fall in investment income, which looks to be part of a longer-term trend. The Society has always used this income to support its operations, so the loss of about a quarter of it will have consequences. Nevertheless the level of unrestricted reserves is so high that there is no danger to the Society's survival in the short or the medium term.

The Society's investment portfolio has risen in value across the year as economies recover from the impact of the Pandemic. Its value has risen from £724,313 to £812,582, showing a net gain of £92,694 across the year. Stock markets have been surprisingly resilient, although investment income has fallen substantially as described above.

In the view of the Trustees there are no uncertainties about the Society's ability to continue as a going concern. Unrestricted reserves amounted to £888,332, which provides a substantial cushion, despite the financial challenges faced.

Trustees' Report

Policy on reserves

The Trustees' policy in the medium term is that the Society should seek to live within its annual income from activities, subscriptions and income from its investments in the Capital Fund. Its policy is to maintain the real value of the Capital Fund in the medium term and only to spend income and capital in a way which is compatible with this. The Capital Fund is a designated fund, so it remains available to deal with emergencies, and is included in Unrestricted Funds in the financial statements. However, in the current very difficult conditions, the trustees accepted that they would have to draw on reserves to a small extent. Unrestricted reserves at £888,332 are very high in relation to annual expenditure, so the Society can afford to do this.

Investment policy and objectives

The investments in the Capital Fund are professionally managed in line with the Society's instructions with a view to achieving capital growth so as to maintain its real value and generate an increasing annual income. The investments are overseen by the Investment Committee which meets annually with the Society's fund managers.

Plans for future periods

Activities planned to achieve aims

The Society's Council plans to continue the move back to face-to-face meetings and events, so long as this is compatible with medical advice. However, the enforced move online did show an appetite amongst members for involvement at a distance, including members abroad. The Society will therefore be live-streaming future lectures as well as offering them face-to-face and addressing the technological challenges that this poses.

It hopes soon to be able to make past editions of Proceedings available on-line through the Archaeology Data Service at the University of York. Council also plans to make further archival material available on-line, as has already been done for the Poll Book and the Flood Book, using volunteers to carry out the work, whilst seeking grant aid, where appropriate, to subsidise the costs of publishing. The Society also intends to add to its collections as and when suitable artefacts and documents relevant to the history and archaeology of the North East of England become available.

The Society is advancing plans to introduce colour illustrations into Archaeologia Aeliana with the start of a new Sixth Series, commencing with the 2022 edition.


Disclosure of information to auditor



Notes to the Financial Statements for the Year Ended 31 December 2021

1 Accounting policies

Statement of compliance

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019) - (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Charities Act 2011.

Basis of preparation

The Society of Antiquaries of Newcastle Upon Tyne meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy notes.

Previously, the activities of The Society of Antiquaries of Newcastle upon Tyne were carried out by a separate unincorporated charity (charity number 230888). The comparative figures presented in these accounts represent this unincorporated charity. The 2020 charity's financial statements were subject to audit. The amounts transferred on becoming a Charitable Incorporated Organisation (CIO) have been presented as opening balances at 1 January 2021 (rather than a gift received) as the only change has been to incorporate by becoming a CIO.

The functional currency is sterling.

Exemption from preparing a cash flow statement

The charity opted to adopt Bulletin 1 published on 2 February 2016 and has therefore not included a cash flow statement in these financial statements.

Going concern

The trustees have considered the financial position in light of the ongoing situation in relation to the Covid-19 virus and on conclusion of this work, consider that there are no material uncertainties about the Society's ability to continue as a going concern.

Collections of the Society

These are heritage assets. These assets are irreplaceable originals to which no reliable cost or value can be attributed and accordingly these have not been capitalised in the financial statements.

Estimation uncertainty and judgements

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the amounts reported.

Management have provided depreciation, prepayments, accruals and other cut-off adjustments. Whilst management believe that these estimates and judgements are accurate, there is every likelihood that they will not be exact.

These estimates and judgements are continually reviewed and are based on experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

Income and endowments

Voluntary income including donations, gifts, legacies and grants that provide core funding or are of a general nature is recognised when the charity has entitlement to the income, it is probable that the income will be received and the amount can be measured with sufficient reliability.

Donations and legacies

Donations and legacies are recognised on a receivable basis when receipt is probable and the amount can be reliably measured.

Membership subscriptions are recognised upon receipt.

Grants receivable

Grants are recognised when the charity has an entitlement to the funds and any conditions linked to the grants have been met. Where performance conditions are attached to the grant and are yet to be met, the income is recognised as a liability and included on the balance sheet as deferred income to be released.

Expenditure

All expenditure is recognised once there is a legal or constructive obligation to that expenditure, it is probable settlement is required and the amount can be measured reliably. All costs are allocated to the applicable expenditure heading that aggregate similar costs to that category. Where costs cannot be directly attributed to particular headings they have been allocated on a basis consistent with the use of resources, with central staff costs allocated on the basis of time spent, and depreciation charges allocated on the portion of the asset's use. Other support costs are allocated based on the spread of staff costs.

Raising funds

These are costs incurred in attracting voluntary income, the management of investments and those incurred in trading activities that raise funds.

Charitable activities

Charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

Grant provisions

Provisions for grants are made when the intention to make a grant has been communicated to the recipient but there is uncertainty about either the timing of the grant or the amount of grant payable.

Support costs

Supports costs have been differentiated between governance costs and other support costs. Governance costs comprise all costs involving the public accountability of the charity and its compliance with regulation and good practice. These costs include costs related to the statutory audit and other costs with an allocation of overhead and support costs.

Governance costs and support costs relating to charitable activities have been allocated as set out in the Support Costs note (note 8).

Governance costs

These include the costs attributable to the charity's compliance with constitutional and statutory requirements, including audit, strategic management and trustees's meetings and reimbursed expenses.

Taxation

The charity is considered to pass the tests set out in Paragraph 1 Schedule 6 of the Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes. Accordingly, the charity is potentially exempt from taxation in respect of income or capital gains received within categories covered by Chapter 3 Part 11 of the Corporation Tax Act 2010 or Section 256 of the Taxation of Chargeable Gains Act 1992, to the extent that such income or gains are applied exclusively to charitable purposes.

Tangible fixed assets

Individual fixed assets are initially recorded at cost, less any subsequent accumulated depreciation and subsequent accumulated impairment losses.

Depreciation and amortisation

Depreciation is provided on tangible fixed assets so as to write off the cost or valuation, less any estimated residual value, over their expected useful economic life. The assets within the financial statements have already been written down to a £nil net book value.

Asset class

Fixtures, fittings and equipment

Depreciation method and rate

25% to 33% straight line

Fixed asset investments

Fixed asset investments are included at market value at the balance sheet date. Realised gains and losses on investments are calculated as the difference between sales proceeds and their market value at the start of the year, or their subsequent cost, and are charged or credited to the Statement of Financial Activities in the period of disposal.

Unrealised gains and losses represent the movement in market values during the year and are credited or charged to the Statement of Financial Activities based on the market value at the year end.

Trade debtors

Debtors are amounts due from customers for merchandise sold or services performed in the ordinary course of business.

Debtors are recognised initially at the transaction price. They are subsequently measured at amortised cost using the effective interest method, less provision for impairment. A provision for the impairment of is established when there is objective evidence that the will not be able to collect all amounts due according to the original terms of the receivables.

Cash and cash equivalents

Cash and cash equivalents comprise cash on hand and call deposits, and other short-term highly liquid investments that are readily convertible to a known amount of cash and are subject to an insignificant risk of change in value.

Fund structure

Unrestricted income funds are general funds that are available for use at the Trustees' discretion in furtherance of the objectives of the charity.

Publication Grant Fund

The Publication Grants Fund consists of grants made to the Society to support the publication of specific articles in Archaeologia Aeliana.

Publications Fund

In the past the society received grants for publications made on the condition that any proceeds received were put into future publications. Therefore all income from publications other than Archaeologia Aeliana is paid into this fund, from which expenditure on future publications other than Archaeologia Aeliana will be drawn.

African Lives Project

The Society has handled the finances of this project to produce educational materials, a project in which the Society is a partner. The income comes from the proceeds of 2020's calendar, grants and the sales of booklets produced. The expenditure has been on producing a wallchart and booklets.
