In 2021 the charity started receiving regular contributions from donors as well as contributions from a corporate golf day who supported the charity via VirginMoney Giving. Private contributions included two lump sum contributions for a specific project the school was involved with for the benefit of the students.

Summary of Main achievements of the charity during the year The PBHF (UK) raised £16,370.75 in 2021 for the benefit of Paarl Boys High Students and made its first payment of £14,000 to the Paarl Boys High Foundation Trust in Paarl, South Africa where the money was deployed as per the wishes of the donor for the benefit of the students of the school. At the end of 2021 the balance in the Charity account was £3,216.75.

Policy on Reserves

The Trustees have agreed that the trust should aim to have a reserve of £1,000 in the Charity CAF bank account at the end of each year to ensure that the costs of running the charity are covered. All other earnings to be paid out to Paarl Boys High Foundation Trust.
