		as well as for young people, children and toddlers. We advance the arts by providing a home for regular rehearsals by theatre groups, children's dance classes and photographic society. We help those who are disadvantaged by reason of age, ill-health or disability by providing groups which can support them, i.e. support groups for those with alcohol problems and their families, support group for those with dementia and their carers.
