### **Trustees**

There has been no change to the trustee status this year  
The total number of trustees remains at  
18 with representation from 16 Wallsend schools.

### **Young in Wallsend Programme**

Funded by the Big Lottery Fund this programme has delivered a range of activities using 9 local partnerships.

Partners include Barnados/ YMCA/ Prometheus/ Family Gateway/ Local Churches. The majority of these groups were delivered on-line adhering to the Covid-19 restrictions in place. Once they were allowed to open up for face-to-face sessions they did.

Support for Wallsend primary & secondary schools

This year activities have been organised and funded for children across the schools during holidays, including half0terms. Over 800 children attended during the summer programme

Successful Grants / Funding

Successful grant applications this year were from North Tyneside Council through their Holiday Activity and Food funding.

This was used to deliver activities across Wallsend during school holidays and targeted most vulnerable

### **Meetings**

The management committee comprising the headteachers of all Wallsend schools met on 6 occasions throughout the year.

### **Future Developments**

In the near future, we are looking at using a different charitable structure.
