CONTENTS AND ADMINISTRATIVE INFORMATION

The financial results for the Charity's second accounting period from 1st July 2021 to 30th June 2022 show an overall surplus on unrestricted reserves of £13,050 as at 30th June 2022.

Financial Review and Reserves

The Trustees are aware of the Charity Commission guidance on Public Benefit and their operation of the Charity reflects this. The Trustees believe that the Charity satisfies its public benefit obligation and has acted within its approved objects.

Objectives and Activities

During the year, Mr S W Martin came to the end of his first tenure of two years. Mr S W Martin stood again for re-election and was re-appointed as Trustee for a second term of three years to 12th February 2025.

The current Trustees are the First Trustees on incorporation on 12th February 2020. Their terms of office expire a year apart in order to retain Board cover. The Charity is able to have as many as nine Trustees. The First Trustees have discussed appointing additional Trustees to support the Charity meet its strategic and charitable aims and the Charity grows.

Organisation and Appointment of Trustees

All Trustees give their time freely and no remuneration or expenses were paid during the year.

The Trustees are responsible for the overall management and control of Ride2Give CIO and hold regular meetings.

Ride2Give CIO (the Charity) is an incorporated entity governed under a constitution of a charitable Incorporated Organisation.

Structure, Governance and Management

The Trustees present their annual report for Ride2Give CIO for the year 1st July 2021 to 30th June 2022, which comply with the CIO's constitution and applicable law and accounting requirements.

RIDE2GIVE CIO

The intention of the Charity is to deliver smiles and sense of occasion as well as services & support, so the primary delivery method is a visit to the person with a group of motorcyclists being the method of delivery. This has remained our approach, but the Charity has also organised events and directly helped people outside of this approach. Over the course of the financial year, Ride2Give organised 10 such charitable donation events.

In addition, we were nominated as the beneficiary of a local Christmas lights show, with all the public donations being given to the Charity.

The Charity has worked on improving its profile over the past 12 months and has made presentations at events and networked with other Charities. This is to both help secure funding but also help the Charity to identify people in need who meet the Charity's charitable objectives. Through this activity, we secured a significant and generous donation from GXO Logistics, in recognition of the work the charity has done and enabling it to provide further support.

Cherished Urns have also continued to provide regular donations throughout the year which has helped the Charity significantly.

Valley HOG Chapter. The Charity has remained their nominated charity and they have continued to provide fantastic support to Ride2Give, both financially, but also in supporting ride outs and visits to those in need.

The Charity has continued to work closely with the local motorcycle Harley Davidson group, Nene Valley HOG Chapter. The Charity has remained their nominated charity and they have continued to provide fantastic support to Ride2Give, both financially, but also in supporting ride outs and visits to those in need.

The Charity's second accounting period to 30th June 2022 saw Ride2Give become more established in the community, with wider recognition, helping more people than ever and in establishing that track record & profile, was able to generate more funding in order to provide more assistance to those in need.

The Trustees have agreed that £1,000 is sufficient for this purpose. As at 30th June 2022, the sum of £14,050 was held in cash or at bank.

The Trustees have agreed a Reserves Policy to ensure that sufficient funds are held at all times to cover such items as working capital, unforeseen unavoidable expenditure or an unexpected cessation of income.

The Trustees are responsible for overseeing the risks faced by the charity. Risks are identified, assessed and controls established throughout the year. These are maintained on a Risk Register and discussed and managed at Board Meetings. The Trustees believe they have mitigated against any major risks to the Charity.
