The Trustees present their report for the year ended 31st March 2021.

The accounts have been prepared in accordance with the accounting policies and comply with the governing document, the Charities Act 2011 and the Statement of Recommended Practice, "Accounting and Reporting by Charities", issued in March 2005.

### **Objectives and Activities**

The charity continues to operate as a community association providing a venue for local activities. The Trustees have paid due regard to guidance on public benefit published by the Commission in exercising their powers of duty.

### Achievements and performance

The charity continues to seek opportunities to support local community activities and has done so in the period under review.

#### Financial review

The financial situation at the end of the year is not as satisfactory as in previous years but this is due to the Covid pandemic. The centre was closed for much of the year due to lockdown which resulted in a loss of revenue from rents. In addition, a major repair to the roof required reserve funds to be used.

#### Structure, governance and management

Little Common Community Association is a charitable incorporated organisation. The association was established under a deed dated 1 April 2016. Objects and Powers of the charitable incorporated organisation are governed under its deed dated 1 April 2016.
