Established in 1604 "for the relief of 8 poore people of the Town of Crewkerne, Misterton, West Crewkerne or Woolminstone", aged over 55 years and in need, with four dwellings in Court Barton, Crewkerne.

1887 to celebrate the Golden Jubilee of Queen Victoria a further terrace of four dwellings was built in adjoining West Street.

(5-year appointment)

The Almshouse buildings are all Grade II Listed.

The Charity also owns a small agricultural plot which is let on an annual basis.

The Charity is administered by eight Honorary Trustees:

- 4 are co-opted
- 2 are nominated by Crewkerne Town Council (4-year appointment)
- 1 is nominated by West Crewkerne Parish Council (4-year appointment)
- 1 is nominated by Misterton Parish Council (4-year appointment)

The Trustees are assisted by a Warden and Clerk who receive an honorarium to defray their expenses.

The Charity has 8 residents who pay a monthly contribution towards maintenance costs. The Trustees keep the maintenance charge under review and take a parochial and continuing interest in the wellbeing of the residents and their surroundings. A scheme of gentle, graduated increases to the Maintenance Charges has been introduced as they had fallen below the 70% of commercial rates recommended by The Almshouse Association (authoritative body)

2022 saw no change in Residents.

The only outlay was in maintenance of the buildings and was within allocated budget. All Residents paid their Maintenance Charges regularly. The Charity has a stable financial position, with stable reserves.
