The Trustees present their annual report and the financial statements of the Agency for the year ended 31st December 2022.

Legal Status and Organisation of the Charity.

The Agency is a Registered Charity and was first established, by a Trust Deed dated 31st July 1987. Management of the Agency is vested in Trustees, who comprise the Moderator, Vice Moderator, Honorary Secretary, Honorary Treasurer and one other or such larger number as the Trustees themselves shall determine.

Our Communications Manager Cherry Hamilton works part time for the Charity

The Trustees normally meet at least three times during the year. Details of the Trustees are given on Page 3.

The Agency was set up with the support of the British Council of Churches, the Evangelical Alliance, the Roman Catholic Church, the Black-led Churches and others. The Objects of the Agency are to advance Christian religion and Christian education within England and Wales.

Activities

The Agency deals with enquiries relating to the Christian faith, particularly from people who have no existing contact with Christian communities, and are not ready to make contact with a local church. We give free, objective, reliable and confidential information to those who are interested in the Christian faith.

The main channel through which we give information is the website www.christianity.org.uk. This was completely redesigned in November 2010 and again in 2015 and a further redesign in 2019. This has allowed the Agency to provide information to a far greater number of people than was possible through activities that were largely paper-based. The website contains about 80,000 words of information about the Christian faith - information about what Christians believe, and frequently asked questions about faith, as well as seasonally changing features.

The website also enables people to make contact with the Agency. We are able to send those who do so a Gospel, put them in touch with a local church, answer their questions, enter an email conversation about what it means to have faith, or pray for them through a network of about two hundred supporters who are committed to this task. It is our policy to send people what they ask for, and solely what they ask for.

A print-based ministry continues for those who prefer to receive information in this way, and we continue to respond to requests for information that come because of the Agency's presence in free newspapers, and because a freepost address is made known at exhibitions in cathedrals, and on other literature made available to those who might be interested in the life and teaching of Jesus. The redesigned www.christianity.org.uk website continues to be updated and edited by Cherry Hamilton and the Trustees.

Funding

Throughout its history, the Agency has derived the greater part of its income from grants from the denominations and charitable trusts which support its work. Grants from denominations have been significantly reduced during the last two to three years, partly because financial pressures are directing denominational resources to their own agencies, and also because of the reduced level of our own activity. Full details of such grants appear in Note 2.

We are also very much indebted to the local churches and individuals who made voluntary donations to support the work of the Agency during the year.

Achievements and performance

During the year, we have continued with the further development of the website at www.christianity.org.uk, including the development of new material and the establishment of a facility for access from mobile devices. We are greatly indebted to the many people who have written and developed the website content.

We are enormously grateful to the Trustees of the Deo Gloria Trust for their continued support which is so vital to the agency's operation, and to the contribution of Church Army.

Financial Results

Details of the financial transactions in 2022 appear in the accounts. Overall, expenditure exceeded income by some £8,642. Total reserves are thereby reduced to £84,830 due to revaluation of Charifund including a general Contingency reserve of £20,000.

Future Development

Whilst work still continues to update and improve the website, the agency is also seeking to develop new initiatives, and to this end, the Trustees will also be seeking to build up the agency's funding to ensure future viability. We are committed to develop resources that respond to the culture of mobile technology users, strapped of time and concentration, and to respond to the different way British people think about their lives.

Public benefit

The trustees have taken into account the Charity Commission's general guidance on public benefit and the specific guidance on the advancement of religion. Through the information made freely available on our website and materials supplied to enquirers, and by meeting requests for further assistance, for example, by introductions to local Christians, we seek to provide a service to all people who are seeking to find out more about Christianity for themselves.

Statement of Trustees' Responsibility

Charity Legislation requires the Trustees to prepare Financial Statements which give a true and fair view of the state of affairs of the Charity as at the end of the financial year and of the surplus or deficit for the period. In preparing the Financial Statements, suitable accounting policies are to be adopted and consistently applied, to the best of the Trustees' knowledge and belief, making reasonable and prudent judgements and estimates as necessary. The Statement of Recommended Practice for Accounting by Charities is to be followed, together with applicable Statements of Standard Accounting Practice. The Trustees are responsible for maintaining adequate accounting records, for safeguarding the assets of the Charity and for preventing and detecting fraud and other irregularities. The Trustees are also required to indicate where the Financial Statements are prepared other than on the basis that the Charity is a going concern.

The income and expenditure account is derived from the Statement of Financial Activities with movements in endowed funds excluded to comply with company law. All income and expenditure is derived from continuing activities.

1. ACCOUNTING POLICIES

The following accounting policies are used consistently in relation to all items which are considered to be material in relation to the Charity's affairs:-

- (a) The accounts are prepared on a going concern basis, under the historical cost convention, and on an accruals basis. Where applicable, the principles embodied in the Revised Statement of Recommended Practice "Accounting and Reporting by Charities" issued in March 2005, and applicable United Kingdom Accounting Standards are followed.
- (b) Office Furniture and Equipment is capitalised, and depreciation is provided at rates which are expected to write off the cost, less any residual value, over the economic life of the asset. Equipment acquired before 31st December 2005 is depreciated at 25% of written down value per annum; equipment acquired after that date is depreciated at 25% of cost per annum. The full annual charge is applied to all assets owned at the accounting date. Prior to 1st January 1997, Office Furniture was not depreciated. We do not own any office furniture or equipment.
- (c) Voluntary donations and grants, income from fund raising and bank interest receivable are normally brought into account when received. However, where donations are stated to be for a period in excess of one year, the proportion relating to future years is carried forward as Deferred Income, and credited to revenue in the period to which it relates. Literature provided without charge by other agencies for distribution to enquirers is not brought into account, as it is considered that the Charity is simply distributing this on behalf of the donors.
- (d) Restricted funds received for specific purposes are accounted for separately together with related expenditure. Any unspent balances of restricted funds are held on separate Reserves.
