Respective responsibilities of Committee of Management and Examiner



Basis of the Examiner's statement

An examination includes a review of the accounting records kept by the committee of management and a comparison of the accounts presented with those records which is primarily limited to analytical procedures and to the making of such enquiries of the committee of management as was necessary for the purposes of this report. The procedures undertaken do not constitute an audit.

Examiner's statement
