<u>President's Report</u> for the Year Ended 31 December 2022

As of the date of this report, I am now coming to the end of my first of two years as BTS President. It has been a great privilege to act as your President during this time. The current success of the Society is due to the excellent efforts from many individuals who generously give up their time to serve on various BTS Committees. Without the efforts of the various BTS committee members the Society would not be able to function.

The last year has seen some return to normality after the issues of the Covid pandemic. We held a very successful face to face Annual Congress meeting in Newcastle in April 2022, which was attended by over 220 delegates. I do hope that the 2023 BTS Congress in Birmingham will be even more successful in attracting BTS members to participate in the meeting.

For the 2023 Congress I should like to offer my congratulations to the three award winners who will make presentations at the meeting. The 2023 Barnes Prize winner is Professor Samuel Cohen (University of Nebraska Medical Center, USA), the Malcolm Blackwell Award winner is Professor Matthew Wright (University of Newcastle) and the Frank Sullivan Early Career Award winner is Dr Liza Emirali (MRC Toxicology Unit, University of Cambridge). In addition, a new BTS award, namely the President's Award, will be presented for the first time this year. This award is to recognise a BTS member who has made a significant contribution to the Society. I am please to inform you that the 2023 President's Award winner is Julianna Berrie (Office for Product Safety and Standards). Full details of all the BTS awards are available on the website.

In terms of BTS membership, we have seen some increase in BTS membership in 2022 compared to 2020 and 2021. As of the end of December 2022, we had a total of 874 members, of which full, student, postgraduate and early career members comprised 496, 183, 56 and 81 members, respectively.

BTS income is derived from two main sources, namely donations and membership subscriptions. With respect to donations, I should like to acknowledge with thanks financial support from ApconiX, AstraZeneca, GlaxoSmithKline, Syngenta and Unilever. In addition, some companies provided donations to help finance the 2022 Annual Congress. These companies included ApconiX, Cyprotex, NC3Rs, Regulatory Science Associates, Sequani and UCB. I would ask all BTS members to enquire if their company would be able to make a donation to the Society or one to help support the Annual Congress. Our current Treasurer, Professor Rob Chilcott, has now set up a scheme for individuals to donate to the Society in a tax efficient manner. Further details are described in the BTS Treasurer's report and I would urge members to support BTS by personal donations.

In terms of membership income, from the result of the Extraordinary General Meeting held in June 2022, the Society has raised membership fees for 2023. This is the first fee increase since 2018. The Society has also implemented a £20 student administration fee. As described in the Treasurer's report, the accounts of the Society are formally examined in order to meet Charity Commission requirements. The Society does have some financial reserves, which are maintained within Charity Commission guidelines, in order to achieve the sustainability of the Society by enabling operating costs to be met for a period during times of financial distress.

The company donations and the increase in membership fees will permit the Society to continue to support many initiatives including the Annual Congress, Speciality Section webinars and other meetings, Network for Early Stage Toxicologists (NEST) activities, student scholarships and bursaries. Details of the various bursaries and scholarships offered by the Society can be found on our website.

The achievements of the Society in 2022 include the establishment of a new website, a successful Annual Congress, Speciality Section activities, production of public statements and a project on looking at the skills gaps in training for regulatory toxicology.

Over the last year the Executive Committee has been working with Insights to develop our new website. Drs Fiona Sewell and David Mason have led this initiative and I would like to sincerely thank them for all their hard work. I hope you will all agree that new website is a great improvement over the previous version.

<u>President's Report</u> for the Year Ended 31 December 2022

As already mentioned, the Society held a very successful Annual Congress in April 2022. The Scientific Subcommittee, chaired by Dr Lesley Reeve, have produced an excellent programme for the April 2023 Congress. In addition, the Scientific Subcommittee are actively identifying suitable venues for the BTS Annual Congress 2024 and 2025 meetings in order that members can be aware well in advance of the dates of these future meetings. The Society has a number of Speciality Sections which comprise Regulatory Toxicology, Risk Assessment, Clinical and Human Toxicology, Mechanistic and Discovery Toxicology and Computational and In silico Toxicology. All these five Speciality Sections have been very active in 2022 and have held webinars and other meetings. In addition, a new Speciality Section on Ecotoxicology has been established. Dr Natalie Burden will chair this new Speciality Section. The Speciality Section webinars and other meetings provide training opportunities for BTS members and can be used as part of continuing development for UKRT registration. They also provide an opportunity for all BTS members (from student to retired members) to keep up to date with various aspects of toxicology.

The Public Communications Steering Team, chaired by Dr Phil Botham, has continued to produce proactive and reactive statements relating to issues in toxicology which are of interest to the general public. There are now over 20 public statements available on the BTS website. The BTS has conducted a project to understand and identify skills gaps in training for regulatory toxicology. This project has been co-ordinated by Dr Sarah Judge (University of Newcastle) supported by an Advisory Panel of experts across a number of sectors. The report of this project is now available on the BTS website.

BTS members should be aware that the Society is affiliated to the journal, Toxicology Research. I would encourage BTS members to submit manuscripts to this journal. The Society does receive a small donation from the publisher for each paper published in the journal by a BTS member.

As at the start of this report, I must reiterate that I am extremely grateful to all those who serve as members on the Executive Committee and its subcommittees, the Speciality Sections and the Ambassadors. I do encourage members to participate in the Society by becoming members of BTS Committees. Vacancies for BTS committees are published regularly both in the BTS Newsfeed and on the BTS website.

With respect to the Executive Committee, we have been seeking a new General Secretary and a new Treasurer. I am delighted that the Executive Committee has endorsed the application of Frances Hill for the Treasurer's position. A vacancy for an ordinary member has also become available due to a retirement and I am pleased that the Executive Committee has endorsed Dr Ehi Idahosa-Taylor for this position. The appointments of both the new Treasurer and the ordinary member of the Executive Committee are of subject to ratification at the AGM. For the General Secretary position, I am most grateful that Professor Shirley Price, who has been acting General Secretary since April 2022, has very kindly agreed to take on this role for the next 2 years while we seek a new General Secretary to work with Professor Price and to then take over the role permanently from April 2025.

This April sees the retirement of two members of the Executive Committee, namely Professor Rob Chilcott and Dr John Thompson. I should like to thank both Professor Rob Chilcott and Dr John Thompson for all their excellent efforts in helping the Society achieve its objectives. In the case of Professor Chilcott, Rob has very kindly agreed to shadow the new BTS Treasurer over the coming year.

I do hope that 2023 will be a successful year for the Society and I would encourage all BTS members (from student to retired members) to become more involved in Society activities.

Report of the Trustees for the Year Ended 31 December 2022

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31 December 2022. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and significant activities

The Society is established for the promotion and advancement, for the public benefit, of education in the science of toxicology. In deciding the aims and activities of the society, the trustees have paid due regard to the guidance issued by the Charity Commission on public benefit. Toxicology is the science of disease induced by chemicals present in the diet, medicines, and in the environment. The British Toxicology Society (BTS) is a leading international toxicology society, based on the highest quality science, and promotes the advancement, communication and understanding of the scientific disciplines necessary to foster public health and environmental safety.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The Society is a company limited by guarantee and the liability of members is limited to an amount not exceeding £1. It is exempt under Section 60 of the Companies Act 2006 from the requirement to use the word 'Limited' in its title. The Society is governed by the Memorandum and Articles of Association. It is registered with the Charities Commission, number 286197, and no liability to taxation arises.

The Executive Committee are Directors for the purpose of company law and Trustees for the purpose of charity law. Directors/Trustees are appointed by the Society's members at the Annual General Meeting. When a Trustee retires, the Executive Committee nominates new Trustees. Additional nominations may be made by the membership, provided they are signed by six members of the Society.

Informal induction procedures are in place for new Trustees, conducted by an existing member of the Executive Committee and they are also provided with relevant documentation to formally advise and inform them of the Society's constitution and objectives and also their duties and responsibilities as a trustee.

One third of the Executive Committee ordinary members retire each year in rotation but are then eligible for re-election. The society is organised so that the Trustees, in the form of the Executive Committee, meet regularly, usually on a quarterly basis, to manage its affairs. There are also sub-committees which are responsible for advising and researching the various activities and development of the Society, who report to the Executive Committee.

Statutes for the workings of the various sub-committees are continually being revised and updated to ensure that the terms of reference are clearly defined and the ways of working are consistent. This also enables transparency of committee elections and duration of membership, while allowing the committees to work to agreed aims, backed up by comprehensive set of Standard Operating Procedures for the Society.

The trustees have assessed the major risks to which the Society is exposed, in particular those related to the operations and finances of the Society, and are satisfied that systems are in place to mitigate exposure to major risks.

All of the officers and members who serve on the Society's committees are unpaid. They are entitled to be reimbursed for any out of pocket expenses incurred in attending meetings.

No related parties, related party transactions, beneficial relationships or conflicts of interest requiring disclosure by the Charities' or Companies' Acts existed during the year.

Attendance by Executive Committee members has been reasonable throughout the year. The co-opted members continue to provide liaison with the relevant Sub-Committees and Speciality Sections.

The day to day administration of the Society is undertaken by an outside agency on a fee basis.

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Going concern

There are no material uncertainties about the charity's ability to continue.

The trustees' assessment of the risks associated with Brexit and the pandemic are detailed in the President's report.

Financial reporting standard 102 - reduced disclosure exemptions

The charitable company has taken advantage of the following disclosure exemptions in preparing these financial statements, as permitted by FRS 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland':

- the requirements of Section 7 Statement of Cash Flows:
- the requirement of paragraph 3.17(d);
- the requirements of paragraphs 11.42, 11.44, 11.45, 11.47, 11.48(a)(iii), 11.48(a)(iv), 11.48(b) and 11.48(c):
- the requirements of paragraphs 12.26, 12.27, 12.29(a), 12.29(b) and 12.29A;
- the requirement of paragraph 33.7.

Income

All incoming resources are included in the statement of financial activities when entitlement has passed to the charity; it is probable that the economic benefits associated with the transaction will flow to the charity and the amount can be reliably measured. The following specific policies are applied to particular categories of income:

- Income from donations or grants is recognised when there is evidence of entitlement to the gift, receipt is probable and its amount can be measured reliably.
- Legacy income is recognised when receipt is probable and entitlement is established.
- Income from donated goods is measured at the fair value of the goods unless this is impractical to measure reliably, in which case the value is derived from the cost to the donor or the estimated resale value. Donated facilities and services are recognised in the accounts when received if the value can be reliably measured. No amounts are included for the contribution of general volunteers.
- Income from contracts for the supply of services is recognised with the delivery of the contracted service. This is classified as unrestricted funds unless there is a contractual requirement for it to be spent on a particular purpose and returned if unspent, in which case it may be regarded as restricted.

Expenditure

Expenditure is recognised on an accruals basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is classified under headings of the statement of financial activities to which it relates:

- Expenditure on raising funds includes the costs of all fundraising activities, events, non-charitable trading activities, and the sale of donated goods.

1. ACCOUNTING POLICIES - continued

Expenditure

- Expenditure on charitable activities includes all costs incurred by a charity in undertaking activities that further its charitable aims for the benefit of its beneficiaries, including those support costs and costs relating to the governance of the charity apportioned to charitable activities.
- Other expenditure includes all expenditure that is neither related to raising funds for the charity nor part of its expenditure on charitable activities.

All costs are allocated to expenditure categories reflecting the use of the resource. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs are apportioned between the activities they contribute to on a reasonable, justifiable and consistent basis.

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.
