

## IHOMSA AGM

### Financial Report 2021-2022

Fundraising activity in the 2021-22 school year was again impacted by the effects of Covid-19, limiting the number of events that were able to take place in the early part of the school year.

The Christmas activities in school raised £2,762.18, with the Christmas Wreath making activity raising another £163.50.

Mother's Day stall raised £770.44, and Father's Day stalls raised £756.81. The 'Break the Rules Day' raised a fantastic amount of £1,262.36 with very little up-front effort.

The Marathon Challenge in June raised £1,100.22, including Gift Aid, via JustGiving – again, with very little up-front investment of time.

The return of the Summer Family Night was a great success, raising a total of £5,541.53

Amazon Smile donations raised £247.73, Easyfundraising donations raised £462.20, and the Sainsbury's collection tins raised £306.05.

The 100 Club raised the sum of £3124 over the financial year. At the time of reporting, 11 draws remain to be made and paid, with a small amount (£66) owed in overpaid subscriptions

A donation to IHOMSCPS of £1000 for end of school year events activities was agreed by has not yet been transferred.

Overall, IHOMSA's net income for the 2021 /2022 financial year is very positive at £15,443.12. The year-end balance across all accounts, and subject to reconciliation of the 100 Club draws and payments, was £36,506.37.

Thanks for this Mari. I have added explanations for the differences on to a new version, v3, attached.

The one thing I cannot explain is value of £35,143.83 that appears as the end balance on the bank transactions sheet. This is a data extract from Virgin Money, which does not appear to have calculated the correct balances for each row - you can see that by looking at the first 3 transaction rows. I'm not sure what to do about this - I can try extracting and labelling the data again, if you like?
