All Trustees were in office for the full year.

B. Structure, Governance and Management

The Preschool's governing document is it's Constitution and the Preschool is a body in membership of the Preschool Learning Alliance.

The Preschool's committee are responsible for the overall management and control of the Preschool.

The Committee members are also the charity frustees of the Preschool.

Committee members are appointed annually at the Preschool Annual General Meeting, by the members of the Preschool.

C. Objectives and activities

The aims of the Preschool are to enhance the development and education of children primarily under statutory school age by encouraging parents to understand and provide for the needs of their children through community groups and by offering appropriate play, education and care facilities for all children whatever their race, culture, religion, means or ability.

Occupancy continues to rise, with each intake to the primary school. We have continued to recruit staff to support with the increasing numbers of children in the play group. Throughout this year we have had a waiting list of pre-school children wanting to join.

E. Financial Review

Reserves policy

It is Preschool policy to maintain a balance on unrestricted funds, if possible, which equates to at least one months unrestricted payments, equivalent to £4 400. The balance held of £29,117 exceeds this target.

Financial Review

Total receipts were E81k, an increase of E5k from last year ---attributed to the reputation of the preschool generating more interest and an effort to get to near full occupancy.

Wage costs are higher, both for the extra cover and increase in National minimum and living wage.

Accounts have been kept up to date.

We have managed to do some fund raising this year which has helped a lot.

Various fundraisers throughout the school year helped raise £758 which was spent on a leavers party and new equipment for the school.

The net result for the year was an excess of receipts over payments of £5,357, this is due to increased numbers in children attending pre-school.
