## Public Benefit Statement

It is the recognised voluntary agency through which the Anglican Church of Papua New Guinea (ACPNG) and the Anglican Church in the UK and Ireland relate to each other, effectively acting as London Office for the Province and dedicated to raising awareness of and support for the Church's mission and ministry in PNG.

ACPNG may request people with skills and expertise in particular areas, and when asked to do so PNGCP will facilitate the recruitment of personnel for ACPNG. In addition, PNGCP acts as a conduit for donations from the UK to Anglican personnel, projects, parishes and dioceses within Papua New Guinea.

The Trustees have had regard to the guidance issued by the Charity Commission on public benefit.

# Objectives

The objectives of the Charity are :

- to encourage a Christian partnership with the Church in Papua New Guinea
- to assist the maintenance and extension of the work of the Anglican Province of Papua New Guinea in all or any such ways as the House of Bishops of the Province of Papua New Guinea for the time being shall approve
- to forward the interest of the Anglican Province of Papua New Guinea within the United Kingdom and elsewhere in all such ways as are within the competence of the Committee.

## Activities, achievements and performance

Donations from supporters in 2022 were at a similar level to those in 2020. As a result of this we were able to send donations of £38,200 to ACPNG.

£15,000 to Newton Theological College :-

 $\pm 5,000$  to support the training of 10 theological students with  $\pm 500$  each. Most of this funding coming from Parishes in Scotland and the Scottish Episcopal Church.

 $\pounds$ 10,000 to help upgrade plant, equipment and services to meet Government guidelines.  $\pounds$ 4,000 to the Society of St. Francis to help with their electrification project to connect the Friary to mains electricity.

 $\pounds$ 3,500 to Mission Aviation Fellowship (MAF) to help with their Church and Evangelism Project transporting Mission and Church Workers and vital freight into hard to reach areas.  $\pounds$ 10,700 to Aipo Rongo Diocese :-

£10,000 to help with the rebuilding of a Health Centre.

£700 for medical supplies for Covid – 19 patients.

£4,500 to KiKi Early Childhood Learning Centre to support courses for teachers in Early Years Phonics training.

Following a growth over recent years in our relationship with the New Zealand Diocese of Waiapu as we both seek to support ACPNG, we invited them (via the Williams Trust there) to join us in supporting the project for the Franciscan Brothers, which they accepted. We hope this shared support of appropriate projects will continue.

Work has continued on our archives, thanks to our USPG volunteer archivist, in preparation for their safe keeping at the School of Oriental and African Studies (SOAS). Other materials are being documented prior to their use (films) or dispersal.

The Trustees and wider Committee met four times during the year. The first meeting was held by Zoom and the other three meetings in person with the facility to join in by Zoom for those members who were restricted by transport problems. Partnership working with ACPNG was maintained through email and telephone communication.

Currently there are no PNGCP sponsored personnel from the UK working with ACPNG.

Three Newsletters were produced for UK supporters and shared with ACPNG and their other overseas partner agencies. The Newsletter is produced in email format and as a hard copy since many of our supporter group have indicated they prefer this. The Charity has an active website and Facebook page.

We receive Newsletters from ACPNG that are distributed online to supporters and friends.

The Committee meeting in August was an opportunity to meet with the Acting Archbishop, two Diocesan Bishops and their wives from PNG who had come to the UK for the Lambeth Conference. The Bishops outlined some of the issues of concern in their Dioceses for some of which they would require major funding.

The Bishops and their wives stayed in the UK for a further week. The Committee had arranged some visits to supporting Parishes and places of interest, some of which had a PNG connection.

The London based members took them all on a sightseeing day in London. This included a boat ride to the Tower of London, a visit to All Hallows' by the Tower (London's oldest church), then to the Mothers' Union Headquarters and Chapel at Mary Sumner House, followed by tea in Westminster Abbey and a walk through the Nave to view PNG Martyr, Lucien Tapiedi's statue.

The next day the Bishops and their wives travelled to three different parts of the UK where members are based, for five days.

Bp Lindsley and his wife Felicity from Popondetta were met in Coventry where they visited the National Trust's 600 year old property Baddesley Clinton, the Cotswold village of Bourton -on -the-Water and went to Evensong at Christ Church, Oxford.

On Albert Maclaren/Copland King Day, (2 of the first missionaries), Mass was celebrated, using the ACPNG Rite and a bungkai (feast) prepared including a PNG receipe. On the Sunday there was a bungkai with the wider church enabling more people to meet Bp Lindsley and Felicity who spoke of the brimming churches in PNG and the faith of the people there.

Bp Reg and his wife Kathlyn from New Guinea Islands were taken to Cambridge where they were able to view letters written by Queen Elizabeth 1 and the original copy of the '39 Articles' at the Parker Library, then Evening Prayer at Little St Mary's Church (long time supporters of ACPNG) was followed by a reception at which Bp Reg talked about his Diocese.

Bp Reg relies on boat travel in his Diocese so a visit was made to see the construction and repair of wooden boats at the International Boatbuilding College in Lowestoft. A visit was also made to Walsingham Shrine followed by tea with the Norwich Link Committee and then to the 13<sup>th</sup> century St Oswald's Ashwicken, (Norwich's smallest church). On the Sunday Bp Reg gave talks at Southwold and Wangford churches.

Acting Archbishop Nathan and his wife Jesicah from Aipo Rongo were met in Durham and went to St Michael and All Angels Church in Houghton-le-Spring where their host, a former Bishop of Port Moresby had been a curate, then a coastal trip and a walk on the beach before visiting St Ignatius Hendon in Sunderland (long time supporters of ACPNG) where a previous vicar, Philip Strong later became Bishop of New Guinea. This visit was on St Lawrence Day, the 131<sup>st</sup> anniversary of the first Anglican missionaries landing in what would become PNG. After an evening Mass Bp Nathan and Jesicah spoke to the congregation.

Then on to Scotland where their hosts had previously worked with them in Aipo Rongo Diocese. Formal visits included tea with the Bp of Edinburgh and his wife and meeting congregations at supporting parishes in the Edinburgh Diocese. Other visits included a trip to Holy Island where Christianity arrived 1400 years before PNG, a full scale lifeboat call out at St Abbs and a walk to the harbour, where at low tide Bp Nathan explored the seaweed covered reefs – a vast contrast to his home high up in the mountains.

## **Financial Review and Reserves Policy**

At the end of the year our reserves (unrestricted funds) were £80,805. (2021 £96,604). Our reserves policy requires us to carry reserves sufficient to safeguard costs of any staff. In addition, the Trustees consider it prudent that unrestricted funds should be sufficient to provide one year's operating expenses. During 2022, £2,806 was spent on administration and £5,230 during the Bishops visits to the UK, but we believe we hold more than sufficient reserves to safeguard the needs of PNGCP.

## Plans for future periods

We plan to continue sending money to the Anglican projects, parishes and Dioceses of PNG in 2023. We will continue to develop our website and our Facebook page, to increase our profile and knowledge of our work.

We will continue our promotional activities within the UK and it is anticipated that we will initiate a programme to welcome and support a member of ACPNG staff on a personal development visit to the UK towards the end of 2023.

Plans have been made for a group of Trustees, including those who have not yet visited PNG, to attend the Partners' Meeting later in the year.

Support for volunteers overseas is ex gratia payments to volunteers aiding ACPNG in country at their own expense.

The Charity qualifies as a small entity as outlined in Financial Reporting Standard No. 1 and has used the exemption provided by that document under which it is not required to include a cash flow statement as part of its accounts.
