Objectives and Activities

The Parochial Church Council of Tong (the PCC) has the responsibility of co-operating with the minister in charge, the Reverend Thorneycroft, in promoting in the ecclesiastical parish, the whole mission of the Church, pastoral, evangelical, social, and ecumenical. The PCC is also spiritually responsible for the maintenance of the church.

The PCC is committed to enabling as many people as possible to worship at our church and to become part of our parish community at Tong. The PCC maintains an overview of worship throughout the parish and makes suggestions on how our services can involve the many groups that live within our parish. Our services and worship put faith into practice through prayer, scripture, music and sacrament. Also, through non sacramental activities of hospitality and fellowship we aim to reach non churched members of the community.

Public Benefit

The trustees of the PCC are aware of the Charity Commission's guidance on public benefit in The Advancement of Religion for the Public Benefit and have had regard to it in their administration of the Charity. The trustees believe that, by promoting the work of the Church of England in the Ecclesiastical Parish of Tong, it helps to promote the whole mission of the Church (pastoral, evangelistic, social and ecumenical) more effectively, within the Ecclesiastical Parish, and that in doing so it provides a benefit to the public by:

- Providing facilities for public worship, pastoral care and spiritual, moral and intellectual development, both for its members and for anyone who wishes to benefit from what the Church offers; and
- Promoting Christian values and service by members of the Church in and to their communities, to the benefit of individuals and society as a whole

Vicar's Report 2022

It has been a momentous year in some ways nationally which naturally affect the local scene; first there was the **Platinum Jubilee** to mark 70 years of Queen Elizabeth on the throne and we celebrated with a parish lunch; in September **the Queen died** and we mourned with the tolling of the Great Bell; we have also officially ended all the Covid 19 restrictions and re-introduced the chalice at Communion - and we have noted the coming and going of 3 prime ministers! In addition, the economy had taken a nosedive and our Food Bank is in more demand than ever but all sections of society are reacting to the cost of living crisis which has been driven by the hike in energy costs largely due to the war in Ukraine which began with an unprovoked attack by Russia in February. These have all been the subjects of our intercessions.

Funerals, Burials, Cremations: In January I attended the funeral of the oldest member of our congregation, Gwen Myerscough, in Liverpool cathedral where she had worshipped and been a support for seven decades, until she came to be cared for by her son Fred and his wife, Diane. We buried her ashes in Tong on her 108th birthday. There have been 5 church funerals and burials, (3 new graves and 2 reopened), 3 cremations of people with Tong connections, 4 further cremations 'outside', one church service followed by cremation and one double Memorial service for a wife who died early in the pandemic and her husband who followed her after it was over. With Gwen, four burials of ashes in the churchyard. I also conducted a Memorial service in the Golden Chapel for a lady who had committed suicide from the M 54 bridge for her distressed son.

Weddings and Baptisms: Marriages in church were more numerous this year: 8 couples at Tong and two in Shifnal and the bellringers also rang for Viscount Newport's wedding although the ceremony was in Weston. Ten infants were baptised including the twin grandchildren of one Church Warden and the American granddaughter of our other Church Warden. It must be admitted that 3 of those families came from a nearby parish because of the delay in getting their children baptised while they were still infants. It is always nice to welcome back the offspring of couples who were married in church, and we had two of those.

Being so close to RAF Cosford brought us a bonus in 2022 as the **Revd Jesse Holland** and his wife and three big sons came to worship with us and it was good to hear Jesse preach - without a note and just the Bible in his hand - and he was prepared to stand in for me when I was away. At our Bank Holiday Evensong, The Ven John Hall, a former vicar here and archdeacon of Salop, gave a rousing sermon. That service was further enhanced by St. Andrew's choir.

Bells: During the year the Tower Captain, Rex Edwards, stepped down and we made a presentation of a watch for his long service. Phil Murphy has taken over and

one new rope has been fitted and one spliced. The established ringers are very competent, and some others are coming along to learn.

Organ: We have again had a throughput of organists for whom we are very grateful, but the star prize goes to Ruth Pilsbury who plays month in month out, though we try to give her one Sunday off regularly. It is more difficult to organise a seamless rota with more than one organist and I anticipate there may be a day when no one turns up to accompany the singing.

Zooming: One of the things we have learnt due to Covid 19 is how to meet each other online via Zoom and although not as satisfactory as in person, it does cut down on a lot of travelling, so, for example, the renewal of our Safeguarding training is now done electronically, but I am pleased that our PCC meetings have been able to resume in person.

Architect's Plans: Regarding the building, especially the provision of toilets, Tim Ratcliffe has taken over as our architect, though the glass doors were installed (finally) under the auspices of Donald Insall. After such a long wait it has been a disappointment that they need adjustment to prevent them coming open all the time. This is not yet solved but is in the hands of Insalls and Treasures the contractors. In February we agreed with the architect that he would draw up an extension on the north side with access through the 'Door of excommunication'. We put in a faculty application to that end, but many months later and there seemed to be little progress, though we had had to wait for a detailed pew appraisal which eventually arrived. With the passage of time the north side extension seemed less appealing, and we returned to another option - a lightweight extension through the West doors to be made of oak and glass. This got a unanimous vote a week into the New Year 2023, partly because members of the PCC are so tired of the whole thing, partly because with increased number of visitors, the toilets are such an obvious necessity and partly because if the west end extension is ever not required, it can be removed with no detriment to the 15th century church. It has been agreed that the kitchen part of the arrangement will remain where it has been for the past 30 years viz inside the northwest corner near the font but with the addition of running water, a sink with drain and storage.

Visitors have increased in number because of an advertising campaign in the local "Connect Pages" (60,000 homes) for 3 months. There have been **tours** for over 700 quite apart from casual visitors for which we have to thank Christine Deane who does all the bookings, and all the organising of helpers, buying of food and supplying lunches and teas in the Village Hall. It is a lot of work, and I am immensely grateful to her for boosting our income by over £6,000. I also much appreciate the work of the guides - Sandra Owen is new to the team this year - but Robert Parry does the bulk of them including Heritage Tours in September which are advertised nationally.

Other things to mention: **Airband** was installed thanks to some negotiations on our behalf by Philip Hutchinson, though it is still difficult to receive a signal inside the building.

The clock workings have had to have a makeover at considerable cost, much of which has been borne by the Parish Council, since for historical reasons it is a parish clock sited on the church.

The almshouses are in a parlous condition and the permission awaited to sell them is in the hands of the Charity Commissioners but is a very long time coming.

The Bradford Estate has organised for **the Justice Department** to do work on the fencing at the bottom of the churchyard.

The Website has been kept up to date by David Alcock and is a very good advertisement. He has, with the connivance of Rob Stallard, incorporated the "Discovering Tong" website (based on Robert Jeffery's book). The spin-off of that merger is that we will be responsible for mailing out any book purchases. I am so grateful to David for all the hours he puts in free of charge and I know that it tends to be bottom of my To-Do pile and he has to be very patient with me.

Country Kids Nursery: keep in contact and visit the church with parents and grandparents at Christmas, Easter, and Harvest. This is our only ongoing link with children now and although mayhem, a very good introduction to our sacred building and reassuring to know the under-fives are being taught the rudiments of the Christian faith. One visit had to be cancelled in 2022 due to an outbreak of chickenpox, but I was able to visit the nursery a bit later.

Meashill Farm Wedding Venue: Eliza, the wife of Viscount Newport, has put forward a plan to develop the Grade 2 listed farm with a wonderful view towards Tong (and beyond) as a complete wedding venue with an agreement that if couples should desire a church wedding, St. Bartholomew's will be pleased to offer their services.

Women of Tong I have been asked to do three lectures on my research for the booklet with slides and have given the payment into Tong's coffers. However, I find that it takes up too much time and energy and have declined further such invitations.

Arts Society Lecture by Philip Modiano on Rev. J. L. Petit who painted some exquisite pictures of our church inside and out in the nineteenth century which have only recently been discovered. Some reproductions are now displayed in our display cabinet near the south door.

Parish Extravaganzas Besides the parish lunch for the Jubilee, we held a Classic car day on August Bank Holiday which was nearly disastrous because at the last

minute we had no classic cars, but in the event, we had 25 thanks to word of mouth (+ various stalls) and it was a lovely day.

At Christmas we had 25 sponsored decorated trees and made £1600.

Contactless payment machine. It is time to upgrade our little machine and shortly a more accessible one will be installed.

Some sadness's: Revd Roger Balkwill has died. He was my original training incumbent and although notoriously tricky, kept a lively faith and was still preaching well to the end.

Paul Joseland has been a long-term help and support but in hospital for months. Now one leg has been amputated. There are several others on our sick list. We pray for them & their families.

Church Wardens Report 2022

Well once again it has been a challenging year for Tong church. The good news is that

(1) with the easing of Covid restrictions our congregation numbers are slowly increasing back to the pre-Covid times.

(2) We have also seen an increase in the number of weddings and christenings this year (some which had been delayed due to the pandemic lockdown).

(3) We have also been able to do several fund-raising events. A Christmas fayre at the Albrighton church hall raised £850.00 organised by Ruth Pilsbury and Ruth Kerrigan doing the catering. Many said it was so nice to sit and have coffee and lunch with friends for the first time in almost two years. The fayre was also attended by members of other local congregations.

A Platinum Jubilee lunch was organised with Ruth Kerrigan preparing a hot meal and other ladies provided puddings. Sally Beard donated an enormous Jubilee cake which we all enjoyed with tea and coffee. This raised £504.00 and again it was so nice to sit and have lunch and refreshments with congregation members and friends. Furthermore, Tong tours have also resumed and with the help of the ten volunteer ladies who cater for the guests, a special thank you to Christine Dean for organising these events, we have raised a total so far from January to date of £2,864. A big thank you to those who give up their spare time to act as guides.

Paul Joseland organized a speaker to attend the church and give a presentation of pictures from many years ago of local churches, painted by the Reverend Petit (of which Tong was his favourite), an afternoon tea was organised and raised the sum of £550.

This August bank holiday (make a note in your diary) we hope to hold a vintage car display with a cream tea afternoon and some other craft stalls organised by Max Owen.

Our three challenges are incorporated in the building works and repairs. The first challenge is to finish off the South porch entrance by the installation of the glass doors.

Our second challenge is to install a toilet. This issue has been ongoing for a long time, and I feel that by having one would only enhance the amenities the church provides and prevent a long walk to the village hall!

The third challenge is to provide a tea point within the church, this project like the toilet issue has been ongoing for many years and needs to be resolved!

Also, we have upgraded our sound system and enhanced our lighting by replacing electrical cables inside and outside the church.

The support from the congregation (of which the numbers have managed to remain at a steady level) during this year has once again been overwhelming. People are coming forward to help in many ways whether it is cleaning/sanitising, playing the organ, opening /closing of the church, readings, serving communion, flowers and prayers or recording and banking the funds.

The Reverend Pippa has managed to get donations from various current parishioners and other donations in memory of family members that have passed away to purchase new frontals and soon hopefully matching lectern covers etc. These were badly needed as the old ones had seen better days. We now need to purchase some pew cushions to make the church services a little more comfortable especially for the elder church members.

In April we had a new church warden join the team. Unfortunately, she is not here tonight as she is in America visiting family for a month. Her name is Sandy Baker. I am sure you will meet her at future events. A big thank you needs to go to David Milner who has been church warden on and off for many years. David is still helping a little on the finance side but would like to wind down. I don't blame him after all the years of service he has given.

The Reverend Pippa keeps in touch with the members of the congregation about their general welfare and well-being. We are always grateful for all the tremendous hard work that Pippa puts in and the rest of the congregation (PCC, the treasurers, vergers) a big thank you to them all. We look forward to a more peaceful and progressive 2023.

Secretary's Report 2022

2022 saw a reintroduction of face-to-face church services/meetings etc. after a relaxation in rules following the Covid 19 pandemic which started in 2020. The congregation enjoyed meeting up again without restrictions and attendances at church services continued much the same as prior to the pandemic with all familiar faces returning.

There were 5 St. Barts PCC meetings in 2022 – January, March, June, August, and October with 2 joint PCC meetings with Shifnal and Sheriffhales held at St Andrews, Shifnal. All St Barts PCC meetings were well attended by members and each meeting provoked lively debate regarding matters to progress, ranging from a new heating system within the church to the provision of toilets and where best these could be included to protect the artifacts and structure of the church. Finances were a standing agenda item at each meeting and all members were able to track income and expenditure whilst reflecting on all the progress made to further enhance the church for the benefit of the congregation and visitors to the church alike. Both Joint PCC meetings discussed church attendance, particularly in the context of declining attendance at Sheriffhales. At the December joint PCC there was a presentation of charity work being undertaken in Africa "Hands at Work"

Several events were enjoyed during 2022, including an August Bank holiday fete with a classic car display and in December St Barts hosted the Christmas Tree Festival. Both events were very well attended and raised funds to support the ongoing development of the church.

DEANERY SYNOD REPORT 2022

3 Meetings were held during the year.

16 Feb 2022 St Michael's Lilleshall -

The meeting began with an interview with Malcolm Maclean the new Lay Chair. The Rural Dean gave an update on Bishop Michael's 'Shaping for Mission' initiative, in particular how to make the Deaneries more efficient by sharing resources, both people and facilities. The local update for the deanery indicated that this could mean operating in 2 'clusters' based around Newport and Shifnal/Albrighton. The meeting continued with an update from parishes and a report on the Deanery Synod Finances.

12 June 2022 St Andrews Shifnal

The meeting began with an interview with Geoff Lott. Rev Chris Dentsham gave a talk on the church in Telford and Shropshire, describing his work with 'Churches Together'. Numbers attending regular church had declined since the pandemic and the need for outreach was stressed. Rev Zoe Hemmings then gave a talk on 'Enabling All' and the need to be aware of 'concealed disabilities' among worshippers and those using church facilities. The meeting ended with updates from Parishes.

9 November 2022 St Mary's Albrighton Church Centre

The main event was a quiz, including photographs of various churches in the deanery. Questions varied from ecclesiastical to general knowledge, inspiring much discussion between team members. Interviews with Rev Kay Roberts and Kerry Holt followed. The rural dean gave an update on 'Shaping or Mission' and various initiatives to share resources. The meeting ended with news from Parishes.

Safeguarding

Volunteers

The members of the PCC would like to thank all the volunteers who work so hard to make our Church a lively and vibrant community.

Risk Management

The Church Wardens carry out regular Health and Safety Reviews and regularly inspect premises for potential hazards. We have safeguarding policies in place for child protection and for work with vulnerable adults, including rigorous DBS checking of staff and volunteers. Our insurances are reviewed annually to ensure adequate cover. An informal review of any new risks which may impact the work of the Church in the Parish is ongoing.

Structure, Governance and Management

The PCC is a Body Corporate established by the Church of England and is a charity registered with the Charity Commission. No. 1192842. The PCC is governed by the Parochial Church Council Powers Measure (1956) as amended that came into effect on 2nd January 1957, and the Church Representation Rules (contained in Schedule 3 to the Synodical Government Measure 1969 as amended).

The method of appointment of the PCC members is set out in the Church Representation Rules. The Council comprises the Incumbent, the Churchwardens, a representative of the Readers, those elected to the Deanery Synod, and other members who are elected at the Annual Parochial Church Meeting, by those on the Electoral Roll. The PCC members receive training from courses run by the Diocese. Members of the congregation are always urged to join the Electoral Roll, and to stand for election to the PCC. The PCC members are responsible for making decisions on all matters of general concern and importance in the parish, and for all financial matters. The PCC meet 4 times a year.

Related Parties

Donations from Related Parties

Donations from related parties during the year totalled £7,596 (2021: £7,288). All these donations were received without conditions.

Remuneration paid to Trustees

None of the trustees have been paid any remuneration or received any other benefits from employment with the PCC.

Expenses paid to Trustees

1 trustee was reimbursed £429 (2021: £239) for travel and subsistence during the year.

Reserves Policy

It is PCC policy to try to maintain a balance on free reserves (net current assets) which equates to at least three months unrestricted payments. This is equivalent to £10,282 (2021: £12,366). It is held to smooth out fluctuations in cash flow and to meet emergencies. The balance of the free reserves at the year-end was £62,307 (2021: £50,580) which is considerably higher than this target. The PCC is comfortable with this high figure as it gives a cushion in these uncertain economic times.

Respective responsibilities of the Trustees and Independent Examiner

Accounting Policies

The financial statements of the PCC have been prepared in accordance with the Church Accounting Regulations 2006 using the Receipts and Payments basis.

There may be minor discrepancies in the totals as the pence are not being shown.

Fixed Assets

Consecrated and benefice property is not included in the accounts by s.10(2)(a)&(C) of the Charities Act 2011.

Moveable church furnishings held by the Vicar and Churchwardens on special trust for the PCC and which require a faculty for disposal are inalienable property, listed in the Church's inventory, which can be inspected (at any reasonable time). For anything acquired prior to 2000 there is insufficient cost information available and therefore such assets are not valued in the financial statements.

Description of Funds

Unrestricted funds are income funds of the PCC that are available for spending on the general purposes of the PCC, including amounts designated by the PCC for fixed assets for its own use or for spending on a future project and which are therefore not included in its "free reserves" as disclosed in the trustees' annual report.

Restricted funds comprise of two elements:

a) income from trusts or endowments which may be expended only on those restricted objects provided in the terms of the trust or bequest

b) donations or grants received for a specific object or invited by the PCC for a specific object. The funds may only be expended on the specific object for which they were given. Any balance remaining unspent at the end of each year must be carried forward as a balance on that fund. The PCC does not usually invest separately for each fund. Where there is no separate investment, interest is apportioned to individual funds on an average balance basis.

Endowment funds are restricted funds that must be retained as trust capital either permanently or subject to a discretionary power to spend capital as income, and where the use of any income or other benefit derived from the capital may be restricted or unrestricted. Full details of all their restrictions are shown in the notes to the accounts.
