## **Trustees' Annual Report**

One more successful year has passed in the work of the Ministry and Charity of the Christ's Vision Church United Kingdom. The Church Council (Trustees) thanks the Almighty God for his grace upon us his people and also all our members who support the work of the charity and of the ministry to advance the message of the Kingdom of heaven here on earth. Unlike the previous year, we did not experience much difficulties and limitations imposed by restrictions due to the Pandemic of Covid-19. We will also thank God for that.

The Trustees present this report together with the unaudited accounts for the year started 1 January and ended 31 December 2022. The Church Council has to comply with the requirements of the Charities Act 2011 with regard to the keeping of accounting records, to the preparation and scrutiny of statement of accounts and to the preparation of annual reports and returns.

# 1. Objectives and Activities

# Summary of the purpose:

The church purpose is to advance the Christian faith in accordance with the Statement of Faith of the Assembly of God GB (AoG) in such ways and in such parts of the United Kingdom or the world as the Church Council from time to time may think fit;

To relieve sickness and financial hardship and to promote and preserve good health by the provision of funds, goods or services of any kind including the provision of counselling and support;

To advance education in such ways and in such parts of the United Kingdom or the world as the church council from time to time may think fit.

## Summary of the main activities:

We provide a place of Christian worship, Biblical teachings and practical and Pastoral support. We preach the gospel of Christ to the people who attend our meetings. We organise a youth day for families in the local community. We provide Pastoral care to the Church in the form of supportive prayer, Bible studies and exhortation and meetings.

The Trustees have had regard to the guidance issued by the Charity Commission on public benefit as provided by our governing document.

#### 2. Achievements and Performance

## Summary of main achievements:

As a result of our gospel sharing through preaching during our services, evangelism through social media, and outreach to people, we received in our fellowship few people

who have given 'their lives' to Jesus Christ. New comers have joined in the Bible studies, and Christian education to the existing group to strengthen our faith in God. We used our place of worship, and electronic methods to achieve that. Unfortunately, few members too have slidden back and found it difficult to come physically to the meetings, but kept in following our services online.

-We reached out by making some visits to members who have been sick and lost loved ones and provided moral support through the Word of God; we provided some financial support to members in need in various forms; the total amount can be seen under the "care and community support".

Many members, especially the medically vulnerable ones, have already gotten the covid-19 vaccines including the boosters. We did not have to give much advice again this year. However, we continue to provide guidance on social distancing, keep good maintenance and sanitation of our place of worship or in our social contact as we understand that covid-19 is here to stay as a normal flu.

We provided funding aid to two orphanages and other people in the Democratic Republic of the Congo, as part of our mission abroad to respond to their different and varied needs, including help with foods when they made requests to the church: for example, in "Espoir" (Hope) Orphanage, where there are 36 young people, including very young ones, we brough clothing, support with rents, and a specific financial support for treatment to a young girl who is unable walk and have speech difficulties. The specialist doctors advised that she could walk again if treatment is followed properly, including machines to be used on straightening her legs to give her much chance to walk again. Her treatment is ongoing, which we may need to provide further financial support.

In "Moklisto" (Christian) Orphanage, we helped with the burial of a baby orphan who died under the orphanage care. The Orphanage made another request for school utensils for about 40 children, but we were unable to heed to that request for assistance on this occasion.

In Ukraine, we made a contribution towards the costs of receiving refugees who fled to Poland and resided in a church. The request was made to us through the Assemblies of God National leadership for all our churches to respond to this appeal to help. We have also spent a small amount in setting up and prayer cell group in Kinshasa, with a view to establishing a proper and permanent evangelical mission in that country. Angola is also within our sight for mission. All these are shown under "mission, partners and aid".

The support described above has made a lot of difference in the lives of people who received them.

The Youth and families Day organised in December was attended by church members and the community where we discussed the 'vision' as seeing what others cannot see, seeing in the future. Young people of the church- who are future ministers in the church- did share in giving Biblical advice after the Pastor spoke.

#### 3. Financial Review

The Income and Expenditure shows the financial position of the Church/Charity at the end of the reporting period. This shows a surplus, reserves fund of the church for this year of operation. The Church still owes money to no one, and has no overdraft with the Bank. This looks fine, as far as the Trustees of the Church are concerned. Thanks to you members who make this possible, and also to the management that we have put in place.

Amount of reserves: more or less £1,430.00 on the financial statement.

The reserves policy for the Christ's Vision Church (CVC) United Kingdom is to aim to hold at least 3 months general income as cash reserves. This is in addition to any fixed assets held and used for the Church' aims and purposes. This level of reserves should ensure, as far as possible, that at any time of the year the Church is not required to borrow funds on overdraft from its Bankers. Any additional reserves are generated with a view to fund longer- term projects. We have achieved that again this year, and with God's help and support of all members we should continue performing this way.

The church /charity has no concern as to its continuity. We are certain to continue the work started with God's help, as the Bible states that "I am sure of this that he [God] who began a good work in you will bring it to completion at the day of Jesus Christ- Philippians 1:6"

## 4. Structure, Governance and Management

A foundation model Charitable Incorporated Organisation (CIO) in fellowship with the Assemblies of God GB, type of governing document.

The church/charity is <u>constituted</u> as Charitable Incorporated Organisation. The Trustees <u>method of selection</u> is governed under our Governing document section 9.6 that provides that "the members of the Church Council shall comprise Senior Minister and other ministers of the church together with such person as the Senior Minister shall nominate and the Church Council shall from time to time appoint. In selecting individuals for appointment as Charity Trustees, the charity Trustees will have regard to the skills, knowledge and experience needed for the effective administration of the church"
