STRUCTURE GOVERNANCE AND MANAGEMENT

The Church in Wales is governed by its Constitution, set up under section 13(1) of the Welsh Church Acts 1914, as amended from time to time by its Governing Body. The MAC is not a body corporate. Its composition, procedures and powers are regulated by the Constitution, which provides that before assuming office, every member must sign a declaration that he or she will be bound by the Constitution.

The Constitution provides that the members of the MAC shall be: The Incumbent, Vicars and Assistant Curates; two Church Wardens, one appointed by the Incumbent and one elected at the Annual Vestry Meeting (AVM); two Sub-wardens for each Church where there is more than one Church in the Mission Area, one appointed by the Incumbent and one elected at the AVM; Up to 25 lay members elected at the AVM; co-opted Secretary and Treasurer (if not already ex-officio or elected); and up to 7 further co-opted members. Lay, communicant persons over the age of 16 may be entered on an Electoral Roll (subject to certain conditions) and all such persons, so entered, are entitled to vote and to stand for election.

OBJECTIVES, ACTIVITIES AND PUBLIC BENEFIT

As required by the Charities Act 2011, the MAC has given due regard to guidance published by the Charity Commission in respect of the operation of the public benefit requirement. The activities undertaken to fulfil the MAC's purposes for the public benefit are described and detailed hereunder. The Church in Wales is a Province within the Anglican Communion and seeks to advance the Christian religion through world-wide mission. It is the responsibility of the MAC and the Incumbent to work together and co-operate in all matters of concern and importance to the Mission Area for the promotion of the mission of the Church, pastoral, evangelistic, social and ecumenical in the Mission Area. The MAC is responsible, inter-alia, for the parochial budget and all expenditure thereunder, the care and maintenance of Church fabric and of the Churchyards, and for any action or other matter referred to it in accordance with the Constitution, and is the normal channel of communication between parishioners and the Diocesan Bishop.

The MAC provides a benefit to the public by:

- a) The provision of regular public worship
- b) The provision of sacred space for personal prayer and contemplation.
- c) Pastoral work, including visiting the sick and the bereaved.
- d) Teaching of Christianity through sermons and small groups
- e) Taking of Assemblies in local schools
- f) Promotion of Christianity through staging of events and services, and the distribution of literature
- g) Promoting the whole mission of the Church in Wales in aiding community cohesion through provision of activities for older people, mothers and toddlers and other specific groups.

PLEASE NOTE: Due to restrictions around Covid-19 and the closure of our churches to the public for some of the year, no membership and attendance figures were gathered for 2021 or 2022. A new Membership App was being introduced and was expected to be rolled out in early 2023 which aims to capture this information.

ACHIEVEMENTS AND PERFORMANCE

2022 was dominated by two major issues, firstly the lessening of restrictions following the effectiveness of vaccinations against COVID and secondly, the invasion of Ukraine by Russia in February.

Each of these had implications for everyone and led to challenges and dangers in the way the Mission Area functioned during this year of major upheaval. In addition, due to United Kingdom political changes the financial markets were adversely affected, and anxiety levels increased across the global markets and within individual households. As the year progressed it became apparent that poverty within previously unaffected households was increasing and anxiety was fuelling a sense of panic about large numbers of families being unable to afford food or fuel. This context was the background to decisions made to extend the mission activity of the Mission Area.

Organisational

Firstly, following on from the committed work of the many church treasurers and our Administrator we were able to complete and submit to the Charity Commission our accounts for 2021 prior to the October cut off.

In February we had a new member of the team, Revd Richard Hainsworth, as Rector of Flint and during the year two Curates also joined the team, Revd Gareth Williams in Holywell and Revd Paul Emberton in the Whitford group of churches.

Also during the year Holywell churches have been formed into a Mission Hub with Revd Dominic Cawdell licenced as Mission Hub Leader and Jon Andrews appointed as its Youth and Children's Worker. A leadership team for the Mission Hub has been formed and an action plan agreed.

Missional

The Table at St. Peters, Holywell continued to function and expand. More families in need were able to obtain food, advice and support within its weekly gathering together. The Bread of Life service continued and has grown and pastoral support was offered throughout the year. The Food Bank also continued to operate from St. Peters and has also increased in the numbers of people accessing its services.

A Christmas lunch on Christmas Day also involved more people accessing it as it provided a celebration for people who would otherwise be on their own or unable to afford a full meal.

Although St Peters has seen the largest involvement of missional and community support activity we have extended additionally in other areas. Within the overall Mission Area we have supported a community shop, multiple weekly and monthly groups to encourage people to build new friendships and develop different skills and interests and in the latter part of the year a number of Warm Hubs were set up as the cost of heating homes soared and more and more people struggled financially.

During the year hundreds of Ukrainian refugees were temporarily placed at the Springfield Hotel in Halkyn and we have worked closely with Flintshire County Council on a twice weekly basis to host support sessions in the local community centre.

In addition, churches have been involved in celebrating national and local events, memorials, processions, street parties and the full liturgical year celebrations as the restrictions on meeting up and personal contact was lifted.

Contacts with both church schools and some state schools in the Mission Area have been restored with physical assemblies, set up of prayer spaces and other events including a full day with Caerwys Church school on creativity based on the parables.

Although for some all the early part of the year, services and events were offered online but as restrictions were eased, online and physically present were delivered side by side.

Developmental

As the COVID restrictions were lifted and groups were able to move offline, Bible study spirituality and discipleship groups have been able to meet physically again.

Confirmations have increased across the Mission Area with some people being confirmed at the Cathedral and some locally within the Mission Area. During the year the St James Well-Being Project has been moved forward gaining support and finances with the expectation that building work will start in 2023.

The reordering of St Paul's church in Gorsedd has been completed and reordering of St Pauls' church in Rhosesmor planned and agreed. Planning work for the reordering of St Mary and St David's church in Flint town centre has also been agreed and work will start in 2024.

In October a facilitated day for the Mission Area at St Beuno's to look at gifts and ministries in our communities took place and various ideas are being implemented as a consequence.

Personal summary

As I have listened, seen and participated in the Mission Area life during 2022 I have been overwhelmingly impressed with the commitment and effort put into the various events and supports we have put together both on a small and a large scale. I have to say that almost none of the exciting things would have been possible without the commitment of many people and our ability to work together.

Two things have been in the forefront of my mind as we have made decisions particularly about mission. Firstly, that each individual we meet is a child of God and should be dignified by that relationship and secondly that in terms of our decision making it should reflect the generosity of our God. I believe that during 2022 we have gone further than before to illustrate these two through the life of our Mission Area and I thank everybody who has participated in this by being there, joining in, sharing gifts and ministries and generally shining the light and life of Jesus in our small corner of North Wales.

FINANCIAL REVIEW

The receipts and payments for the year, and the assets and liabilities at the year-end are shown in the statements of account which accompany this report.

RESERVES POLICY

The MAC aims to retain a balance of unrestricted "free" reserves to provide working capital, and to meet any future shortfalls in receipts or unexpected payments, at least equal to 12 months payments. The unrestricted reserves amount detailed above is in line with this policy.

NOTES TO THE FINANCIAL STATEMENTS
FOR THE YEAR ENDED 31 DECEMBER 2022

1 Accounting policies

1.1 Accounting convention

The financial statements have been prepared in accordance with the charity's constitution, the Charities Act 2011 and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)" (as amended for accounting periods commencing from 1 January 2016). The charity is a Public Benefit Entity as defined by FRS 102.

The charity has taken advantage of the provisions in the SORP for charities applying FRS 102 Update Bulletin 1 not to prepare a Statement of Cash Flows.

The charity's presentational currency is pounds sterling and all amounts stated within the financial statements are rounded to the nearest pound.

1.2 Going concern

At the time of approving the financial statements, the members have a reasonable expectation that the charity has adequate resources to continue in operational existence for the foreseeable future. Thus the members continue to adopt the going concern basis of accounting in preparing the financial statements.

1.3 Charitable funds

Unrestricted funds are available for use at the discretion of the members in furtherance of their charitable objectives unless the funds have been designated for other purposes.

Designated funds comprise funds which have been set aside at the discretion of the members for specific purposes.

Restricted funds are subject to specific conditions by donors as to how they may be used.

1.4 Incoming resources

Income is recognised when the charity is legally entitled to it after any performance conditions have been met, the amounts can be measured reliably, and it is probable that income will be received.

Cash donations are recognised on receipt. Other donations are recognised once the charity has been notified of the donation, unless performance conditions require deferral of the amount. Income tax recoverable in relation to donations received under Gift Aid or deeds of covenant is recognised at the time of the donation.

Legacies are recognised on receipt or otherwise if the charity has been notified of an impending distribution, the amount is known, and receipt is expected. If the amount is not known, the legacy is treated as a contingent asset.

Grant income is recognised on receipt unless income is received in advance at the year-end and the performance criteria relate to a future accounting period.

1.5 Fixed asset investments

Fixed asset investments are initially measured at transaction price excluding transaction costs and are subsequently measured at fair value at each reporting date. Changes in fair value are recognised in net income/(expenditure) for the year. Transaction costs are expensed as incurred.

1.6 Cash and cash equivalents

Cash and cash equivalents include cash in hand, deposits held at call with banks, other short-term liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within borrowings in current liabilities.

1.7 Financial instruments

The charity has elected to apply the provisions of Section 11 'Basic Financial Instruments' and Section 12 'Other Financial Instruments Issues' of FRS 102 to all of its financial instruments.

Financial instruments are recognised in the charity's balance sheet when the charity becomes party to the contractual provisions of the instrument.

Financial assets and liabilities are offset, with the net amounts presented in the financial statements, when there is a legally enforceable right to set off the recognised amounts and there is an intention to settle on a net basis or to realise the asset and settle the liability simultaneously.

NOTES TO THE FINANCIAL STATEMENTS
FOR THE YEAR ENDED 31 DECEMBER 2022

Basic financial assets

Basic financial assets, which include debtors and cash and bank balances, are initially measured at transaction price including transaction costs and are subsequently carried at amortised cost using the effective interest method unless the arrangement constitutes a financing transaction, where the transaction is measured at the present value of the future receipts discounted at a market rate of interest. Financial assets classified as receivable within one year are not amortised.

Basic financial liabilities

Basic financial liabilities, including creditors and bank loans are initially recognised at transaction price unless the arrangement constitutes a financing transaction, where the debt instrument is measured at the present value of the future payments discounted at a market rate of interest. Financial liabilities classified as payable within one year are not amortised.

Trade creditors are obligations to pay for goods or services that have been acquired in the ordinary course of operations from suppliers. Amounts payable are classified as current liabilities if payment is due within one year or less. If not, they are presented as non-current liabilities. Trade creditors are recognised initially at transaction price and subsequently measured at amortised cost using the effective interest method.

1.8 Depreciation

Depreciation is recognised so as to write off the cost of assets less their residual values over their useful lives, based on 15% reducing balance.

2 Critical accounting estimates and judgements

In the application of the charity's accounting policies, the members are required to make judgements, estimates and assumptions about the carrying amount of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised where the revision affects only that period, or in the period of the revision and future periods where the revision affects both current and future periods.
