The project is providing education about the dangers of narcotics abuse in five local schools and addicts willing to change are being mentored and supported by the team. The team also run a garbage collection business that offers paid employment to youth on the programme, to provide them with some income and savings.

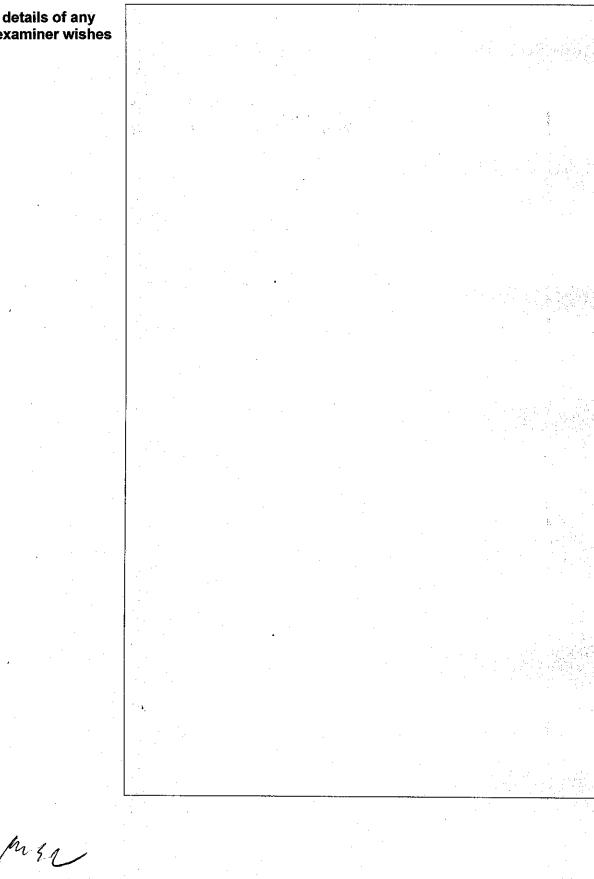
