The directors present their report together with the financial statements for the year ended 31 March 2023. CONSTITUTION

The activities of Wheathampstead Playgroup, a registered charity, is carried out through a company limited by guarantee. The company is governed by a memorandum and articles of association. Directors/Trustees are nominated by members and are elected for a period of up to 3 years at the Annual General

Meeting of the charity. The board of directors/trustees are also able to co-opt new directors/trustees at other times. The policies and activities of the charity are established and controlled by the board of directors/trustees. The board meets approximately 6 times each year.

OBJECTS OF THE CHARITY

The objects of the charity are to enhance the development and education of children primarily under statutory school age by encouraging parents to understand and provide for the needs of their children through community groups and by:-

- Offering appropriate play, education and care facilities and training courses, together with the right of parents to take responsibility for and to become involved in the activities of such groups, ensuring that such groups offer opportunities for all children whatever their race, culture, religion, means or ability;
- Encouraging the study of the needs of such children and their families and promoting public interest in and recognition of such needs;

Instigating and adhering to and furthering the aims and objects of the Early Years Alliance. **REVIEW OF THE PERIOD AND FUTURE ACTIVITIES**

The limited liability company is the operating entity for Wheathampstead Playgroup (registered number 283087) since 1 April 2007. As previously mentioned, 2021/2022 was a very difficult year. This continued into 2022/2023 and the decision has been made to close down Wheathampstead Playgroup Ltd. Early Bird Pre School CIC will be taking over the pre school setting. All staff who decided to stay at the setting were transferred to Early Bird Pre School via TUPE on 02/12/22. Wheathampstead Playgroups Ltd registration with Ofsted has been cancelled and we are in the process of winding up the company.
