The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31 March 2023. The trustees have adopted the provisions of the Statement of Recommended Practice (SORP FRS

102) 'Accounting and Reporting by Charities' (effective January 2015)

STRUCTURE, GOVERNANCE AND MANAGEMENT

The Charitable Trust is a company without share capital and limited by guarantee.

Each member undertakes to contribute such an amount as may be required, not exceeding £1, to the Charitable Trust's assets if it should be wound up.

The trust council comprises a minimum of 5 and a maximum number of 10 trustees, all of whom are recruited from members of the school staff and the governing body. School Governors make up 50% of the number.

OBJECTIVES AND ACTIVITIES

The trust supports St Augustine's Catholic College in the delivery of catholic education by providing financial assistance for the purchase and maintenance of school assets.

Regular voluntary donations are collected from the families of students who attend or have attended the College. These come in response to appeals for contributions to the building and amenities fund, and the purchase of stakes in a monthly 'club' draw.

Funds are transferred to the college or the college's fund raising association, upon request which details intended expenditure.

FINANCIAL REVIEW

Outgoings this year of £78,728 were less than the incomings of £132,791 by £54,063 (2022 shortfall £7,055)

The gifts to St Augustine's Catholic College in 2023 were £76,265 (2022 £6,339)

Reserves policy

The trust has retained unrestricted funds for future expenditure as and when required by the College.

Risk management

The trustees have examined the major risks which the charity faces and confirm that systems have been established to lessen those risks.

The trust council intends to continue with the activities for which the trust was formed

1. ACCOUNTING POLICIES

Basis of preparation

The financial statements have been prepared under the historical cost convention and in accordance with the Companies Act 2006 and the requirements of the Statement of Recommended Practice (SORP RFS 102) 'Accounting and Reporting by Charities' (effective January 2015)

Incoming Resources

All incoming resources are included on the Statement of Financial Activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy.

Resources expended

Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category.

Taxation

The charity is exempt from corporation tax on its charitable activities

Fund Accounting.

Unrestricted funds, are donations and other income receivable or generated for the objectives of the charity without further specified purpose and can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objectives of the charity and arise when specified by the donor or when funds are raised for particular restricted purposes.
