The Hans Albrecht Foundation (HAF) trustees present their third annual report and financial statements covering the period 02/01/2021 – 01/01/2022. The CIO was first registered on 23/10/2017.

Charitable Objects

Objects to promote human rights (as set out in the universal declaration of human rights and subsequent united nations conventions and declarations) throughout the united kingdom by: educating the public about human rights and raising awareness of human rights issues by means of lectures delivered by eminent practitioners and establishing an award to honour an individual or organisation that has made an outstanding contribution to human rights.

Deliverables

The recipient of the Hans Albrecht Foundation Human Rights Award for 2022 was the Kent Refugee Action Network. The event was held on line on the 15th February 2023.

KRAN work with separated young refugees and asylum seekers, also known as UASC (Unaccompanied Asylum Seeking Children). These are young people aged 16 to 24 who have arrived in Kent alone and are claiming asylum. We provide them with a safe, positive space and support them to succeed.

Hans Albrecht Foundation Annual Lecture was delivered by Daniel Trilling. Trilling is an award-winning journalist and author. His lecture drew from his published material about the human experience of the 'refugee crisis' by following their journeys, by considering what keeps them going, as they reach Europe's frontiers, and after.
