MONEY FROM FUNDRAISING

### **GIFT AID**

Gift aid income fell mainly as a result of lower than budgeted fundraising.

### **OUTGOINGS**

Lower than budgeted rent was the result of late invoicing from Effra Space meaning that November and December rent was paid in January 2023.

Payroll costs were 77% of those budgeted because of a later than planned take on of the Publicity Coordinator role and because budgeted pay for sickness cover was not required.

As well as our 5% contribution to the European Chairs Assembly, our contribution to Danaprasada (the men's residential community) was increased to £3.500 to better recognise the value of the community to the Brixton sangha and the material value it brings as a meeting place.

## **MONEY FROM EVENTS**

Classes - 62% above budget. The usage of the main hall and studio has allowed us to offer beginner and regular meditator focus. More people are able to attend and all can enjoy the shared reception area for a vibrant tea

Retreat - Retreat income was close to budget and a small surplus was due to late payment (2023) of the Rivendell retreat balance.

Courses - A 30% increase in course attendees in 2022 over 2021 (232 v 179) but course income has not increased in line with that and overall income was 76% of budget.


