STRUCTURE GOVERNANCE AND MANAGEMENT

Governing Document

The 1st Kesgrave Scout Group is part of the Scout Association and belongs to the Deben Scout District. The Group's governing documents are those of the Scout Association. They consist of a Royal Charter, which in turn gives authority to the Bye Laws of the Association and The Policy, Organisation and Rules of The Scout Association.

Constitution

The Group is a trust established under its rules, which are common to all Scouts.

Trustee selection

The Trustees are appointed in accordance with the Policy, Organisation and Rules of the Scout Association.

Governance

The Group is managed by the Group Executive Committee, the members of which are the 'Charity Trustees' of the Scout Group, which is an educational charity. As charity trustees they are responsible for complying with legislation applicable to charities. This includes the registration, keeping proper accounts and making returns to the Charity Commission as appropriate.

The Committee consists of 3 independent representatives, Chair, Treasurer and Secretary together with the Group Scout Leader, individual section leaders and parent representation and meets three times a year.

Members of the Executive Committee complete 'Essential Information for Executive Committee' training within the first few months of joining the committee.

This Group Executive Committee exists to support the Group Scout Leader in meeting the responsibilities of the appointments and is responsible for:

The maintenance of Group property.

The raising of funds and the administration of Group finance.

The insurance of persons, property and equipment.

Group public occasions.

Assisting in the recruitment of leaders and other adult support.

Appointing any sub committees that may be required.

Appointing Group Administrators and Advisors other than those who are elected.

Risk and Internal Control

The Group Executive Committee has identified the major risks to which they believe the Group is exposed, these have been reviewed and systems have been established to mitigate against them. The main areas of concern that have been identified are:

Damage to the building, property, and equipment. The Group would request the use of buildings, property, and equipment from neighbouring organisations such as the church, community centre and other Scout Groups. The Group has sufficient buildings and contents insurance in place to mitigate against permanent loss.

Injury to leaders, helpers, supporters, and members. The Group through the capitation fees contributes to the Scout Associations national accident insurance policy.

Reduced income from fund raising. The Group is reliant upon income from subscriptions and fundraising. The Group does hold a reserve, which should ensure the continuity of activities, should there be a major reduction in income. The Committee could raise the value of subscriptions to increase the income to the group on an ongoing basis, either temporarily or permanently.

Reduction or loss of leaders. The group is totally reliant upon volunteers to run and administer the activities of the group. If there were a reduction in the number of leaders to an unacceptable level in a particular section or the group then there would have to be a contraction, consolidation or closure of a section. In the worst-case scenario, the complete closure of the Group.

Reduction or loss of members. The Group provides activities for all young people aged 6 to 14. If there were a reduction in membership in a particular section or the group as whole then there would have to be a contraction, consolidation or closure of a section. In the worst-case scenario, the complete closure of the Group.

The group has in place systems of internal controls that are designed to provide reasonable assurance against material mismanagement or loss; these include 2 signatories for all payments and comprehensive insurance policies to ensure that insurable risks are covered.

OBJECTIVES AND ACTIVITIES

The Purpose of Scouting

Scouting exists to actively engage and support young people in their personal development, empowering them to make a positive contribution to society.

The Values of Scouting

As Scouts we are guided by these values:

Integrity - We act with integrity; we are honest, trustworthy and loyal.

Respect - We have self-respect and respect for others.

Care - We support others and take care of the world in which we live.

Belief - We explore our faiths, beliefs and attitudes.

Co-operation - We make a positive difference; we co-operate with others and make friends.

The Scout Method

Scouting takes place when young people, in partnership with adults, work together based on the values of Scouting and:

- enjoy what they are doing and have fun
- take part in activities indoors and outdoors
- learn by doing
- share in spiritual reflection
- take responsibility and make choices
- undertake new and challenging activities
- make and live by their Promise.

Volunteers

All the section leaders and helpers are volunteers and volunteers carry out all the fundraising. The only paid employee of the charity is the cleaner who helps to look after the day-to-day running of the premises.

Public Benefit

The Group meets the Charity Commission's public benefit criteria under both the advancement of education and the advancement of citizenship or community development headings.

ACHIEVEMENTS AND PERFORMANCE

The Group was formed in April 1927 and comprises two Beaver Colonies, three Cub Packs and two Scout Troops. Membership has reduced this year due to the reduction in the number of sections and the reduction in the membership of each section.

Cub Section Report

The three Cub Packs have had a successful year, with a focus on core Scouting skills, having fun and developing team work and leadership, especially given the low numbers of older Cubs to teach the younger ones.

We've also welcomed in a new leader within Constable while preparing to say farewell to Tracey and Merv Scase who step down at the end of the Summer Term. New leaders will be needed for September.

Numbers within the section have been slowly building but not yet at capacity across the three packs, with mostly younger cubs. We have however had a varied and enjoyable programme across all three packs, working through the challenge badges (with two from Bader pack achieving the Silver award this year).

Highlights of the year include a trip to the Martlesham Police HQ, an escape room evening, bowling and a visiting Fire Engine, as well as an evening run by our Explorers going to the World Scout Jamboree, which was well received and supported.

We also held a sleepover with around 50 cubs from across the three packs in the scout hall, many of whom had never spent a night away from home before. More recently, 32 Cubs from across the three packs also attended District Camp, most of whom were camping for the first time with Scouts. All in all a successful year (with still more planned for this term to look forward to) in which it feels like we have made up for a lot of lost time.

Scout Section Report

Activities have now returned to pre Covid levels and 2022 season included a cycle camp from Layer-de-la-Haye, via Mersey Island to Boxford and then home, this was followed by the National Archery Competition, Wet weekend, Family Camp and Summer Camp, which was held at Marshside Campsite, nr Ramsgate Kent. This was the camp postponed from 2020 so it was great to finally get to do the walk to Ramsgate, cycling at Betteshanger and visits to the Hornby Museum, Margate and Chatham Docks that had all been planned back in 2019. We held the usual September Challenge camp attended by 21 scouts, where again we built on traditional and teamwork skills, and took a small Group to the Peak District to experience some hill walking.

Weekly meetings have included cooking evenings on a number of themes and included practising and taking part in the District Cooking competition which was held in February. We played games on Foxhall Heath, cycled to Woodbridge and had chips, built rafts at Waldringfield, visited BT and did some computer programming and had an evening of fun at Lasertag. During the Spring term we undertook some expedition training which culminated in a day's hike using ration packs and had a very interesting astrology evening.

Several scouts took part in additional archery training and then went to the 2023 National Archery competition where Joshua Beards won the U14 Clout with Ava Bainbridge and Gwyneth Albins coming 2nd and 3rd. Over the May Bank holiday 2023, 31 scouts attended the District Camp at Henham Park. Daniel Jones also took part in the local Ipswich Gang Show.

We awarded the Gold Award to Danny Leggett and 240 activity and challenge badges were presented during the year.

The Troops have now been divided in to 3 sections, with one troop meeting on Tuesday and two meeting in the adjoining halls on Thursday evening. New members have also been joining the troops and we currently have around 60 scouts across the three sections.

We are looking forward to another summer full of camping opportunities and the chance to encourage our young people to undertake new activities and learn new skills.

The Scout Hall

The Hall has is now in its 20th year and continues to be widely used by both our own sections and other community Groups and for private parties.

During the year we carried out the usual annual maintenance and we fitted the batteries to store the surplus electricity generated by the solar panels. This has proved to be a very worthwhile investment and has helped to reduce our electricity costs especially as the electricity contract was renewed at 31st August and the prices increased significantly.

FINANCIAL REVIEW

The finances this year are now back to pre-Covid levels with all the usual activities back up and running and all sections meeting fully. Membership fees were charged in full for the year, but sections numbers are still slightly reduced from the peak in 2019. Fundraising activities are also "back to normal" with the increase in come being attributable to the return to a full year of jumble sales and a bumper Christmas Fayre where Father Christmas handed out 300 presents.

Expenses have been as expected with the hall running costs of £24,175 representing the base cost of running the hall on an average year with standard annual maintenance. The costs for fundraising and charitable activities have risen in line with the corresponding increases in income for these categories. For fundraising this includes the cost of providing the presents for Father Christmas. Charitable activities includes the cost of not only running all the camps but also the cost of weekly meetings and the provision of badges etc. For some events such as Family Camp the Group subsidises the event to provide activities and for other camps small subsidies have been given to help ensure that the activities are open to all and that the inflationary increases are partially absorbed by the group

During the year the Group also discussed the need for additional financial support for members who during the current cost of living crisis are unable to afford membership fees or camp charges. To date there have been no formal requests for support and the Group will continue to monitor need on an individual basis, whilst being mindful of keeping fees as low as possible.

Also during the year the Group continued to support the four members of the Group who were selected to attend the World Scout Jamboree to be held in Korea in July 2023. They held bingo evenings, car washes, quiz nights and helping at the Town Fun Day then they reached their target of £4,000 each and are now looking forward to their trip.

At the end of the year the Group made a surplus of £5,288 for the year and after a loss on the revaluation of the investment for the year £1,277 was added to Group Funds.

Reserves and Investments

It is the intention of the trustees to continue to keep a reserve for upkeep and repair of the hall, and at least one year's expenses for the running of the Group. During the year some investments will reached maturity and they will be reinvested in similar cash investments with the best available interest rates.

NOTES TO THE ACCOUNTS

FOR THE YEAR ENDED 31 MARCH 2023

1. Basis of preparation

Basis of accounting

The charity constitutes a public benefit entity as defined by FRS 102. The accounts have been prepared in accordance with Accounting and Reporting by Charities; Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) issued in October 2019, the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS102), the Charities Act 2011 and UK Generally Accepted Accounting Practice.

The financial statements have been prepared to give a 'true and fair view' and have departed from the Charities (Accounts and Reports) Regulations 2008 only to the extent required to provide a 'true and fair' view. The departure has involved following the Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their annual accounts in accordance with the Financial Reporting Standard and applicable in the UK and Republic of Ireland (FRS102) issued in October 2019 rather than the Accounting and Reporting by Charities: Statement of Recommended Practice effective from 1 April 2005 which has been withdrawn.

The financial statements are prepared on a going concern basis under the historical cost convention. The financial statements are presented in sterling which is the functional currency of the charity and rounded to the nearest pound.

Change in Basis

There has been no change to the accounting policies or estimates (valuation rules and methods of accounting) since last year.

2. Accounting policies

Recognition of incoming Resources

These are included in the Statement of Financial Activities (SoFA) when

the charity becomes entitled to the resources;

- the trustees are virtually certain they will receive the resources; and

- the monetary value can be measured with sufficient reliability.

Membership subscriptions

Memberships subscription collected on behalf of other parts of the Scout Movement are reported in the SoFA net of any amount paid out. This is because these subscriptions are in effect held as agents before being paid out.

Offsetting

There has been no offsetting of assets and liabilities, or income and expenses, unless required or permitted by the FRS 102 SORP or FRS 102.

Grants and donations

Grants and donations are only included in the SoFA when the charity has unconditional entitlement to the resources

Tax reclaims on donations

and gifts

Incoming resources from tax reclaims are included in the SoFA when they are received

Gifts in kind

Gifts in kind for sale or distribution are included in the accounts as gifts only when sold or distributed by the charity. Gifts in kind for use by the charity are not valued or included in the accounts

Donated services and Facilities The value placed on these resources is not included in the accounts

Volunteer help

The value of any voluntary help received is not included in the accounts

Investment income

This is included in the accounts when received.

Investment gains and losses

This includes any gain or loss on the sale of investments and any gain or loss resulting from revaluing investments to market value at the end of the year.

Liability recognition

Liabilities are recognised as soon as there is a legal or constructive obligation committing the charity to pay out resources.

Governance and Support costs

Governance costs comprise all costs involving public accountability of the charity and its compliance with regulation and good practice. These costs have been included in the charitable activity costs.

Stocks and work in progress

These are valued at the lower of cost or market value

Current asset investments

The charity has investments of cash and cash equivalents with a maturity date of less than one year held for investment purposes rather than to meet short term cash commitments as they fall due.

In 1997 the Group acquired a lease for 125 years of a piece of land on which it has built a Scout Hall which opened in 2004. The premium of the lease included the cost of providing the services to the site and the communal infrastructure of square, car parks and paths that will be shared by the other site users.

The Group also has camping equipment and furniture from the old hall that has historically been written off as acquired. The assets have little or no open market value so the trustees have agreed that they should be assumed to be fully depreciated for accounts purposes. Equipment for the new hall and new camping and activity equipment costing more than £100 is capitalised at cost.
