

Para 1.20	 In recognising the importance of 'on the ground' expertise when working in this field, The Helen Bailey Trust continues to work in partnership with Seven Stories (The Nationa Centre for Children's Books) a registered charity whose mission is to collect, champior and celebrate children's literature. The principles and primary objectives of this ongoing and successful partnership are to deliver innovative learning programmes that inspire and enable young people and their teachers in the North East of England to take diverse approaches to creative writing by sparking empathy with the creative process, develop increased confidence, imagination and stamina in creative writing and to enable them to begin to see themselves as writers. Following discussions between Seven Stories and the Trustees of The Helen Baile Trust, it was agreed to continue to support Welbeck Academy (located in Walker in the East End of Newcastle upon Tyne) together with and additional school (St. Lawrence RC Primary School in Byker) with programmes which were then developed and delivered by Seven Stories. Priority approaches for these programmes included: Delivering an innovative learning programme that inspired young people in the North East of England and their teachers with a diverse approach to creative writing; Sparking young people's empathy with the creative process and enable them to see themselves as writers; and Using the unique Seven Stories collection, expert practitioners and contacts within the creative process and enable them to see themselves as writers; and

Positive feedback was received from teachers to the programmes, examples being "I have more children interested in reading books from Seven Stories and several children come in to read during lunch times", "Children are more confident and creative", "Children are definitely more excited about writing" and "Interest and exposure to a wider range of books, more reading for pleasure, more interest in writing and becoming authors when older". The Trustees have been delighted with the positive achievements these ongoing programmes have achieved and look forward to exploring a continued and valued partnership between Seven Stories and The Helen Bailey Trust.
