Para 1.20	Due to the government's implementation of the BNO policy, starting from January 2022, the church saw a sharp increase in the number of attendees for worship services, reaching between 120 and 150 people. With an increase number of individuals holding BNO status from Hong Kong, the church made changes effective from 3th July, 2022, shifting from the original bilingual worship service (Cantonese and Mandarin) to two separate language services. By the end of 2022, the attendance for both services had increased to around 170-180 people. The church also reinstated a Mandarin Chinese school and initiated a senior fellowship and Bible study class for Cantonese speaking individuals from Hong Kong. Additionally, we organised online seminars to help them adapt to life in the UK, covering topics such as purchasing a car and applying to schools.
