As a Charity, we provide buildings and facilities to ensure a continued meeting place for the community.

Our users currently include Scouts, Cubs and Beavers, Squirrels, Karate, Exercise classes, Companionship clubs, art and craft, quilting, dog training, gardening, music, church events including wakes and christening parties, plus many events by other local fundraisers and charities.

The Parish Hall which forms our 'not for profit' charity, continues to be very well supported and the aim of the Trustees is to ensure its long-term future and accessibility to the community. As our hall is now approaching 100 years old and fast becoming unfit for purpose, we are continuing to work towards our long term aim to demolish and rebuild. Grants have, and continue to be, sought, planning permission has been granted and the project is moving forward towards what will be a very exciting time for the charity and the community which supports it.

From the results of interaction with members of the community, we believe that a new and modern building will greatly improve the lifestyle and well wellbeing of the said residents. It will also open the door for new opportunities for our charity which has been in existence since 1964, and for the community for whom it has acted as a central hub since 1924.

The Charity is working towards a change of status to a Charitable Incorporated Organisation (CIO) from our current Unincorporated status. This change will result in changes to our Governing Document.
