#### Trustees' Responsibilities

The trustees are responsible for:

- Preparing accounts that give a true and fair view of the charity's receipts and payments during the year and of its state of affairs at the end of the year.

- Preparing the Annual Trustees' Report in accordance with Part 8 of the Charities Act 2011 and the Charities Statement of Recommended Practice (SORP) 2005.

#### Structure, Governance and Management

The organisation was set up in 1995 as a non-profit organisation and was governed by it's own rules and regulations as amended by AGM from time to time. The members voted to achieve charitable status in March 2008. The charity is governed by its Constitution adopted on 17 October 2009 and amendments were approved at the AGM on 14 March 2010. Charity status was achieved on 29 March 2010. The charity was established as an Association and as such elects the trustees and such other Honorary Officers, collectively known as the Committee, at the Annual General Meeting. Casual vacancies are filled as necessary by the Committee and formal appointment is made at the following AGM.

#### Objects of the Charity

To support and relieve the needs of families who have or are intending to adopt a child from China.

To advance the education of the public in short and long term issues related to adoption from China.

To advance the education of children adopted from China and their families (in particular in the Chinese culture), and to provide facilities in the interests of social welfare and for recreation and leisure time occupation with the object of improving their conditions of life.

#### Main Achievements

The Chair is pleased to report another good year of progress for CACH in respect of financial soundness of the Charity, the scope of activities available to members and the development of initiatives that shape the organisation for the future.

We have increased the number of CACH Back Awards given out which totalled 5 this year and at the same time we have increased the CACH Back reserves which gives us some reasonable security about being able to provide ongoing support to this initiative. Accordingly the Terms and Conditions of the Award scheme have been re-scoped to broaden the range of programmes being supported.

We are also pleased to welcome additional members to the Teen/Young Adult resource (now numbering 5) on to the CACH Officers Committee. This extra engagement will help us to develop more programmes, activities and social networking for the emerging Teen and Young Adult population and for the younger children the Mentor and Mentoring scheme will updated to capture new interested parties. The Teens/Young Adults will also contribute to debate about the strategic direction and medium term positioning of CACH.

All of this has come about through the widespread dedication of the CACH membership who have contributed in their own way and time availability, be it as an Officer, as Regional Coordinators, a supporter and volunteer to run events and initiatives and as a source of experience and knowledge into which CACH can tap.

Once again though there are a few areas of caution. A review of CACH has highlighted a number of risk areas of which the highest were;

- · Failure to adapt the organisation to deliver the programmes and activities' to retain membership
- · Insufficient numbers attending the Reunion and Picnic causing income loss and extra charges
- · Failure to recruit and embed new Officers onto the CACH Committee

All the members have the ability to help reduce these risks. In particular of the 12 CACH Officer positions 9 of these are due for retirement at the AGM 2016 which takes place on the 13th March at the Reunion. At present, the majority of those in post have offered to stay in post if no replacements step forward. This, however, is not the case for the Reunion Organiser. This will be highlighted at the 2016 Reunion and AGM in the hope that a replacement for this post will step forward otherwise the event will not take place in 2017.

In planning our activities for the year, we kept in mind the Charity Commission's guidance on public benefit at our trustees' meetings and will continue to do this in future meetings. Looking forward to 2016/17 we will continue to provide ways for our member families to interact on a variety of levels through the Reunion, Picnic and Regional activities. We will continue to look at the longer term issues of the security of CACH as an organisation and its ability to continue to meet its aims and objectives towards its current and future families. We will continue to look for ways to benefit the children of CACH and we will continue to support other charities doing work with children in China and those supporting new adoptions.

#### **Finances**

We saw a small reduction (2.4%) in the membership subscriptions due to the continuing trend of families leaving the organisation as their families grow up and their needs change. The budget for the reunion was increased for this year by £3K to enable the organisation to celebrate its 20th anniversary.

The charity also made the decision to purchase £4K of merchandise in the form of t-shirts, mugs, keyrings, notebooks, bookmarks etc all with the Cach branded logo. These were purchased to sell mainly at the reunion and picnic and the funds from these sales are shown in the accounts. It was decided to provide for the full cost of the merchandise in this year's accounts, whilst stock would be stored by the committee members for future events. Taking these planned additional costs into account a deficit on the general fund was seen for the year of £1,674 (2014: surplus £3,605).

The CACH Back fund made 5 grants, of £500 each, this year so that we continue to financially assist the teens to further their cultural understanding and deepen their sense of heritage. At the end of the year this fund stood at £24,481 (2014: £24,276).

An additional fund has been opened up called the 'Cross Region' which is for providing funds for additional cross regional events so that children of a similar age can get together even if they don't live in the same Cach designated region. One very successful event ran in the year and more are hoped to follow. A transfer of £500 was made out of the core funds into this Cross Region fund being a proportion of the regional payments not claimed by a handful of regions. At the end of the year this fund stood at £765.



# INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF CHILDREN ADOPTED FROM CHINA

I report on the accounts of the Charity for the year ended 31st December 2015 which are set out on pages 1 to 7.

#### Respective responsibilities of trustees and examiner

The Charity's trustees are responsible for the preparation of the accounts. The Charity's trustees consider that an audit is not required for this year under section 144(2) of the Charities Act 2011 (the 2011 Act) and that an independent examination is needed.

It is my responsibility to:
