Our sole aim is to enable our 250 member groups to better serve children, young people and families in the Borough.

TRUSTEES' ANNUAL REPORT FOR THE YEAR ENDED 31 MARCH 2016

Our now, 250 member organisations are closely connected through the Forum's bi-weekly newsletter and of course always invited to our 4 open meetings during the year.

A new development is the increase of requests to receive our newsletter from professionals working locally. They too acknowledge the unique nature of our charity and the fact the Forum holds a 'finger on the pulse' of the rich range of charitable activities in our Borough.

None of this important work could take place without the generous commitment and high professional standards employed by Judy Kimmins, the Forum Development Officer and our invaluable Trustees. It is a pleasure to work with such talented, committed people. I can honestly say that being a part of the Forum is an exciting experience and even more exciting is observing our member charities grow as they contribute so creatively to our Bromley community.

Activities

The Forum's activities for the year followed the objectives set in our operational Plan and included:

1 Information

Outcome: Member groups have been informed of relevant local and national issues, plans and developments, so that they can better serve and appropriately inform the children, young people, and their parents and carers that they represent.

We have provided electronic fortnightly updates to member groups and partner organisations with information central to their work. We have, over the past few months, included a section in the updates where members can highlight any resources that they are able to offer to other members and also items that they need. We have welcomed 3 new members during this year.

2 Networking

Outcome: Sharing information and good practice has been of benefit for those served by member groups.

Four open events were held during the year for networking and information purposes. We held these at member's premises for ease of access and to keep expenditure to a minimum. At each of these meetings we include some time for members to share good news, best practice or to share how they have overcome a difficulty. We also give our members an opportunity to tell others about their work and provide fundraising tips. In addition to the regular items we covered the following:

• Bromley LA used this meeting to host the annual Children & Young People's Stakeholder Conference focusing on emotional wellbeing. We were pleased that the Forum was invited to deliver a presentation alongside Cllr Evans and Doug Paterson, Chief Exec Bromley LA. The conference was a reminder of how useful it is to meet people from other organisations. The information gathered from the Conference will help those who organise health and social care services to understand the role that voluntary sector groups play in helping children and young people to develop emotional wellbeing.

3 Consultation and Representation

Outcome: The London Borough of Bromley was enabled to consult organisations working with children, young people and families. The Forum represented children's, young people and family services effectively, (especially with regard to service provision in these challenging economic times).

 gathered from the annual Children and Young People's Stakeholder Conference
 will help those who organise health and social care services to understand the
 role that voluntary sector groups play in helping children and young people to

- It is the Forum's ambition to increase its ability to proactively represent the needs of children, young people and families in Bromley, offering support to its member groups as appropriate.
- We continue to represent the interests of member organisations on the Bromley Children's Safeguarding Board and are working closely with their Business Manager to support voluntary sector groups across Bromley Borough. We have supported the Safeguarding Board during the lay member recruitment exercise and also on their communications group.

4 Encouraging Good Practice - Training (Workforce Development)

Outcome: Improved skills and knowledge for those working for member organisations whether paid staff or volunteers.

We continue to seek ways to support member groups increasing the skills and knowledge to serve children and young people across the Borough. We arranged for an introduction to Makaton session to be delivered at our December open meeting. Following this we will be holding our first Makaton training session in May 2016. The initial course will be delivered to 20 member groups and further sessions will follow. The Forum strives to encourage member groups to share training. We have started to see member groups sharing training including: spaces being offered on a volunteer induction course, two groups sharing personal care training and spaces being offered on a first aid course.

5 Administration, Finance/Fundraising, Reporting and Governance

Outcome: Value for money, effective governance, financial security and efficient administration.

The Forum is a 'no-frills' network providing support and information for the benefit of local children's, youth and families voluntary organisations. We seek to keep our expenditure to a minimum and over the past year have used member accommodation to host both trustee and open forum meetings. This is our second year of independence without any statutory funding and we are grateful for the financial support we have received. We have seen a 50% increase in donations from our members and continue to use a systematic approach for fundraising. We are very grateful for the financial support we have received.

The Forum continues to be served by Judy Kimmins in her role as Development Officer. We are grateful for the continued support received from George Ruston during this financial year, in particular for delivering the fundraising sessions at our open forum meetings.

Structure, Governance and Management

Bromley's Children and Families Voluntary Sector Forum was established in the early 1990's as an independent network of voluntary and community organisations concerned with children, young people and their families. The Forum acts as a primary point of access for a diverse range of organisations in the London Borough of Bromley for information, training, joint planning, consultation and representation purposes. There are approx. 250 groups in membership, many of which are small and do not have the time or expertise to keep up to date with changes in legislation, good practice or funding opportunities. Trustees are appointed at the Annual Meeting on the basis of nominations received from member groups. Consideration is given to specialist skills or knowledge, competence and overall suitability. New Trustees receive information about their responsibilities and the aims of the charity. They are required to undergo a Disclosure and Barring Service check. Trustees meet every two months. The day to day running of the charity is carried out by the Development Officer.

None of the Trustees has any beneficial interest in the charity. All of the Trustees are members of the charity and quarantee to contribute £1 in the event of a winding up.

Risk Management

Risks are identified, assessed and controls established throughout the year. The key controls used include:

- comprehensive strategic planning, budgeting and accounting.
- clear authorisation and approval levels.
- vetting procedures as required by law for the protection of children.

Financial Review

Our financial statements show that we were successfully in obtaining financial support from various sources during 2015/16. These included: £3,000 from Truemark Trust £1,600 from Bromley & Orpington Sunday Football League, £3,000 from DCR Allen Charitable Trust, £600 from Cutler Trust, £2,000 from Mrs Smith & Mount Trust, £3,500 from the Foyle Foundation, £2,500 from Bromley Community Fund and £1,000 from Albert Hunt Trust. Support has also come from our members in terms of voluntary contributions that range from £10-£120.

The statement of financial affairs shows the total income for 2015/16 was £18,237.00 The total resources expended amounted to £15,995.15. The surplus of £2,241.85 has been carried forward to 2016/17 year.

Reserves Policy

It is the policy of the charity that unrestricted funds which have not been designated for a specific use should be maintained at a level equivalent to between three and six months expenditure. The Trustees consider that reserves at this level will ensure that, in the event of a significant drop in funding, they will be able to continue the charity's current activities while consideration is given to ways in which additional funds may be raised. This level of reserves has been maintained throughout much of the year although there was a period when the Forum's resources nearly dropped below three months expenditure and the Trustees had to plan for closure should income not have been received.

Independent Examiners Report

We also report to you if, in our opinion, the Trustees report is not consistent with the financial statements, if the Compant has not kept proper accounting records if we have not received all the information and explanations we require for our audit, or if information specified by law regarding remunerations and transactions is not disclosed.

In our opinion the Trustees' report is consistent with the financial statements and the financial statements give a true and fair view of the state of affairs at 31st March 2016.
