### **OBJECTIVES, POLICIES AND ORGANISATION**

#### **Investment Policy**

Management of investments is delegated by the Committee to Coutts & Co. The fund is managed with an emphasis on income with some regard to capital growth and a moderate approach to risk.

### **Reserves Policy**

The trustees consider it prudent to keep unrestricted reserves at levels which ensure that there are sufficient funds to meet the needs of current and future activities. The activities of the Association are largely regular and predictable in the medium to long term. Reserves can therefore be relied on to act as contingency in the event of income flows being disrupted. Our unrestricted free reserves amounted to £393,507 (2014 - £273,682).

#### **Charity objectives**

The objects of the Association are the advancement of public education in the subjects of soil and rock mechanics and engineering geology and in their application to engineering.

### Summary of policies adopted to further the objects of the Association

a) To hold regular meetings for discussion of subjects lying within the above fields.

b) To arrange for the holding of periodical and regional conferences, symposia and seminars.

c) To co-operate in the activities of International Societies of which the British Geotechnical Association is a member and with such bodies as may be appropriate.

d) Generally promote training courses and seminars in the field of geotechnology.

e) To do all such lawful things as shall further the above objects.

There are no changes in the Association's objects from the previous year.

### **Association Organisation - Committee**

The affairs of the Association are managed by the Committee.

### Membership

Individual membership shall be open to those professionally engaged or otherwise actively interested in work lying within the scope of the Association, upon payment of the appropriate entrance fee and annual subscription.

Corporate membership shall be open to all organisations, or parts of organisations, engaged or otherwise actively interested in any aspect of geotechnical engineering. Corporate members must nominate an individual to act as the contact person for correspondence. This person shall not be considered as an individual member of BGA.

Subscriptions may only be modified with the approval of the Annual General Meeting or a Special General Meeting.

# REVIEW OF DEVELOPMENTS AND ACHIEVEMENTS DURING THE YEAR

#### **CHAIRMAN'S REPORT FOR 2015**

### **1 COMMITTEE STRUCTURE AND ACTIVITIES**

Dr Chris Menkiti remained as Chairman in 2015 until September when Professor Stephan Jefferis took over at the end of the Edinburgh Conference. At the same time, Dr Martin Preene took over as Vice-Chairman.

Neil Smith, Peter Eldred and Fleur Loveridge continue in their honorary positions of Secretary, Treasurer and Publicity Officer to the BGA. These three are key to the smooth running of the BGA and importantly provide continuity as chairmen come and go. For the executive committee, the terms of office for the following elected members came to an end: Dr Stuart Hardy, Mr Peter Rutty and Professor Mike Winter.

Newly elected executive committee members in 2015 were Dr Way Way Sim, Professor Kelvin Higgins and Mr Miguel Pacheco Andrade. We welcome them to the committee and thank them for their commitment to the Association. Associated body representatives are: Mr Ian Duncan (Geological Society), Mr Andrew Stenning (British Tunnelling Society). Mr Ian Nettleton (IMMM), Dr Gareth Swift (ISRM). Dr Gary Fowmes continues as a guest, representing the British Chapter of the International Geosynthetics Society. Mr Jim Cook continues to provide liaison with the AGS. Dr John Powell represents BGA interests on the advisory panel of Ground Engineering, although he is no longer a member of the executive committee or a Trustee.

Dr Felix Schroeder continued to oversee the 2015 Rankine Lecture and the arrangements for the Rankine Dinner. Dr Angeliki Grammatikopoulou took over this role to prepare for the 2016 event. We thank them both for an enormous contribution to our major annual event.

#### **2 MEETINGS**

Programmed joint evening meetings included collaboration with EGGS and IGS. There was also a meeting on the subject of the Warsaw Metro which was of interest to both the BGA and BTS, and which was enjoyed by members of both societies.

The Geotechnique Lecture "A Particulate Perspective on Soil Mechanics" was presented by Dr Catherine O'Sullivan. The Telford Theatre was fully booked for the lecture which was warmly appreciated by the substantial audience.

The 55th Rankine Lecture was delivered in March 2015 by Dr Suzanne Lacasse of the Norwegian Geotechnical Institute on "Hazard, Risk and Reliability in Geotechnical Practice". The lecture was presented to a full house in the lecture theatre at Imperial College and those who could not be fitted in were accommodated in an overflow lecture hall, itself full. It was also webcast live to an international audience. The Rankine Lecture is a major event for the international geotechnical community as well as the BGA and Dr Lacasse presented a magnificent lecture. Such is the significance of the Rankine Lecture that the lecturers are invited to deliver the lecture at many locations across the world and Dr Lacasse has been invited to deliver her lecture 27 times with invitations to make a further 11 presentations.

### **3 PRIZES**

It is a special pleasure to report the award of Skempton Gold medals to two distinguished members of the Association: Martin Stroud and Duncan Nicholson. The Skempton medal is the highest award of the BGA with typically only 4 awards per decade.

The John Mitchell memorial medal was awarded to Colin Edie who presented a lecture on his perspective on the past, present and future of tunnelling - an exciting and challenging presentation.

The Cooling Prize competition was held at Southampton University and was won by William Beuckelaers of Oxford University. As part of his prize, William was sponsored by the BGA to attend the European Young Geotechnical Engineers Conference (EYGEC) which was held in Durham immediately prior to the Edinburgh Conference. A second sponsored delegate to EYGEC was Paul Sargent of AECOM/Newcastle University/Northern Geotechnical Group, who won a paper competition between the regional groups. The MSc Dissertation prize was won by Srikanth Madabhushi of Cambridge University.

There were three finalists for the Fleming Award, an ICE/BGA event sponsored by Cementation Skanska Ltd, to commemorate the life and work of Dr Ken Fleming. After an exciting evening of project presentations the award was won by a team presentation on Chantry Lane Chalk Mines Remediation at Hatfield in Hertfordshire.

The BGA Medal was awarded to Dr Gasparre and Professors Hight, Coop and Jardine for their paper on "The Laboratory Measurement and Interpretation of the Small-Strain Stiffness of Stiff Clays" published in Géotechnique, Volume 64, Issue 12.

### **4 BGA HIGHLIGHTS OF THE YEAR**

There was no Annual Conference in June as the BGA was hosting the 2015 European Conference on Soil Mechanics and Geotechnical Engineering (ECSMGE) in Edinburgh in September. The AGM was held in London as normal in June, and was followed by the presentation of the Skempton Medals and a talk by Professor Hugh St John on Urban Development. Arup kindly hosted a reception after the meeting in honour of the Skempton medallists.

The ECSMGE Conference was a spectacular success. 1024 abstracts were submitted from 65 countries. A total of 383 papers were presented orally with a further 347 presented on electronic posters. A total of 686 papers were published in the proceedings, a 7 volume work totalling 4,784 pages, the largest work the ICE has published in its 200 year history. There were 1155 attendees at the conference. On the social side there were four cultural events, including a whisky tour and a gala dinner at the National Museum of Scotland. There were also nine technical tours. Overall a feat of organisation and delivery. Our sincere thanks to all involved with the conference and especially the core of the conference organising committee, Professor Mike Winter, Derek Smith and Peter Eldred. The committee took a risk in organising a conference on such a grand scale. They delivered it and the results also include a donation to BGA funds amounting to £112,214.

### **4 BGA HIGHLIGHTS OF THE YEAR (Continued)**

The BGA continues to progress and develop as the UK's leading professional association for geotechnical engineers. Membership at the end of 2015 stood at almost 1400. Numbers are significantly up on last year, perhaps to some extent as a result of a discount offered to ISSMGE members attending the ECSMGE. Next year's challenge will be to retain and further grow this membership. Corporate membership has also shown a pleasing growth and we look forward to welcoming further support from contractors and consultants.

In 2013 BGA launched the Early Career Group (ECG), targeting the interests of members broadly within the first 10 to 15 years of their careers. The group aims to facilitate knowledge sharing and networking between members and the wider community and has an active programme of events and activities to complement the BGA's activities. The ECG goes from strength to strength and also leads joint events with the British Tunnelling Society's Younger Members (BTSYM) and other ICE Associated Societies from related disciplines. The BGA will continue to support this initiative as part of its encouragement of younger members. ECG meetings are usually followed by networking opportunities, both with established industry figures and peer-to-peer networking. There are opportunities for companies to host meetings and/or sponsor post-meeting refreshments.

The monthly e-newsletter continues to provide regular updates to members. The BGA also maintains a thriving Twitter feed, Facebook page and Linked In Group. BGA evening meetings continue to enjoy higher member satisfaction ratings in post-event surveys.

#### Importance of the efforts of unpaid volunteers and provision of free facilities and services

The success of the Association continues to depend entirely on the work of very many people, those who have served on its committees and working groups, those who have spoken and taken part in its meetings, and those who have helped in many other ways. The British Geotechnical Association would like to take this opportunity to register its appreciation of the efforts of all those who so willingly helped during the year.

#### Review of the transactions and financial position of the charity

#### **Unrestricted Funds**

Membership subscriptions include subscriptions to the publication Ground Engineering. The Committee considers the reserves to be adequate to meet its on-going activities. Surplus funds are placed on short term deposit.

A surplus of £124,726 income over expenditure for the year has increased the unrestricted fund which amounts to £197,880 at the year end. This compares to a surplus in the unrestricted fund of £10,930 in 2014. The significant increase in the surplus generated in the year predominantly relates to a donation receivable from XVI ECSMGE 2015 Limited amounting to £112,214 (2014 - £Nil).

#### **Designated Funds - Rankine Fund**

The fund balance at the year end amounts to  $\pounds 176,968$  after an increase for investment loss of  $\pounds 5,034$  compared to a gain of  $\pounds 8,492$  in 2014 and an excess of expenditure over income of  $\pounds 971$ , compared to an excess of expenditure over income of  $\pounds 3,423$  in 2014.

Investment income is used to fund the Rankine Lecture.

#### **Designated Funds - The BGA Fund**

The fund balance at the year end amounts to £18,659 after payment of £500 for the BGA MSc Prize, a donation of £1,564 and interest received of £40 compared to £27 received in 2014.

The BGA Fund is for raising the understanding and the appreciation of geotechnics by the public, particularly pupils at schools and colleges (to further the interest in geotechnics as a career) and other technical/scientific professionals (to encourage the employment of experts in geotechnics on projects wherever appropriate). Also for aiding young undergraduates and graduates in geotechnics and allied subjects (normally under 30 years of age) in their training and experience (including funding of teaching, research and travel, eg exchanges with young graduates in other countries).

#### **Degree of Financial Dependency**

As discussed above the Association is dependent on the voluntary efforts of its members.

#### **Risk Assessment**

A risk assessment with respect to the finances of the BGA has been carried out by the Financial and General Purposes sub-committee. A register of risks has been established which is reviewed at least annually. Where appropriate, measures have been identified to mitigate the risks the charity faces.

### **Organisational Context**

The Association's role is the advancement of public education in the subjects of soil and rock mechanics and engineering geology and in their application to engineering, which is not something that can exist in isolation and there are many important links with other engineering disciplines and sciences. Although totally separate from other organisations, the Association seeks to co-operate in areas of common ground with other bodies.

#### 1 Responsibilities of the Committee

The Committee is responsible for maintaining proper accounting records which disclose with reasonable accuracy at any time the financial position of the Association and for taking reasonable steps for the prevention and detection of fraud and other irregularities.

In preparing the financial statements the Committee are required to :

a) select suitable accounting policies and then apply them consistently

b) make judgements and estimates that are reasonable and prudent

c) prepare the financial statements on the going concern basis unless it is inappropriate to presume that the Association will continue to operate.

#### 2 Accounting Policies

The financial statements have been prepared in accordance with the Financial Reporting Standard 102 (effective January 2015) (FRS 102), the Companies Act 2006 and the requirements of the Statement of Recommended Practice (SORP) applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015) (Charities SORP FRS 102).

The British Geotechnical Association meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy note(s).

There are no material uncertainties about the charity's ability to continue, and so the going concern basis of accounting has been adopted.

### Reconciliation with previous Generally Accepted Accounting Practice

In preparing the accounts, the trustees have considered whether in applying the accounting policies required by FRS 102 and the Charities SORP FRS 102 the restatement of comparative items was required. No prior period adjustments were necessary.

#### Income

All subscriptions and investment income is accounted for when received, except in the case of subscriptions which are specifically stated to be in respect of an ensuing accounting period. No credit is taken for subscriptions unpaid at the balance sheet date.

Donation income is accounted for when the Association has entitlement to the income, the income is probable and can be measured reliably.

### Expenditure

Expenditure is recognised when there is a legal or constructive obligation to transfer resources to a third party, settlement is probable and the amount can be measured reliably. Expenditure is included within the Statement of Financial Activities on an accruals basis.

#### **Fund Accounting**

Unrestricted funds can be used in accordance with the charitable objectives of the Society, at the discretion of the Trustees. Restricted funds can only be used for the particular restricted purposes within the objectives of the Society.

The association has the following designated funds:

### Rankine Fund

The Rankine Fund has been consolidated into the British Geotechnical Association accounts.

### **BGA** Fund

The BGA Fund has been consolidated into the British Geotechnical Association accounts.

#### Investments

Investments are shown at market value. Unrealised gains are incorporated within the fund balances to which the investments relate and are identified as unrealised. Cash held as part of the investments portfolio is included in investments.

#### Taxation

The charity is exempt from taxation on its charitable activities.
