116th Annual Report of the Council of the London Topographical Society for 2015

Our 115th Annual General Meeting was held at the Cadogan Hall in Chelsea on Monday, 6th July 2015. It was well attended and after the formalities of the meeting David Le Lay gave a short talk on the development of the area of Chelsea known as Hans Town, so called after Sir Hans Sloane.

As usual, Council meetings were held in January, April and September to discuss the Society's publications programme, membership, finances and general administration.

The Society's annual publication for 2015 (No. 176) was the *London Topographical Record, Vol XXXI,* a five-yearly collection of essays and illustrations contributing to our knowledge of London's past. In addition, a second publication (No. 177) was also provided to members: *Two Early Panoramas of The Regent's Park* with text by Dr Geoffrey Tyack. These were the final LTS publications edited by our long-standing Hon. Editor, Dr Ann Saunders, who retired at the AGM after 40 years' service to the Society. In paying tribute to Ann the Chairman estimated she must have overseen production of more than 50 of the Society's publications.

The Chairman gave notice of the deaths of Elspeth Veale, a Vice-President, and Ralph Hyde, a council member. She announced that Denise Silvester-Carr had decided to stand down from the Council and thanked her for her contributions, particularly as former editor of the Newsletter. Sheila O'Connell took over as Hon. Editor from Ann Saunders who was elected as a new Vice-President.

The Society's total income for 2015 was £34,173 while expenditure came to £50,277. The deficit is the result of a decision by Council to reduce the size of our reserves by making grants to suitable London-interest bodies

The Society made two grants this year - £11,356 to the Guildhall Library for conservation work on the library's Tallis Collection; and £10,000 to the British Film Institute, the first of three annual grants, for digitisation and cataloguing of 15-20 short historical films about London which the BFI will produce, in conjunction with the LTS, as a DVD in 2017.

During the year 33 new members joined the Society: at the end of 2015 there were 1208 paid-up members and four honorary members.

Our Newsletter was published in May (No 80) and November (No 81). Articles included: The Gough Collection in the Bodleian Library: Illustrated London by Bernard Nurse; Using livery company records at Guildhall Library by Dorian Gerhold; A Question of Gauge by David Crawford; Remembering Dr. Salter by Tony Aldous; Changes at Sir John Soane's Museum by Sue Palmer; and Old Lambeth: the Wooley Collection and William Strudwick by Laurence Marsh. As always, there were many excellent book reviews.

During the year work continued in producing the *Newsletter* in electronic, fully-searchable versions for posting on the Society's website. Editions 76 to 81 are now available in this format with the web editions being published six months after the printed version.

The Society amended its website domain name to <u>www.londontopsoc.org</u> and set up an automatic re-direct from the old domain name www.topsoc.org.
