Summary of the objects of the charity set out in its governing document

To advance education and relieve financial hardship amongst migrants, those seeking asylum and those granted refugee status, particularly by the provision of advice and guidance. To advance the education of the public in general about the issues relating to refugees and those seeking asylum.

Summary of the main activities undertaken for the public benefit in relation to these objects Weekly drop-in session ('The Hub') providing information and support sign-posting help, English lessons for adults, Turkish lessons and homework help for children, activities for younger children, shared meal, and regular guest speakers. Weekly youth club ('4 Corners') providing a range of social activities, sports and trips for young people aged 13-18 from the community. Hardship support for families and individuals facing destitution.

The trustees consider that they have complied with their duties to have due regard to the public benefit guidance published by the Charity Commission.

Additional details of objectives and activities

Achievements and performance

Summary of the main achievements of the charity during the year

• We have continued to run our weekly drop-in service for refugees, asylum seekers and migrants, known as The Hub. During the year we ran 32 x 3 hour sessions. The main activities at The Hub have been: o Turkish language classes for children to develop confidence, self-esteem and Turkish and English language skills

o Educational support, including help with homework for children whose parents are unable to assist them, liaison with schools and extra help for children who speak no English when they start school

o English language classes for adults, who because of cultural barriers or immigration status do not attend existing ESOL classes in York but whose English is very limited. We also support learning of adults who are able to attend ESOL classes

o Talks from voluntary & statutory service providers in York to ensure that this community can access health, leisure and social services. Talks this year included the Family Information Service, fire safety, Police, "into University", and Healthwatch

o The Community Police attend on a regular basis, chatting to and building trust with service users, and also giving talks about subjects such as Domestic Violence, and Race Hate

o Signposting to key agencies e.g. Citizens Advice Bureau, Education Department, legal advice, mental health services, housing, Women's Centre

o A safe space where men, women and children from refugee and migrant communities, and volunteers from York, can meet together and share food

o Adult beneficiaries have attended a range of new activities and learned new skills including: computer skills, Zumba, origami, felt crafts, poetry and yoga during the year

o A women's poetry workshop in July saw 10 women working in groups to create 2 poems which they read out at the end of term showcasing event. It was a really moving experience for everyone, audience included

• We offer additional support outside The Hub to families who are particularly vulnerable and isolated. This includes:

- a hardship fund for destitute families and those experiencing severe financial hardship

- liaison with legal services for those seeking asylum

- home visits for families who are particularly isolated

- additional homework support in the home for children whose parents speak little or no English and who are struggling to keep up in school

We held a picnic during Refugee Week, in partnership with York Minster

• During the summer holidays we offered a programme of at least one activity per week for families, including some in partnership with York Minster

• The 4Corners youth club continues to be extremely effective in supporting young people from the communities we support. Activities have included baking, art (an ongoing art identity project), games, football, basketball, badminton, rounders, dance, drama, gymnastics, board games and computer gaming. External trips have been climbing, sledging, bowling, the beach, and 'high ropes'. The young people helped Upstage theatre company write a play by sharing their own experiences. They were very proud when they went to see the finished production after they were invited as a thank you; many of them hadn't been to see a play before

• Some of the young people from 4Corners took part in a football tournament at York University in summer, which was very popular and increased the participants' confidence noticeably. At the showcase event in December the young people demonstrated their football skills and gave a dance/gymnastics performance to guests

• We now run the ASDAN programme on Youth Leadership for the young people, through which we hope that self-confidence will be improved, new skills gained and developed, and opportunities for the future widened

• Numbers reached: We currently have regular contact with 26 families. Of these, 4 families are of African origin, one is Bengali, one is Iranian, and the remainder are Turkish or Kurdish. Over the last 6 months we have also supported families or individuals from Syria, Iraq and Somalia.

Financial review

Reserves policy

The Trustees have established a policy whereby a general reserve of approximately 3 months of fixed costs (salaries and basic running costs for The Hub and 4Corners) is held as prudent planning to ensure RAY's continued operation in the event of a significant drop in funding. This equates to approximately £13,000 in general funds to be held at any time. As at 31/03/2016 the level of reserves was maintained at this level, despite another year of increasing demand for RAY's services. The target was reached and maintained throughout the majority of the year due to focused fundraising efforts from staff, trustees and volunteers, as well as an impressive and inspiring response from the local community in the wake of the well publicised refugee 'crisis' during the last 18 months. These efforts and acts of generosity have allowed the organisation to continue to deliver and grow its core services, as well as return the reserves to a level which increases RAY's sustainability for the future.

The Trustees recognise the importance of reserves and aim to maintain the balance at a level representing 3 months of fixed running costs throughout the next financial year through a combination of planned fundraising and well managed operations to find cost savings and efficiencies where possible. The Trustees will continue to assess the required level of reserves throughout the year based on the risks facing the organisation, as well as the wider environment in which it operates.
