Section D Summary of the main achievements of the charity during the year	 Achievements and performance During the year 2015-16 Animal Rescue and Care rescued, treated and cared for 316 animals. We rehomed 322 animals including 62 cats, 60 kittens, 111 rabbits, 43 guinea pigs, 1 dog, and 45 other animals including mice, chinchillas, gerbils, hamsters, rats, degus, fish and a tortoise. Our volunteers carried out a range of fundraising activities including stalls at community events such as Richmond May Fair, sponsored events, and cake sales. One of our volunteers organised a very successful quiz night. Others set up Just Giving pages for us on social media. We also continued to educate the public about the care and welfare of their pets through social media (Facebook, Twitter and our own website) and at community events including fairs.
