## Love in Action International Report of the Trustees for the year to 31<sup>st</sup> March 2016

Summary of Trust Objectives

To relieve poverty

To advance educational provision

To provide employment opportunities, mainly for young people

To support Love in Action Uganda, a Ugandan NGO no s5914 6097 which provides education, employment and training opportunities and accommodation

During the year The Love in Action International has continued its work to raise awareness and gain support for the work of Love in action Uganda, and its founders and Directors Alan and Beryl Went.

Love in action

This charity raises funds through direct gifts and child sponsorship for the support of schools families and villages in the Masaka district. This year most of the funds have been raised to extend the school community in Kasaka owned by the Love in Action Ugandan NGO.

The charity took over the child sponsorship scheme originally started by Kingsland Church to support children in Kasaka and Kytume. This collects monthly donations, and forwards the gifts to Uganda to pay school fees for the sponsored child. The school fees include uniform, school requirements and lunch

We collect money from the online shop on the Love in Action website and forward it to Uganda to be spent on the allocated gifts

The Ugandan NGO also ran an internet café in Masaka and Hosanna House, a home for girls completing their secondary education or earning in order to do so. It also owned a farm seeking to produce crops to supplement the income of the NGO.

We also raise funds for the support of Alan and Beryl Went who run the NGO in Uganda and for Eagles Wings, an orphanage in Uganda with no legal connection to Love in Action.

As a service to local charities and friends of the Ugandan NGO we often include funds from other sources in our transfers. During the period £2246 was added to the transfer, from trusted friends for Eagles wings orphanage. These funds appear in our bank account but as the operation was simply to save on administration and transfer charges they do not appear in our accounts; it was not part of our fundraising.

Reserves policy.

The reserves of the trust are maintained at a level which will support the continued activities of the trust.
