# 1 Chairman's report

The chairman agreed last year's minutes.

The year started off with several developments relating to the rateable value of the Centre and confirmation of Charitable status. Charitable status helped with the sum of money required to meet our rate demand, however after further consultation with the Valuation Office the value was reduced further by a considerable amount.

The Borough Council after notification of our new valuation adjusted our outstanding rates to that appropriate for a charity, which we are grateful. We are still waiting for the application for discretionary rate relief to be resolved almost a year after the initial enquiry.

As part of the Charitable status it has been agreed that the Parish Council will provide the Jubilee Centre with a twenty-five year lease. This is currently in the process of being drafted and will give some continuity to the facility, especially the Wilstead Football Club, who via the Football Foundation have a Legal Charge to use the facility for over twenty years.

Throughout the year we have met our obligations on safety with regular inspections of alarms, electrical and gas equipment. This included the fitting of a CO2 detector in the kitchen. We are grateful to the Parish for financing the painting of the Jubilee Room, bringing it back to a good condition after nearly five years use.

We have had several people hire the Jubilee Room for parties as well as meetings for local organisations, including 'Move Your Body' and Pilates. Unfortunately these have not been abundant enough, even with a regular advertisement in the local News Letter. I am pleased that the MUGA is being used by the community and we have had a few hirers for sports events throughout the year in the MUGA.

We are grateful to Councillor Graeme Coombes for supporting the Centre with some Ward funding, which has enabled us to get a grit bin and a safety net. The safety net will be installed according to the Parish Councils requirements now that the football season is over.

Earlier this year we sustained some damage to the back door due to the high winds. Through ingenuity we have managed to resolve the problem with the help of Tim Wren.

Various Trustee roles have changed over the year and I am glad to say that we are managing the Centre. I would like to thank the other members of the Trust as well as Tim and Stan the caretaker for their support over the past year.

On a high note I am pleased to say we managed to get the gas rate reduced substantially, which will help our situation.

# 2 Treasurers report 2015-2016

Eric thanked Ian for doing the accounts, up to his takeover earlier this year.

The provisional results (before audit and final analysis) for this Financial Year are shown on the next sheet.

Highlights from this:

#### Income:

Income from the Football Club and from hire of the building to others has been largely unchanged from the previous year. However, a reduction in income of £4952 from 2015/5 has been largely caused by the loss of the hire of the Centre to the Bluebells Nursery offset by one off receipts from the Parish Council and grants from the local councillor's Ward Fund.

## **Expenditure**:

An increase in expenditure of £1497 has been largely caused by an increase in utility costs of £703 (due to our catching up with outstanding gas bills) plus the return of deposits (both provided for in last year's accounts)and the spending of the money received in grants (Sundry Costs) offset by a reduction of £332 in repairs and maintenance costs.

The combination of these two areas means that from a surplus of £3140 last year we have moved to a £3309 loss.

After allowing for potential costs and deferred income this results in a Balance of £9580 as at 31<sup>st</sup> March 2016. This is then sufficient to sustain losses at the same rate for approximately 3 years but this leaves nothing left as a contingency.

The recommendation for next year, therefore, must be to look for ways to increase the income of the Centre by additional hiring and/or fundraising.

## 3 **Booking Secretary report**

Jackie thanked Eric for his work as secretary until recently.

This year has been challenging in terms of bookings, in March The Dance Class closed down with no promise of a return, and our regular Pilates Class will cease at the end of June, as the instructor is due to have a baby. She hasn't been able to make a promise to return, so we do not have any regularly weekly bookings.

There have been several ad hoc bookings for various organisations, who have been complimentary about our service, and hopefully they will use us again in the future.

Bedford Swimming Association is one of these organisations and they have a further booking in November.

A netball tournament has been booked again for the hire of the netball nets, MUGA and kitchen in July. This has been done before and was very successful for the group, and it is pleasing they have booked again.

A group wishing to set up a childcare nursery approached us and viewed the building but haven't proceeded with the enquiry. I think the lack of storage and need to clear away when other things happen in the building is a big factor in their decision.

There has also been an enquiry for a dance class to be held in June and July, again, although I have provisionally booked the hall, I haven't had any further correspondence, and will have to chase this up.

We continue to have private parties booked, some at very short notice, and do all we can to accommodate these. Parties on a Saturday afternoon have to be refused because the building is used by the Football Club, but once their season ends this isn't a problem.

Once again a family have booked the Centre for their New Year's Eve celebrations, and as several of the guests are football managers, it means we don't have to

open/close for them. This is the third year they will have done this, and there haven't been any problems so far.

A notice of the AGM and a suggestion for a fun day at the Jubilee Centre in 2017 was put in the Newsletter last month, so far no one has shown any interest in helping with this fund raising fun day, so it may be something the committee will have to deal with.

# 4 Football Chairman's report - Season 2015-2016

Another season comes to a close and as we reflect on what has gone before we should as always be proud of what a village the size of Wilstead has achieved in regards to football being available to all ages within our community.
