Summary of the main achievements of the charity during the year

President's Report 2015-16

It is with great pleasure that I present the Prince of Wales Alumni Association's Annual Report 2015-16. I do so with a deep sense of gratitude to the many supporters of the association; patrons, donors, sponsors and well-wishers. Special thanks to POWAA UK members and the wider Princewaleans family in the UK and Ireland for their various forms of support.

In order to fulfil the POWAA UK's objectives to improve educational opportunities for present and future pupils of the Prince of Wales School, the association largely depends on its fundraising activities.

Fundraising Events

The year's activities kicked off with a successful **Skool Daze** in November 2015, an event that is growing in popularity and seems to be catching the right pre-festive seasonal spirit. There was an impressive turnout of people in their various school colours. We look forward to a bigger and better event in November 2016.

In April 2016, the flagship annual **Dinner and Dance** was a huge success. We learnt lessons from the previous year and sacrificed increased financial returns for a better customer service and experience. It was a great atmosphere and the positive feedback vindicated our approach and indicated that the event was good value for money which enhanced our reputation and bode well for the next Dinner and Dance.

The **Thanksgiving Service** in May 2016 broke new ground with a weekend trip to Manchester. A sizeable group of members and supporters, including a contingent of FSSGians, made the journey. The Manchester planning group of Princewaleans rose to the challenge and laid out an impressive 'meet and greet' social evening followed by a memorable day of worship at St. Luke's Church and the Salaam Mosque. Sylvester During, Desmond James, Dr Mohamed Kamara and Abu Koroma deserve a special mention. Thanks also to Victoria Mambo in Manchester and Binti Dixon from London for organising the hall and refreshments for the reception. The Pastoral team did a fantastic job ably supported by Syl Zack-Williams and Dr Kayode Robbin-Coker who handled the logistics of the coach and hotel bookings.

Despite all we asked of our patrons that weekend, they were still very generous in their giving, with donations exceeding £1,600. We give thanks to the Lord for his favours.

Pastoral

In addition to the Thanksgiving Service, the pastoral officers discharged the association's pastoral duties diligently, particularly when individual members needed our fellowship most. Thanks to Revd. Dudley Hancilles for his spiritual leadership and guidance and to Ian Luke-Macauley for deputising when necessary.

The 2015 AGM decision to boost the Association's **Benevolent Fund** from members' subscriptions and donations seemed prescient given the events during the year. In 2016-17, the Trustees will bring recommendations to the general membership to codify the principles, criteria and application of the Benevolent Fund.

I applaud Rowland Davies (Chiks) and Ola Asgill for their dedication in planning and promoting the **Summer Fest, Badminton and Golf** events. Summer Fest and Golf, in particular, have the potential to become significant and rewarding fundraising events in the Summer calendar but yet again this year the efforts of the organisers were not matched by members. We need to do much more to realise the potential of these activities.

POWAA UK's fundraising events would not have been successful without the hard work of the Organising Committee led by Yves Thomas and Femi Jones. Also, the contribution of the good quality of our promotional material to our success should not be underestimated. Thanks to Yves, our appointed resident printer.

The sale of **merchandise** has been steady. It is always a pleasure to see the school colours being worn with pride by Princewaleans at every function. Mr FGO Bright, merchandise guru, continues to set the pace with sale of blazers, ties and bow ties but Patrick Dixon and Remie Akibo-Betts are hot on his heels with T-shirts, lapel pins and caps. Well done gentlemen!

An addition to our monthly General meetings or revival of an old tradition was the **health focus** in July 2016. Members received very enlightened presentations from two General Medical practitioners, both Princewaleans. Dr Willie Morgan gave a talk on male sexual health and Dr Ethan Harris-Faulkner covered hypertension followed by a question and answer session. I hope this trend will continue.

GLC collaboration

The Global Leadership Committee held a successful international conference call meeting in January 2016 attended by all the chapters including a Freetown representative. All constituent chapters agreed the principles for support and release of funds for the Assembly Hall project and the need to embark on the Science Block project. It was decided that Atlanta Georgia's funds would be released to speed up the project and others would follow when required. POWAA UK set aside an equivalent of \$7,000 and an additional \$2,000 to be released on behalf of the California branch.

We continue to benefit from the pro bono professional advice provided by TEDA, a firm of architects and engineers led by two Princewaleans, Alpha Tejan-Jalloh and Gibril Koroma.

Direct Support to the Prince of Wales School

- Shipped books donated by Mrs Jenny Blanshard
- Christmas bonus to the two principals, all teachers and ancillary staff
- Committed \$9,000 to the refurbishment of the Assembly Hall
- Visit by Alex Blanshard to the school during which he interviewed blind students about their experience in the school. This resulted in a vivid and moving presentation at the Dinner and Dance (thanks to Alex and ERS for putting this together) and the decision to award all them scholarships from this academic year.
- We are in contact with the Principal and other chapters to renew the scholarship programme on a coordinated basis.
- The President and Mr Dennis Babin (Membership Secretary) attended the AGM of the Freetown Old Boys Association in May

2016. The President addressed their members and called for us to strengthen the coordination of activities for the school through the Global POWAA committees

- A follow up visit to the school by the President, Mr Dennis Babin and Mr Zainu-Deen Karim, Princewalean from London. We met with Mr Bundor, SSS Principal and Mr Freeman, Secretary of Freetown Old Boys Association. We discussed various issues including the role of the Board of Governors, the status of the revolving fund, coordination of local and diaspora projects, and the income generated through the hire of the school's facilities by IPAM, the Cricket Association and **Médecins Sans Frontières (Spain)**.

Other cohorts of Princewaleans, the Idle Group and Class of 88 and are supplementing the work of POWAA UK and other alumni branches by taking responsibility for the roofing of one classroom block and Science Block toilet refurbishment respectively. Plans are underway to ensure that these efforts are coordinated under the auspices of the Rehabilitation Committee and the Board of Governors. In August 2016, we held a special General Meeting to address this issue as well as the need to establish an effective maintenance culture and regime in the school.

Financial State of the Association

The Treasurer's report will show a year on year increase in the association's overall funds. We raised less funds in 2015-16 than in 2014-15, our 30th Anniversary year, which was not unexpected but we could do better.

Thanks to Patrick Dixon, Treasurer, for his resolute and astute stewardship of the association's finances.

I believe that the main lesson we should take from the year under review is that we cannot rest on our laurels. There is fierce competition from a plethora of Sierra Leonean organisations for the support and patronage of our community. With that in mind, I appeal to you to double your efforts as we embark on another year of fundraising.

We will also need to focus our efforts on achieving a step change with other fundraising methods such as grants for projects from funding bodies and charitable trusts.

My sincere gratitude to the Trustees for their hard work, dedication, support and wise counsel to me. Special thanks to Eugene Benjamin, General Secretary, for the smooth running of POWAA UK's administrative functions.

On behalf of the Trustees and the Association, I extend sincere gratitude to the partners/spouses who hosts the monthly Trustees meetings and ensure lively and constructive meetings fuelled by good food and drinks.

Conclusion

Once again, I am proud of the response of members and other Princewaleans to the needs of our alma mater.

2016-17 promises to be an equally exciting year that will require hard work to replicate the successes of this and previous years. We will strive

in all our activities to continue improving the standard of what we offer and the quality of the customer experience.

Above all, our aim is to raise funds for the Prince of Wales School to fulfil our objectives and public benefit by improving the quality of education for present and future pupils with dedicated teachers and excellent facilities in an environment conducive to learning.

We look forward to a successful 2016-17.





