Charitable Aims and Objectives

- 1. The advancement of the arts for the benefit of the public and in particular the Dearne Valley Communities, in particular but not exclusively by the production, performance and promotion of drama, mime, dance, music, singing and the establishment and maintenance of a theatre known as the Dearne Playhouse.
- 2. For the public benefit to promote the education of the Dearne Valley communities in such ways as the charity trustees think fit, including providing training and retraining among unemployed people.
- 3. To promote for the benefit of the Dearne Valley communities, the provision of facilities for recreation or other leisure time occupation of individuals who may have need of such facilities by reason of their youth, age, infirmity or disablement, financial hardship or social and economic circumstances or the public at large in the interests of social welfare and with the object of improving the condition of life of the Dearne Valley communities.

Activities Undertaken for the Public Benefit and Achievements during the Period

In shaping the objectives for the year, the trustees have paid due regard to the public benefit guidance published by the Charity Commission.

During the period to March 2016, the trustees have focussed on putting into place policies & procedures and governance arrangements to enable the CIO to take over the management of Dearne Playhouse from April 2016. This has included the negotiation of a lease with Barnsley Metropolitan Borough Council (BMBC) for the Playhouse on the site on Furlong Road, Goldthorpe and the acceptance of the transfer of assets from Dearne Community & Miners Scheme (registered charity number 0523576) that has previously managed the site.

There were no financial transactions during the period to March 2016.
