#### Minutes of Annual General Meeting Held on 25 November 2015

#### 1. Welcome and Apologies

Chairman, Gary Colby, welcomed those who attended - Ian Wells (Centre Manager), Max Griffiths (Norwich City Council), Lynda Thain (Dance Exercise), Karen Browes-Walker, Gary Colby (Norwich Cycle Speedway Club), Mary Almey (Petanque), Robert Lovejoy, Sarah Wells, Michele Neave (All About Rescue), Richard Nunn (Ipswich Road URC - Friday Youth Drop-In).

Apologies were received from - Cllr K Driver, Cllr Sue Whitaker, Cllr Chris Harries, Janet Harradine (Tea Dance), Kay Hall (Dance Exercise), Johanna Steward (Lakenham Dale Creative Theatre).

#### 2. Minutes of 2014 AGM)

The minutes of the last AGM (26 11 14) were accepted.

#### 3. Annual Report

Chairman, G Colby, read his Annual Report. He thanked the Committee for their hard work over the last twelve months and said that the Centre continued to be very popular, with many different activities happening each week. He said that the Centre Manager, Ian Wells, was working hard to make the Centre a success and was on site most Mondays to answer enquiries and show prospective user groups around, which was most appreciated by the public. The Social Club had now folded, mainly due to lack of help and bookings, and he would like to thank Ian Stubbs, Paul and Dieter for their efforts over the years.

The Chairman said that there was no Treasurer's report, but the accounts had been independently verified and a copy of the accounts were included in the meeting papers.

He also mentioned the approach made to the Trustees about moving to the new community centre which had been built at the ASDA site on Hall Road. He emphasised that no decision had been made, but it was being considered by the Committee.

#### 4. Accounts & Treasurer's Report

I Wells said that there was no actual Treasurer's Report because at present there was no Treasurer. The Accounts were presented. They showed that income had increased by about £13,000 (partly due to a large rebate received) and expenditure had decreased by approximately £7,500 on last year.

#### 5. User Group Reports

**Dance Exercise** Class - Lynda Thain read the report from Kay Hall (Elizabeth Kay School of Dance) who said that they had had quite a good year, with 11 members regularly attending, 5 of which were from the local area. They had not suffered so much disruption from local youngsters this year, which had been a relief.

**Petanque** - Mary Almey said that the group were concerned about parking; they were now not allowed to park on the grass, which had caused difficulties with another group which met at the same time. However, she believed that the Speedway Cycle group were still using the park. G Colby said that that was now in hand and that Petanque were now parking in front of the gate, which was a help.

**All About Rescue** - Michele Neave said that they were delighted to have found Harford Community Centre, and that the City Council's "Get Involved" week had been very useful for them.

**Cycle Speedway Club** - Gary Colby said that the Club had gained two extra riders and, although they were quite low in numbers, they were looking forward to the next season.

Reports were also received from - URC Friday Youth Drop-In, Dog Agility Exercise, Support GroupMeetings (Pearl Cooper), Wednesday Bridge Club.

#### 6. Election of General Committee

The Committee stood down and Max Griffiths took the Chair. He thanked the Committee and staff at the Centre, and also the User Groups. He said that Harford was a thriving Centre and was going from strength to strength. In connection with the possible move to a **New Community Centre**, he said that there were many hurdles along the way and next year could bring big decisions for the Committee to make.

He asked for volunteers who would like to be elected onto the Committee at this important time. Michele Neave, Mary Almey, Karen Browes-Walker, Lynda Thain, and Gary Colby came forward and were elected.

#### 7. Election of Honorary Officers

Chairman - Gary Colby Minutes Secretary - Lynda Thain were proposed and seconded. The post of Treasurer remains vacant.

#### 8. Election of Trustees

Gary Colby will remain as a Trustee. Michele Neave and Lynda Thain were nominated and elected as Trustees.

9. Appointment of Independent Examiner

Jennifer Burns (Freed of London) will continue as Independent Examiner.

10. <u>Amendment of Constitution</u> - No amendments received.

#### 11. Questions to the Committee

Max Griffiths asked whether there were any questions, particularly re the new community centre. In reply to several questions, he said that there would be discussions with User Groups and park users and their views would be taken into account. The proposed move was being considered because of the cost of maintaining this building; the last quote for the roof alone had been £50,000. The new centre would have a hall and two meeting rooms. There would be no outdoor space but some sports would be possible inside the hall. There would be solar panels on the new building, which would help to keep costs down. The plans would be going before the City Council in January 2016 and we would be looking at the end part of the year for the move.

#### Friday Youth Drop-In

#### run by Ipswich Road United Reformed Church

The 'Drop In' is for young people of High School Age and runs nearly every Friday in term time from 4-6pm. The very nature of Tuckswood Youths as a 'Drop In' means that numbers vary each week, usually between 7 and 17, but there could be more or less. Currently we have a regular attendance of 10-15, but over 70 young people have been registered with us during the past year. We have also noticed that many of the young people are coming for the whole session, rather than dropping in and out and this has led to a much calmer atmosphere. We have 2 main groups of young people attending, one group has been with us for many years, (one young man who attends regularly registered in 2011) and this year we have also welcomed a number of younger people, some of whom used to belong to the Wednesday Club which we run at the church for those in school years 2-6. Both groups integrate well in the club and interestingly; the majority of the young people are male. We continue to employ 3 youth workers to support our activities and there is always a representative of the church in attendance as well, who takes responsibility for the evening.

The 'Drop In' is free but there are refreshments for sale including cheese toasties, Mars bars, Coca Cola and sweets as well as hot and cold drinks. The most popular activities are x-box, (loaned weekly by ENYP, through whom we employ a youth worker), snooker, table tennis, board/card games and the chill out zone. Crafts are available, but we no longer provide a weekly one as there was not the demand.

We are extremely grateful to the staff and committee of Harford Community Centre for their support for the group and for allowing us to store the larger equipment on the premises. Without this support, we would be unable to run the club.
