St Mary's finance function is pleased to present the twelve month financial results to 31
December 2016. This report provides a summary of the results and should be read in
combination with the financial results attached.

Incoming and outgoing resources

- 2. Incoming resources increased from £161,852 in the year ended 31 December 2015 to £166,073 in the year ended 31 December 2016. In particular, planned giving increased to £66,277 in the year ended 31 December 2016 (£63,016 in the year ended 31 December 2015). This positive result reflects the increased commitment from the congregation at St Mary's over the last year. Other categories that saw an increase included PCC fees (£2.1k) and hall hire (£1.0k).
- 3. Total payments fell from £173,459 to £170,952, but excluding the effect of the Living Stones Project rose from £135,784 to £144,008. The largest items of expenditure related to the ongoing operations of the church (the parish share and church running costs), as well as our missions giving, representing 10% of our unrestricted voluntary income. There has also been an increase in our expenditure on local mission; specifically the CAP debt centre, our social action initiatives, and youth work. We were also able to improve the accessibility of the church to potential visitors with our new website.
- 4. The church is extremely grateful to those who provided the income to support all of the activities of the church in 2016. We are constantly humbled by the generosity and self-sacrifice shown.

Financial position at the end of the year

- 5. The 'fund movement summary' provides a view of the St Mary's financial position at the start and end of the financial year. The total balance of funds has decreased by £4,878 and this is due a number of factors, including that during 2016 we spent the money we had been holding for the Living Stones project, and also the former Youth Worker Fund (the youth worker salary is now paid through the Chipping Norton Area Christian Trust). On the other hand, through our Gift Day, we now have money saved up for the re:Sound project and, from general income, have put aside £2k for equipment replacements.
- 6. Importantly, the general fund has remained stable at £32,617 (£32,640 as of 31 December 2015). This indicates overall stability in St Mary's finances, since it represents funds that are neither restricted nor designated, and indicates that the church is not holding funds back that could otherwise be used for charitable activities.

Looking ahead

- 7. St Mary's has set aside enough funds to pay for our missions giving, agreed in 2016, and these have been paid in February 2017.
- 8. An ongoing increase in growth and commitment in 2017 will enable us to meet new challenges, in particular resourcing the new House for Duty post.

Parochial Church Council of St. Mary's, Chipping Norton (Reg. Charity No: 1132070) Year ended 31 December 2016 Accounting Policies

The financial statements have been prepared on a receipts and payments basis, in accordance with Charity Commission requirements for non-company charities with a gross income of £250,000 or less.

Where money is held in a PCC bank account on behalf of another organisation (e.g. Oxford Diocesan Board of Finance, The Children's Society) these amounts are shown as "Agency collections" in the Statement of Assets and Liabilities, and paid over to the relevant organisations at regular intervals.

Funds

General funds represent the funds of the PCC that are not subject to any restrictions regarding their use and are available for application for the general purposes of the PCC.

Designated Funds are unrestricted funds which the Church has allocated for a specific purpose. They can be 'undesignated' at any time and returned to their unrestricted status.

Restricted funds are those funds that must be spent on restricted purposes and details of these funds are provided in the financial statements.

The accounts include all transactions for which the PCC is responsible in law. They do not include the accounts of Church groups that owe their main affiliation to another body or informal gatherings of Church members.

Incoming and Expenditure

Income is recognised when received by or on behalf of the PCC. Expenditure is accounted for when paid.

Fixed assets

Consecrated land and buildings and moveable church furnishings.

Consecrated and beneficed property is excluded from the accounts by s.96(2)(a) of the Charities Act 1993.

Moveable church furnishings held by the Vicar and Churchwardens on special trust for the PCC and which require a faculty for disposal, are accounted as inalienable property unless consecrated. They are listed in the Church Inventory which can be inspected at any reasonable time.

137 Cornish Road, Chipping Norton

The value of 137 Cornish Road is shown as the PCC's proportion [approx. 29%] of the initial purchase price and takes no account of inflation.

Other fixtures, fittings and office equipment

Expenditure on equipment has been recorded in the Receipts and Payments Accounts, but has not been included in the Statement of Assets and Liabilities.

Current assets

Short term deposits include cash held on deposit with the CCLA CBF Church of England Funds or at the bank.

Bank accounts are operated with CAF Bank CAF Bank Limited, 25 Kings Hill Avenue, Kings Hill, West Malling, Kent ME19

4JQ and at HSBC at 18 Market Place, Chipping Norton OX7 5NE.

Notes to the accounts

Accounts for St. James' Chapel Over Norton are not included in the main accounts except for voluntary giving by envelope and bank and payments for annual insurance. A summary of the St. James' Chapel Bank account income and expenditure is included at page 5.



- 2. St Mary's PCC is required to co-operate with the Team Rector in promoting in the parish the whole mission of the Church, pastoral, evangelistic, social and ecumenical, as stated in the Parochial Church Councils (Powers) Measure 1956.
- St Mary's PCC also has maintenance responsibilities for the Parish Centre and a house at 137, Cornish Road.

Church Life

So much has been going on this year that it's hard to know where to begin. As ever, though, I start with a caveat – it would be impossible to acknowledge everything that is happening and everyone involved with individual mention, so – if you are amongst the large proportion of the church family who contribute faithfully week in, week out, please would you accept my heartfelt thanks for all that you do, whether seen or unseen. Moving on, then, and selectively high-lighting aspects of our corporate life...

In our gathered worship we have sought to ground our mission to share the life-changing love of Jesus, serving our whole community on a broad Scriptural base: We began the year being inspired by 1 Peter and Titus to embrace our identity as new creations, born again into God's family, before following stewardship.org's 40 Acts material as a church to keep us outward-focused during Lent. The book of Daniel then encouraged us to have the confidence, in Jesus, to swim against the tide of secular opinion when it goes against God's clear direction as to what's best for our lives. We spent the summer months being reminded by Galatians of the 'True Freedom' that we have in the Gospel, before considering some of Jesus' parables, and then ending the year in song – firstly in Isaiah's Songs of the Servant, and last of all in the Songs of Christmas.

Beyond our Sunday worship, it's so encouraging to see more people joining the various **Small Groups** which increasingly form the heart of our growing church, providing the primary setting for the church family's **pastoral provision**, as well as equipping us in our lifelong **discipleship**.

As we've journeyed together in these ways, it's been wonderful to see God continue to grow us both in number and in faith throughout 2016, leading us into new **mission** opportunities and partnerships.

Touching firstly on those: as well as seeing our CAP (Christians Against Poverty) Debt Centre flourish and begin to make a deep impact locally, alongside developing existing mission partnerships with Bruce and Jan Rossington of AIM (African Inland Mission), it's been wonderful to embark on a new partnership with Open Doors, which has helped us to keep the persecuted church firmly in our minds and prayers. We've also been delighted to contribute towards the Christian Chaplaincy at Long Lartin Prison, and the wonderful youth ministry

provided locally through **Adventure Plus**. All this is, of course, in addition to our regular support of **Operation Christmas Child** through their shoebox appeal, and **The Children's Society** through our Christingle service.

In May, we also held a Gift Day. Thank you so much to all those of you who contributed, enabling us to direct over £12,000 towards support four separate projects: We were pleased to be able to bless both **The House of Bread at Burmington Mill** with equipment to help them the next time they are flooded, and **St Mary's school**, with a fund to support those who would otherwise be unable to afford school trips, and also with a celebratory meal for the staff to thank them for their wonderful work with our children. We also had the amazing privilege of facilitating a **Bible translation** pilot project for an unreached people group **in Tanzania**. Finally, the church family's generosity has enabled us to address the urgent need for equipping the church with a **sound system** that is fit for purpose, both for our own needs and for the needs of the many people who use the church for external events.

Through these partnerships and initiatives, we're not only broadening our horizons by financially supporting wonderful examples of Christian witness locally and abroad, but also aiming to engage the church family actively, in the knowledge that we will ourselves be blessed as we get stuck in personally.

Many aspects of our church life this past year will be covered in the various sections below, but — without any hope of being totally comprehensive - I will mention here just a few other things in the hope of recording as broad a perspective as possible of where God has been leading us over the course of the year:

- A real highlight early in the year was our 'Journey to Easter'
 Labyrinth in the church. Coordinated superbly by Judith Marshall,
 this event drew the churches in the town together, with dozens of
 people contributing creatively, and hundreds of people from the town
 and surrounding area coming to visit and to be inspired.
- Following a training session in the summer, we have been able to establish a regular pattern of offering Prayer Ministry during our main Sunday Services. Along with 1st Priority Prayer on the first Wednesday of each month, this has served to keep prayer at the centre our church life. On some months we have also enjoyed joining to pray with members of other churches in the town and from the

wider region for Town Prayer and North Cotswold Gospel Partnership Prayer evenings respectively.

- To assist with our general pastoral provision, we held a training session in the Spring for a new team of **Pastoral Visitors** and were hugely encouraged by the number of willing volunteers.
- Phase 2 of **Living Stones** is now complete, with the Croft and Redrobe tombs splendidly restored and resituated. This paves the way for us to pick up our greater 'Phase 3' ambitions for re-ordering when the time seems ripe. Particular thanks must go to John Marshall for seeing this through in such a determined fashion.
- Over 40 of us again spent a week together growing in community and in faith in the summer at **New Wine**.
- God used **Alpha** again powerfully in the summer term to make himself known to our guests, and we were able subsequently to celebrate **6 baptisms by full immersion** in September.
- Our annual civic events (Civic Service in July and Remembrance Service) were as well-attended as ever, and we also shared with the Churches Together in Chipping Norton to hold a short service to open our Town Festival in honour of the Queen's 90th Birthday.
- The catalyst of a new-look website prompted the PCC to consider and lay out a set of Values which underpin our sense of church and ministry. Do take a look at www.stmaryscnorton.com/vision-and-values.
- Bookings of our refurbished Parish Rooms have increased as the town has taken advantage of the hospitality that we can now offer through this improved facility.
- Our programme of Women's Events, has continued with hugely popular breakfasts giving a platform for some inspiring speakers, and with Mary's Kitchen and 'Create' events drawing people in from well beyond our church family.
- Our monthly 'Come to Tea', continues to grow as a valuable time of fellowship. Likewise the Parish Lunch remains hugely appreciated by everyone attending.

Looking forward

Renewed Vision for next 5 years

Although our current 3-year vision has served us well, 2017 brings the need for us to review our priorities as we prepare for the next season in the life of the church. We will initially be engaging with that as a PCC in the summer, but encourage the whole church family to be involved in that process prayerfully and in putting forward your views and suggestions.

Small Groups

Our Small Groups, which are the primary place in which we can care for the growing church family pastorally and spiritually, are becoming increasingly essential to the health of the church. To help us to develop our Small Groups and nurture their Leaders, we are thrilled to be welcoming a new member of our clergy team to start after Easter 2017. Along with her husband, Roger (who is also ordained), Ursula Simpson brings with her a wealth of experience in leading growth in Small Groups.

Tearfund Connected Church

As part of our aim to broaden our horizons when it comes to personal involvement with overseas mission, we have just signed up to Tearfund's Connected Church programme and will be supporting ZOE (Zimbabwe Orphans through Extended hands). We would love to see as many of you as possible involving yourselves actively in this new partnership, hopefully sending a group on a short-term mission trip in the coming months to deepen and strengthen that relationship.


NCGP Tent-Mission, Summer 2018

It may seem like an age away, but throughout 2017 we will be looking to build momentum towards an exciting vision for a North Cotswold Gospel Partnership Mission in the summer of next year, possibly situated very close to Chipping Norton. Again, if you would like to be involved in shaping this vision, then we'd love to hear from you.

Families

Outreach – This has grown in momentum with 12 people signing up to help build an Outreach Team. We are still struggling to find a store. (see separate report prepared for the PCC in January). We have helped over 25 families with housing issues and furniture, delivered school uniforms to children, and partnered with CAP to deliver Christmas Hampers to their clients and the clients at the hostel in Horsefair.

Mary's Kitchen - this continues to be a winning formula: lots of fun whilst we cook, and then able to bless so many. We have encouraged the Pastoral Team & clergy to make more use of this. Over 150 recipients of meals this year



St Mary's Minis - Minis has grown from strength to strength in the past year with Anna Mitchell continuing to lead the sessions with support from Martha and a small team of volunteers. Numbers have grown steadily, especially with the closure of the Ace Centre. We now have over 60 parents or carers on the books, with around 15 adults and 20 children coming each week. We have been encouraged to see that people moving into the new developments are finding the group quickly, and also to see more overlap with baptism families.

Marriage Preparation - running twice a year, and planning a marriage Course for the summer term

Children and Communion - the introduction of Communion to the whole church family went well. This will need to be looked at on an annual basis to introduce new families and children.

Creche - Bill & Jo Rees have introduced a Bible focus to the creche session, in the form of a puppet - Jack, who greets and sings with the children, before then looking at a bible theme. Bill is training up the creche team. We are looking forward to Resound scheme making it possible for the adults in creche to hear the sermon.

OneWay - continues to be a fun and engaging environment for children to look at the same Bible passage as their parents/carers, but in a more age-relevant way. We have several new team members, and are also looking to be able to offer 1-to-1 support for those children with special needs.

Baptisms - Baby and child baptism continues to be a key way of meeting and welcoming young families into our church fellowship. Over the last year, we have baptised 13 infants, most of whom would have no

contact with church otherwise. Work continues to look at how we maintain and grow ongoing relationships with these families.

Looking forward

Most excitingly several doors seem to have opened for us to step in and support the work of our **Primary School**, and through that build relations with the most vulnerable families in out community. The School are already feeling the negative effects of the <u>closure of the ACE Centre</u>, and have asked us if we could increase our level of support in running:

- a "Parent Drop In" every Monday morning, where parents can discuss problems, parenting issues etc and we can signpost them to other services (such as CAP / Parenting Course)
- a "Stay & Play" session on a Friday morning where parents and toddlers enjoy breakfast together, followed by a soft play session. The school have committed £2,000pa to this, and we are currently putting together a bid to the OCC Transition Funding

Youth

Employed formally through the Chipping Norton Area Christian Trust, which was established in 2014 to support our ministry at St Mary's, Jonny Lowe has now been with us for 18 months.

Jonny writes: There have many things to be really thankful for this year.

Weekly Groups: These continue from last year... Firstly Spark (a boys group meeting on Wednesday evenings) in Churchill. It has been a really great way to hang out, play sport and dig deep into God's word. Jonny Shaw and Harry Povey have led this alongside me. Then the girls also love coming along to Impact (meeting on Sunday evenings run by Katie Lowe and Kathryn Walton), hanging out together and chatting about life. This is a time of getting into the word and encouraging and challenging each other. Both groups have been looking at different topics such as Daniel, I am claims of Jesus, James, Generosity etc. It's a great space to really learn and grow in God's word and it provides real fellowship.

Ablaze meets on a Sunday morning and we enjoy some food and time where we can chat and discuss God's word. Emma Hornez has

supported me in providing a great network for young people and space for them to learn and be encouraged. We have looked at **Parables of Jesus**, **How to share the gospel with friends**, and **what the bible says about big issues of life**. We also **serve once a month in church** which is a great way of integrating into the church family.

Mentoring: There is now a mentoring network in place which is very exciting. Young people have the opportunity to meet with an older Christian one-to-one, to grab a coffee and read the bible, pray and seek advice in life. This has been really beneficial for the young people and is allows them space to share their thoughts and it means someone older is looking out for them, praying for them and investing in them. Sharing life is so important!

Weekend Away & 'United' week away: In January 2016 we went on a weekend away to Ledbury at The Poplars. It was the most incredible weekend. We had 13 young people and some brilliant leaders. We were looking at the book of Ruth in our meetings together and everyone was really challenged and went away with an even greater view and love for God. We had a worship night which was a special time for all. God was really doing a work in young people's hearts as they opened up to God and the Holy Spirit was transforming lives right in front of us. It was beautiful to see tears fall and smiles as God was speaking to young people in such a profound way. We had such a good time that we returned to The Poplars for 5 days at the end of the summer holidays for more fun and games, bible teaching, worship and food.

Take a Hike: John Marshall continued to lead these monthly boys' hikes on Saturday mornings until August, but owing to a shortage of available leaders, we have had to draw them to a close for the time being. These have been great fun and the lads have loved them, enjoying several testimonies over the last year after coming together to enjoy God's amazing creation and hear how he is changing people's lives (at the same time as eating a super fry up!). A huge thank you to John for his commitment to these Hikes over the years – they've been a great way to share time and life together.

Worship Unplugged: Once a month we get together with some our worship team and learn how to lead worship together. This year, we then had a fantastic Sunday in November when the youth led the entire service, which was wonderful for the church family to see, and a great encouragement to the young people too.

Schools: I have had the great privilege of doing **assemblies** in both St Mary's Primary School and Chipping Norton School over the last year as

well as running a weekly **drop-in** in the Top School giving the young people to opportunity to come and chat. I have also been able **coach some after school football** which has been thoroughly enjoyable and is a brilliant way of building relationships with staff and pupils.

Socials & other events: We have been able to do some brilliant things socially as a groups. We have been ten pin bowling, night hikes, trips to Nero's and Nando's. Another great thing that we've enjoyed has been going, as a group, to 'Nightlife' in Oxford (a big youth worship evening), where it was wonderful to be a part of a large body of Christians worshipping our God together. Likewise, The Big Church Day Out in May which was a super day. A more active event was then a Kayaking trip in July too for young people which was great fun as we ripped it down the Thames in Reading.

A few young people also came to '**Sports Plus Xtra**', an even run by Christians in Sport to equip young people to live out and share their faith in their sports teams. This was brilliant and the boys loved playing new sports and getting into God's word and seeing how it affects their sport.

During **Easter** we also did a **community gardening project** which was great fun. We were able to overhaul and give the garden a makeover at Horsefair (temporary accommodation for individuals who have been homeless and unemployed). This was a great way to bless our community and see the young people get stuck in and serving. It really was faith in action.

Lastly, a real step forward for us as a church has been the **launch of** '**Remix**' (a Friday afternoon youth club at the Glyme Hall) in June. This has given us a massive opportunity to engage with the young people in our community and be able to share life and the gospel with all of them. In the first 4 weeks, we saw over 50 different people come through the doors and by the end of the year, we were seeing a regular attendance of about 25 young people each week, having fun playing sports, games, enjoying the cafe and building community.

We are hoping to encourage young people to get involved in various summer camps and events like Big Church Day Out Total Adventure, Sports Plus, New Wine. It's always exciting to be part of something big with other young christians.

Remix – draw people into more active faith

Remix has been super at building relationships with young people in our community. We want to continue to look for ways to share our faith with them and encourage young people to get involved in our youth church family, ultimately coming to know Jesus as Lord. If you can help lead at Remix on Fridays we would be really grateful.

Overseas Mission 2018?

We would love to do an overseas mission in 2018 so we are making inquiries to see what we could do in serving people and the church abroad. It could be a very exciting adventure for our young people and make a huge impact to their faith and the lives of others.

Men

'Men United' has continued to draw the males in the church together in 2016. Particular thanks must again go to David Bishop, Philip Sharman, Tom Simpson, and Stuart Sibley for their parts in the planning and publicity.

After looking back at our activity over the previous year, in 2016, we decided to focus our outward attentions around five main 'invitational' events spread throughout the year, but then to support those with a number of other more regular, but low-key events aimed more towards the church family.

To those ends, we enjoyed a **Men's Breakfast** in January (with guest speaker Paul Weston, keen mountaineer and brother of our former Incumbent), a **Curry Night** in March (guest speaker Piyush Jani, An ENT surgeon who grew up as a Hindu, but came to faith in Jesus as an adult), and another Men's Breakfast in September (guest speaker Chris Lavy, Professor of Orthopaedics and Tropical Surgery, who also set up two children's hospitals in Africa). All of these speakers gave wonderful talks, introducing their faith in ways that were both engaging and accessible, and the Curry Night in particularly proved extremely popular with our guests.

We also held two social evenings: an evening **tour around the Hook Norton Brewery** in June, and a **Skittles evening** in December, both of which were very much enjoyed by all who attended.

As well as these, our regular **Curry Club** continued to meet on the 4th Sunday of each month, and four **Men's Fellowship Breakfasts** in the Parish Rooms were much appreciated by all who attended. At these, we were encouraged and inspired by personal testimonies from Dan Ritchie, Stephen Blake, Chris Mitchell and David McInnes, and enjoyed, on each occasion, the opportunity to pray and support one another.

Finally, this year we joined with other churches around the North Cotwolds to spend a morning together being encouraged and inspired to be 'Ambassadors for Christ' by Rico Tice in the first Cotswold Men's Convention in the Warwick Hall in Burford.

Taken together, these activities again provided a great way for men within the church to get to know one another better, and also an easy environment into which we could invite our friends and neighbours.

We'll also be thinking about how to connect our outward-focused activities more deliberately with either courses or activities that specifically lead people into a more vibrant faith.

Following the success of last year's convention, there will be another North Cotswold-wide Men's Convention in the Autumn at which Vaughan Roberts will be the main speaker.

Sunday, March 20th 2016 at 12.30 p.m. in the Parish Rooms.

- **1.** The Revd Dr James Kennedy opened the meeting with a welcome to all 42 members present, with a reading from Isaiah 54 and with prayer.
- 2. Seven apologies for absence were received.
- **3.** No item of A.O.B. was announced.
- **4.** The minutes of the **2015** meeting were read, approved and signed as a correct record. There were no **Matters Arising.** The secretary was thanked for his contributions to the life of the church.

Churchwardens' Fabric Report

Churchwarden's Fabric Report for the A.P.C.M. 2017

This report has been prepared in accordance with the requirements of the Care of Churches and Ecclesiastical Jurisdiction Measure 1991. It has been circulated to members of the Parochial Church Council and any amendments required by them have been incorporated.

Cleaning and Maintenance

- **1.** The annual clearance of the Church and Parish Centre roof and hopper-heads is carried out by John Harding.
- **2.** The maintenance of the churchyard is the responsibility of the Town Council. We are grateful to Chipping Norton Green Gym for their efforts to tidy in the churchyard throughout the year.
- **3.** Richard Taylor keeps the channels free of weeds. The channel gullies and any blocked drains or gratings around the base of the church walls have to be cleared by us including the drain by the porch after heavy rains.
- **4.** We have a contract with J & J Cleaning to clean both the church and parish rooms weekly. In addition R & B maintenance for annual deep clean of carpets on the platform in church and in the Parish rooms.
- **5.** Cleaning days are well supported with high level in spring and two lower level cleaning days. CN Brownies continue to support this work.

Fabric needs/projects/repairs

The PCC approved a small budget for maintenance of the fabric of the church to be expended at the Fabric Committee's discretion. Potential items of work are, considered at each meeting.

Of the 4 points taken from the Quinquennial Report – October 2013 and highlighted for action 2 large projects remain.

1. Repair wood-block and mosaic paving floors – still outstanding.

- 2. Roof Work major project highlighted in QI Churchwardens submitted a second bid to the Government Roof Repair Fund but were once again unsuccessful.
- **3.** Replace rusting galvanised window guard to window in south aisle (west of south door) this was completed in 2016 thanks to a donation from the Friends of St Mary's Church.

Further projects:

- **4.** A meeting in January 2016 to discuss the future development and use of the area/space created by the removal of tombs. It was considered extra space for distribution and enjoyment of coffee was needed. It was also noted decluttering there possible to make the space safe for those using this area. Some work to repair the wooden block floor has been completed to help with this aim.
- 5. There was a successful sale our 5 non-standards pews.
- **6.** Following Stuart Cutting's risk assessment on the Parish rooms, a new fire door to the kitchen was fitted, also a half-glazed door to the upstairs office. Further work to create an extra office space downstairs was completed. Considering lone working, quotes are being obtained for entry security systems.
- **7.** Alcocks replaced missing glass from the clerestory.
- **8.** Estimates have been obtained from Drain specialists to solve the problem of the blockage in the drain by the main door. Discussions are also underway with the town council about responsibility & maintenance.
- **9.** New LED lights fitted to the church porch and parish rooms have helped with winter evening needs.

Project - Resound

Following a very generous response to the gift day a small group called (resound) was set up to look at various options and give recommendations to proceed with this work, they have met with a number of companies and report below:

Following the feedback we had from consultations with the congregation and a wider group of interested people in the Church, the approach we will adopt will be to have a flexible and 'future-proof' sound solution comprising good quality and reliable components configured into a system that is easy to operate in a variety of circumstances (from small funeral or side-chapel service to large service with many 'inputs', and 'external' event from school service to concert or literary event) - all provided by a professional company with bona fides credentials and relevant reference installations, and offering appropriate warranties, guarantees, training and follow-up service (which all four of these companies offer). This 'stepwise' approach means that the whole 'reSound' project will take up to a year to achieve but will ensue we get a good quality sound system that is fit for purpose, flexible and capable of seeing that St Mary's needs are met for many years and that we don't waste money or make mistakes.

Project to move the tombs -

Relocation and conservation of the Rickardes and Redrobe tombs in 2016 brought to completion Phase II of the Living Stones vision for the church – a comprehensive redevelopment of the church interior developed in 2003 in conjunction with the then church architect, Reg Ellis. While, for financial reasons, it did not prove possible to include conservation of these tombs and the Croft tomb when our redevelopment work was undertaken in 2010/11, a subsequent generous grant offer from the Shaw-Meades trust enabled the project to be revived. The founders of the trust - 20th-century members of the

Meades family – had been keen local historians who had greatly loved our church building and its historic treasures. Further grant offers were negotiated: from the Friends of St Mary's, Churchcare, Oxfordshire Historic Churches Trust, St Andrew's Conservation Trust and the William and Jane Morris Fund. These, together with money already raised from a sponsored walk from Chipping Norton to Croft Castle, Herefordshire, by Canon Steve Weston, former vicar of the parish, and other donations, enabled the PCC to commission specialist conservators Sue and Lawrence Kelland to undertake the work.

Conservation of these three monuments started in 2015 and, after a break, was completed in October 2016. The happy result is that three fine monuments that were previously damaged, dirty and hidden in almost inaccessible corners of the church are now clean, skilfully conserved and displayed together in a space of great beauty and enormous historic interest.

The finishing touch will be to replace the temporary historical display with professionally produced exhibition panels on new stands, as and when funds permit.

This is the final report from the Living Stones Committee set up to oversee this work. The Churchwarden's are grateful to John Marshall and his team for all his hard work in seeing this project to completion.

Inspections

All maintenance and repairs for the church, parish rooms and 137 Cornish Road are logged centrally and monitored by the fabric committee.

- 1. The annual PAT (portable appliance testing) was completed in the Church and the Parish Centre in May 2016.
- 2. Whites of Appleton carried out their annual inspection and maintenance of the bells in November 2016 recommendations for this year: to continue to monitor the headstock splits during future maintenance visits and give advice accordingly.
- 3. Executive Fire Protection Ltd carried out their out the annual inspection in March of fire extinguishers in the church building, parish centre and St James' Over Norton. A church plan showing the ideal location of appliances has been made and is displayed in the Church and the Church Office.
- 4. The First Aid box is situated in Church by the welcome area with a clear sign to locate it. There is a similar box in the parish Centre kitchen.
- 5. Graham Povey continues to manage the church boiler and reports to the Fabric Committee. The boiler service contract was completed this year by Gas safe, this company were very helpful and more cost effective.
- 6. Electrical Testing a periodical 5 year test was last carried out by Bannor Electrics in 2012. The next testing will be due in 2017.

Security

We continue to receive regular warnings from the Diocese and the police about Church security. Thefts of lead are still a regular occurrence, insurance companies are encouraging churches to consider alarms in addition to smart water marking.

There has been concern that the security of the key pads into the main vestry have been compromised over the past year. Codes will be changed to try to keep this in check.

The donations box is still out of action estimates are being sought for the cost of a new metal safe.

The fabric committee continue to monitor the cost & need for additional security aids.

Health and Safety

Stuart Cutting during 2016 carried out a risk assessment on the Parish rooms following refurbishment and additional office use.

Architect

A new Church architect is still to be appointed, the fabric committee will consider this during 2017 before the next quinquennial inspection due in 2018.

Chipping Norton Deanery Synod

In 2016 we welcomed a new (interim) Lay Chair, Alan Kennedy (no relation), from Milton-u-Wychwood, who took over this key role from our very own Amanda Gafford (many thanks to Amanda for her service, with uncounted time devoted to the role...).

Our major focus of the year was a renewal of the Deanery Mission Action Plan (MAP). On his recent visit to our Deanery, the Bishop of Oxford shared his vision for the Diocese, and for the wider Church as being 'Contemplative, Compassionate and Courageous'. The MAP aspires to meet this challenge: looking towards church growth and the launch of new initiatives that will lead to peoples' lives being changed, and wider community transformation. The key areas addressed in the MAP are (1)Children, Young People and Young Families (including schools), with plans afoot for a Deanery Schools Day in 2017; (2) Discipleship, focusing on the involvement of church members, from intercessions and reading lessons to preaching and administering at Communion, and looking ahead to the 'Thy Kingdom Come' prayer initiative 2017, for which a Deanery-level leaflet is planned; (3) Church Involvement in Local Communities And Charitable Enterprises; (4) Buildings and Environment. PCC Committees

There are a number of subcommittees of the PCC. Much has been achieved and many aspects of the life of our church depend on their continued work. We would like to thank all those who have served on them.

- a) **Standing Committee**: This is the only committee required by law. It has the power to transact the business of the PCC between its meetings, subject to directions given by the PCC.
- b) **Fabric Committee:** helps the churchwardens with the maintenance and development of the church fabric including matters relating to the management of the Parish Centre, and liaising with the Town Council in the management of the churchyard.
- c) **Living Stones Committee:** has met to coordinate, seek funding and to advise PCC with regard to the completion of Phase 2 of the Living Stones project (the move and restoration of monuments to monument area)
- d) **Missions Team:** meets to consider the church's 'mission' in the broadest sense. The team advises the PCC and assists with the strategic planning, development and communication regarding Gift Days and ongoing links/ partnerships with other mission-related organisations and activities.

In addition to the above, the PCC can set up additional committees. The PCC met 10 times during the year.

Church Attendance

During 2016, we have continued to see modest growth of our 10.45 congregation (average attendance this year was approximately 5% more than in 2015, standing now at 111 adults and 28 children). Our 8am, 9.15 and Thursday morning congregations have remained stable.

2017 Electoral Roll Revision

Following the annual revision of the Electoral Roll, the number on the Electoral Roll as from 17th March 2017 is 149

20 new names have been added to the Roll.

During 2016, 9 names have been removed, having died.

11 people have moved away (including Elizabeth Allen and Carole Bradshaw) and have been removed from the Roll.

Finance Report

 St Mary's finance function is pleased to present the twelve month financial results to 31 December 2016. This report provides a summary of the results and should be read in combination with the financial results attached.

Incoming and outgoing resources

- 2. Incoming resources increased from £161,852 in the year ended 31 December 2015 to £166,073 in the year ended 31 December 2016. In particular, planned giving increased to £66,277 in the year ended 31 December 2016 (£63,016 in the year ended 31 December 2015). This positive result reflects the increased commitment from the congregation at St Mary's over the last year. Other categories that saw an increase included PCC fees (£2.1k) and hall hire (£1.0k).
- 3. Total payments fell from £173,459 to £170,952, but excluding the effect of the Living Stones Project rose from £135,784 to £144,008. The largest items of expenditure related to the ongoing operations of the church (the parish share and church running costs), as well as our missions giving, representing 10% of our unrestricted voluntary income. There has also been an increase in our expenditure on local mission; specifically the CAP debt centre, our social action initiatives, and youth work. We were also able to improve the accessibility of the church to potential visitors with our new website.
- 4. The church is extremely grateful to those who provided the income to support all of the activities of the church in 2016. We are constantly humbled by the generosity and self-sacrifice shown.

Financial position at the end of the year

- 5. The 'fund movement summary' provides a view of the St Mary's financial position at the start and end of the financial year. The total balance of funds has decreased by £4,878 and this is due a number of factors, including that during 2016 we spent the money we had been holding for the Living Stones project, and also the former Youth Worker Fund (the youth worker salary is now paid through the Chipping Norton Area Christian Trust). On the other hand, through our Gift Day, we now have money saved up for the re:Sound project and, from general income, have put aside £2k for equipment replacements.
- 6. Importantly, the general fund has remained stable at £32,617 (£32,640 as of 31 December 2015). This indicates overall stability in St Mary's finances, since it represents funds that are neither restricted nor designated, and indicates that the church is not holding funds back that could otherwise be used for charitable activities.

Looking ahead

- 7. St Mary's has set aside enough funds to pay for our missions giving, agreed in 2016, and these have been paid in February 2017.
- 8. An ongoing increase in growth and commitment in 2017 will enable us to meet new challenges, in particular resourcing the new House for Duty post.

Chipping Norton Area Christian Trust (CNACT)

A relatively quiet year for CNACT. The Trust continues to employ our Youth Worker, thanks to the wonderful generosity of the church family across the Benefice, with the wonderful ongoing support of the Joseph Rank Trust and with kind contribution from the Community Church and Churchill RE Fund.

A financial report up to 31st May 2016 is included in the appendix to this report along with the church financial report.

In 2017, it is likely that we will need to appeal once more to the church family in order to ensure that we have the full amount required to maintain the Youth Worker position beyond the initial 3-year contract period to take us up to 5-years (and more...).

CNACT will, of course, continue to seek additional external financial support over the coming year but if anyone within the church family would like to support our invaluable Youth Ministry further, either by making a one-off donation, by setting up a new standing order, or by increasing an existing regular donation, please contact either Jamie Bell – churchillheath@mac.com or Linda Carpenter – linda.carpenter50@yahoo.co.uk (Trustees).

Staff

We have enjoyed a relatively stable year as a staff team, Martha Simpson rejoined us in August after a year of maternity leave. Otherwise, Emily O'Shea and Emma Bayley remain invaluable in the office, with Emily slowly expanding her role to embrace more of our electronic communications alongside her finance role. Together with Sam Shaw in Kingham and Churchill they coordinate our administrative functions across the Benefice. We are also grateful to the volunteers who come in to ensure that things run smoothly (especially Gill Parry and Matthew Carpenter).

As will be appreciated from his youth report above, Jonny Lowe has worked hard to develop his role too, engaging youth in the schools as well as within our church family.

We are also remain extremely grateful for the ongoing support of Rev David Salter (Team Vicar), Rev Jackie Jones (Associate Minister) and for the fantastic regular assistance that we receive from neighbouring and retired clergy (namely Victor Story, Robin Howard, Hugh Williams, Mike Selwood, Ian Arthur and Jan Fielden).

The PCC has continued to grow together and to be an amazing source of encouragement and godly counsel. I would particularly like to thank them all for their wisdom, kindness and willingness to give their time to see the life-changing love of Jesus shared even more widely as we serve our community.

Lastly, I would again like to acknowledge and record a particular word of thanks to my family, and especially to my wife Emma, who – although not on the staff team - has worked incessantly throughout the year and been an invaluable support to me.
