REFERENCE AND ADMINISTRATIVE DETAILS

- a. The charity's name is LYMM FESTIVAL CIO ("Charitable Incorporated Organisation").

STRUCTURE, GOVERNANCE AND MANAGEMENT

- a. The CIO is governed by a Constitution, last amended on 19th September 2013. The Trustees delegate some of their powers to Lymm Festival Committee in accordance with a document setting out the Terms and Conditions of Delegation, last amended on 18th January 2014.
- b. Two of the First Charity Trustees retired on 31st August 2016 at the end of their period of office. If a vacancy for a Trustee occurs, then the existing Trustees will make that known and will approve any applicants before their appointment to the Board. The conditions of eligibility for trusteeship are set out in the Constitution.
- c. The CIO's Committee meets monthly and has also established a number of sub-committees to facilitate the work of the full committee.

FINANCIAL REVIEW

- a. The financial position of the CIO at the year-end is set out in the accompanying accounts, which have been scrutinised by an Independent Examiner and whose report is also attached. The results for the year were satisfactory with a successful Summer Festival attracting good attendances for a wide variety of events.
- b. The Reserves Policy adopted by the Trustees was amended in November 2016 as follows:
 - General Reserve at the financial year-end, the reserve will be maintained at a level approximately equivalent to the total loss of ticket and related income from a summer festival. In this way, all financial commitments could be met even in this demanding situation.
 - Restricted Reserve there are no Restricted Reserves at present; a policy to govern
 any such reserves that may be created in the future will be drawn up at the
 appropriate time and with terms appropriate to any conditions attaching to the
 purpose of the reserve.
 - It is recognised that the level of the General Reserve will vary from time to time and, therefore, will be reviewed from time to time to reflect changes in the relevant income over the years.

PUBLIC BENEFIT STATEMENT

The charity's Trustees have complied with their duty to have due regard to the guidance on public benefit published by the Charities Commission in exercising their powers and duties.

OBJECTIVES AND ACTIVITIES

The objects of the CIO are

- (1) To advance the arts for the public benefit, in particular but not exclusively by the provision of an arts festival and workshops.
- (2) To advance the education of the public in the heritage of Lymm.

During the year ended 31st August 2016, the CIO held the annual Summer Festival, comprising almost 50 different events held over 11 days, and during the period from October 2015 to March 2016 held a number of "Winter Warmer" events with the intention of retaining the interest of the public. All events were held in and around the village of Lymm.

ACHIEVEMENTS AND PERFORMANCE

The Trustees are pleased to report very satisfactory results for the year as measured both by the financial outcome and by the way in which the Festival was received by the public. The Summer Festival 2016 was, once again, held over 11 days with almost 50 separate events organised by the Festival Committee and by other local organisations acting under the umbrella of the Festival.

Attendances at events compared favourably with previous years, despite the outdoor events being affected by the poor weather, and demonstrates that the type of events appeal to the target audience and to all age groups. The Festival continues to promote local talent wherever possible.

As planned, more events were put on for families and these were well attended across the board. The involvement of local organisations and businesses in sponsoring and running the events also demonstrates the wide appeal and the commitment to the aims of the Festival as a true community enterprise.

In addition to the Festival Committee, many others come forward to volunteer their help in a range of roles from stewarding to selling tickets and this commitment also embodies the spirit of Lymm Festival.

Communication continues to improve with the website, social media and more people signing up to receive regular newsletter. The reach of the Festival's publicity continues to grow and, consequently, visitors are attracted from a wider area, especially for the Transport Day event.

The Trustees look forward to the coming year with sound financial and organisational structure established to continue the aims of the Festival.
