I report on the accounts of the Charitable Trust for the year ended 31 October 2016 which are set out on pages 2 to 4.

Respective responsibilities of trustees and examiner

Birth rate dropped in 2006

People in their 20's now who were born or were young when Chernobyl happened have fertility problems.

Chief Executive's report - Mike Cowan

Presentation was accompanied by slides

Huge distance covered by charity, children coming from "Clean zone" or "Chernobyl zone" UK government has stopped bi-lateral health agreement which means the children all need health insurance to come this year = \$7 per child.

Presentation from KATYA

16 years involvement with FOCC

Main message was THANK YOU

Involvement in the charity has changed Katya's life and more importantly the lives of the children. Katya described the children returning to Mogilev after the visit – how excited they are to tell their families of their visits and all the things they've done and seen. Makes it all worthwhile. Sad that their own authorities don't do enough to help their own children.

Expressed special thanks to Mike Cowan who is also charity director of Helping Hands a charity that helps FOCC children's families in Belarus too.

What happens in Belarus to prepare the children for the trip:

SELECTION

The March and Oct visits from UK coordinators is essential for helping to select suitable children. Lists are provided to the charity from Belarus social services but on these lists 50% of children are needy and 50% are not. So visits need to be made to the families and children in order to determine which 50% is needy. Also other children NOT on the lists are found by visiting schools and villages. It is hard work – but important to find the right children

DOCUMENTS – there is a serious amount of bureaucracy to complete.

 Passport. Used to be free. On 1st March price doubled to \$10. No discount for multiple children. Plus, papers are required to obtain the passport +\$5 (photos and docs)
 Some parents more willing than others to help organise a passport.

2. Application Form

Parents provide info which is required to apply for the visa. This is family info.

3. School Permission

This is required - even when the visit is in the school holidays – don't know why Parents apply to school. The Head Teacher decides.

Need a stamped form from the school with the dates of the visit

4. Parents' Permission

One for Embassy one for Customs. \$5 each

- 5. Justification Document
- Live in poor area
- Family circumstances

6. English translation of the Consent Form

Embassy requires this every year, prior to Biometrics

7. Medical Record

To certify that the child has no health issues and child OK to travel.

Needs a stamp from the Doctor and head of clinic

Only valid for 6 months so timing critical and needs to be done every year

8. Vaccination Certificate

Child has to provide a list of their vaccinations and if they are not appropriately vaccinated they are not allowed to travel.

 Medical consent form –for the child to receive treatment in UK – signed by parent (NB Take these forms on days out – required if the child needs to go to hospital)
 Ditto weekend visits

If a child is admitted to hospital – Interpreter and Coordinator to inform Mike Cowan.

Full list of the travelling children with consents, needs to be signed by Shaparov – at the Ministry

Humanitarian Aid Department stamps it too.

Katya brings the appropriate list to each departing bus and meets all the kids the off the bus too. Interpreter needs to write an official report within 10 days of what happened on the visit. If the Belarus office has an inspection/audit all the documents need to be in the file, especially the stamped list.

Also need to send the stamped list to book the flight with Belavia (or the price of the flight is more expensive!)

TEAM IN BELARUS (Volunteers) – Katya listed them all and the group acknowledged the support of these regular volunteers.

Xmas parcels delivery – thanks for the donations.

HELPING HANDS PROJECTS that Katya has led in Belarus this year:

• Sergei. Visited UK once then was discovered to have cancer – Katya and team helped to take him back and forward to Minsk for treatment for 18 months. Not just functional support (transport

etc) but emotional support – gave him the determination to recover. Hopefully he will get the all clear later in March and come to UK again.

- West Lothian Group replaced the KITCHEN of one of the families whose child was on a list to go to the orphanage. Photos of the new kitchen before and after.
- One child bedwetting afraid to go outside to go to the toilet in the winter (dark, cold, dogs) Bought a portable toilet/commode to bring into the house. Child doesn't wet the bed now.
- Before and after fridge (Social services take child to orphanage it fridge so bad)
 Helped to get kids out of orphanage 31/12
 Gives courage/strength to mother

DBS Report - Olwyn Keogh

Visas don't happen without DBS Currently 1,500 registrations with DBS for our charity

If it's slow, usually down to Police Force checks

In recent years the Police forces that have been particularly slow are West Midlands in 2015, Metropolitan in 2016

DBS enables up to date police checks year to year - whereas CRB did NOT

The most common cause of a failed DBS is... failure to register the DBS application online

The "C" number is for the applicant ONLY – as coordinator, do not keep these.

Rest way to ensure online registration happens is to do it using the form number r

Best way to ensure online registration happens is to do it using the form number prior to sending off the form to Olwyn

Disregard annual reminder to pay £44 as there is no charge for volunteers

Other reasons to cause a DBS to fail:

Mistakes on form eg Dates – month and year only vs full date (only x2 places for full date)
Coordinator checks – make sure you cross all the boxes W59: Tick YES
Don't check the form yourself if it is for one of your relatives!
Tick volunteer (if not ticked you get charged £44)

Mike added: unsubscribed DBS's – if in the 10% checks that the visa office does, they find that we have an unregistered DBS, then they will be more rigorous with ALL our checks going forward which will make life more difficult.

Treasurer's Report (John Buckby)

Full report available and attached to minutes

3 years audited accounts presented as last 2 years not available at last conference in Oct 14 Visa fees £48,864 out of a total £144,828 income in 2015: JustGiving £26,578 included in that but that comes in, goes straight out.

Expenditure = Mogilev office £36,825 out of a total £127,612

Profit £5,972 in 2015

3 accounts – Natwest Current (Just Giving) Natwest Savings and Coop Current January is the lowest point of the year for cash.

Need substantial funds available/on hand in case of a serious accident/illness whilst a child in the UK

311 children and 42 interpreters forecast in 2016

Deficit forecast in 2016 = £6,334

3 options

- Income up charge groups more (no appetite for that)
- Reduce costs (costs are representative little/no opportunity to save)
- Do nothing

Decided to do nothing as there was a £6K profit last year Interpreters pay will remain as is in 2016.

JUSTGIVING

They charge 7% + admin fee of £18/month

Total charges for the last 3 years = £6,616

JUST GIVING ACCOUNT WILL BE CLOSED on 31st DECEMBER 2016 due to the charges

Replace with:

BT - MY DONATE COSTS

Do it from your local group – register separately

More than one account possible for different events

You have to register with HMRC Gift Aid to be able to set up

BUT they do charge a minimal Debit/Credit card fee per transaction to the charity

Gift Aid paid monthly.

Check whether BT MY DONATE has a text donation facility.

FOCC NEW website – Alison Shepherd – nearly ready to launch – please send Mike any local info.

Flights Coordinator's Report – David Palmer

Let David know whenever a group has an INCREASE and a DECREASE in numbers – really need to have finally confirmed numbers by end April (when the Biometrics completed)

Going home there is an allowance of 30kgs

Belavia very understanding

Xmas Day sponsored swim in the sea. Not recommended

Jane Hines - Monmouth

Theatre – cost £150 – showed a film at Christmas "It's a Wonderful Life"

£1,300 profit + Carol Singers

Charity Box in local Butcher raised £500

Moray/Forth Valley

Come Dine with Me – put in what you'd have paid to go out for dinner raised £700

Mike Cowan visited groups during the visits of 2015 & hopes to visit more groups in 2016. Moray - The Proclaimers (I'm gonna be (500 miles)) – Belarusian style.

Race Night – David Palmer & others Professional (or do it yourself) You can BUY a set for £30 £1500 - £2,000

Alternative - Pig Racing - bacon sandwiches at half time, charge entry and for an Owner, sponsors & betting

BLINGO

£10 ENTRY

Drink, bingo book – bring stuff to bling up the table (wine etc Bring your own wine Prize for the blingiest table $10 \times 10 = £1,000$

Rule in Belarus is that 5 +1 is the min group size Ideal min size is 10 7-8 OK

Private Visit Coordinator's Report (Cecilia)

54 private visits in 2015 incl 24 at Xmas39 booked for Summer 2016 espec through Manchester

Private Visits ratios
25 children + 1 interpreter

Deadlines

1st March

1st September

>18's

Apply in the same way

+ scanned copies of host's passports

Invitation letter – needs to mention how they know the child

Recent Bank statement showing sufficient funds to afford the visit

Still require DBS

VISAS – same process as for children – also need the above info

Need to be 100% responsible that the "child" is returned to Belarus. Would reflect badly on the charity if they did not.

Also try to send on same timings as another group as those >18s perhaps not articulate enough to explain at customs WHY they are coming. Also to dress appropriately!

Experience of a New Group Coordinator

Tony & Linda Baldwin from Medway

Background:

Retired

Knew about Chernobyl Explosion

Were hosts for 2 years

Then existing coordinator resigned. Tony and Linda started Jan 2015, became official in March 2015.

Got a lot of support from Sheila Nash, regional support, met Mike.

Did some fundraising, organised a programme, used local magazine to raise profile

10 kids arrived

Child protection issues (Cecilia helped)

Ambulance – hospital avoided

Key message: you're not on your own - help is always available.

Went to Belarus in 2015 – which made a complete difference/inspired

Vision: 20 kids

Back up to 12 for 2016

Going to present to the Council later this month Trying to give supporting to the host families

Over-riding feeling is to be privileged

Safeguarding Officer's Report - Cecilia

Host Reference form + letter - PLEASE USE

Disclosure of a Child Protection Issue (focus on this has intensified from insurers since Jimmy Savile – eg need to keep any disclosures for 50 years)

We get few.

However they can come from UK side OR Belarussian side

Every group should have a local Safeguarding Officer and all hosts should know who that is.

Advise Mike/Cecilia ON THE DAY AN ISSUE IS RAISED

Avoid "trial by email"; seek advice early; consult safeguarding policy

Also if child **arrives** with signs of mistreatment – discover what it is, record it, discuss with coordinator immediately.

Good idea to do new host training every year.

Cover everything. Be proactive.

DO NOT let children have unsupervised access to the INTERNET

No access to FB or VK if child less than 13 years old.

Ear-piercing – guidance is NOT to have it done in UK

Days out - SAFETY

Group leader

Ratio 1:6

1st aider, 1st Aid Kit, Medical Records

Share phone numbers

Consider visiting venue in advance

Make provisions for the weather

Minimum x 2 adults on the minibus with 1 in the back

Booster seats for children <135cm

Children < 10 years always in the back of cars & put the child locks on. (Belarussian children not used to traffic)

Discussion on Minibus driving

Be aware of the conditions – including what the licence entitles you to do

Note now that paper licences now invalid insurance can require obtaining a number from the DVLA – which can slow down hiring a minibus.

Visits to Mogilev – Clare Cotton

2015, 10 groups went over

2016, 5 groups booked for March – 10 day window - more flexibility on dates, time – can book your own flights and doesn't necessarily need to be with Belavia.

Autumn visit date will be issued later in year.

There will be flexibility around this date, dates around then can be accommodated.

Visit date will be after beg Sept because before then, too much going on in Mogilev for the charity.

Coordinator's visit – can be delegated. Max 3 per group.

Forms have changed slightly

Information sheet is different – regulations have changed in Belarus and some of our arrangements have changed (eg accommodation.)

Now the Hotel Tourist \$15/ night – much cheaper than the apartments.

Final itinerary should be lodged with Mogilev office 48 hours before visit starts.

Katya made a point that you either visit on charity "business" (with an official charity invitation) OR as a "tourist" and the 2 purposes should not overlap as this causes issues – and the charity can get into trouble. If you do not go through the charity then you shouldn't visit charity children etc. All visitors need a DBS – Clare will add this to the form.

Since bilateral medical agreement has lapsed between UK and Belarus – need medical insurance – in fact insurance docs required when applying for visa.
