STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

THE DECLARATION OF TRUST was adopted by Congregational Federation Limited on the 13th day of June 2009 as a recommended governing document for Congregational Churches who are members of the Congregational Federation and for whom Congregational Federation Limited are appointed as holding trustees, the form having been previously agreed between Congregational Federation Limited and the Charity Commission and also having been approved by HM Revenue and Customs , and at shall henceforth be known as and referred to as the **APPROVED GOVERNING DOCUMENT**

OBJECTIVES AND ACTIVITIES

Who we are and how we work

Highbury Congregational Church began in 1827 and is an independent Church that is part of the Congregational Federation. While we work closely with other churches all we do is decided and funded by our own Church Members. We do not have any outside source of funding and we do not have any outside body over us. All who belong are welcomed into church membership on confession of faith in God and Jesus Christ as Lord and Saviour. Those Church Members meet together in the guarterly Church Meeting to seek the mind of Christ in shaping the life of the Church and setting the future direction of Church life. There is a team of six Ministry Leaders serving the Church: Andrea Lacey in Children's work, Mary Buchanan in Youth work, Jean Gregory in Mission and Outreach, Lorraine Gasside in Pastoral Care, from our AGM in 2017 Judi Marsh in Discipleship and Sharon Wallington in Worship. The Deacons serve the church as Managing Trustees and ensure all the Church does is in keeping with its aims as a Congregational Church and its responsibilities as a Charity with reference to finances, safeguarding, health and safety, disability, employment and other legislation. They are Iain MacLeod, Ted Horsfield, Darryl Mills, Janet Partington and Peter Harrison. Helen Roberts is on the Diaconate as Church Secretary and Roger Gregory as Treasurer. Richard Cleaves serves the whole Church as Minister. We are part of the Congregational Federation and are registered as a Charity 1159085. We have adopted the Congregational

Federation's Declaration of Trust as our Governing Document together with our own Working Practices document.

Our Objects and Vision

The principal purpose of our church as summed up in our foundation documents is 'the advancement of the Christian faith according to the principles and usages for the time being of Congregationalism'. We 'may also advance education, relieve need and carry out other charitable purposes in the UK and other parts of the world.' Our vision is that Highbury be a place to share Christian friendship, explore Christian faith and enter into Christian mission with Christ at the centre and open to all.

Our Aims for 2016

A year ago we set out our aims for 2016.

It has been a year with the Bible as a good number of people made use of Fresh From the Word, the IBRA Bible reading notes. Sunday services and Explore sessions were linked to the readings church members were sharing.

A highlight of the year was the involvement of Faith Taylor in our church life: her passion for mission and her faith made its impact in the short time she was with us.

The servery at the back of the church has made a world of difference to the fellowship that is such an important part of our worship. The new Café space and entrance to the hall means that our community facilities have been greatly enhanced.

It was good to be part of the first Christian Arts Festival and to continue to strengthen links with our immediate neighbourhood through our involvement in the Street Party to mark the Queen's 90th birthday.

We have continued to build up the involvement of people in our services as members of the congregation have shared insights, testimony and their own stories. Sunday Special has developed in a new way giving a different structure to our morning service on those Sundays with the children and young people joining us at the end of the service. It was good to receive communion from our children and young people. We have had a focus on the Persecuted Church and made links with Open Doors. We have made a start on the Congregational Federation's GIFT course on Sundays, at Explore and in day sessions with the SW Midlands Area of the Congregational Federation.

Benefitting People Through Church

As a registered charity we are obliged to demonstrate in our Annual Report that all we do is 'of public benefit'. As a church we exist for the benefit of other people: the detailed reports in this issue of Highbury News demonstrate the difference we make in so many different areas!

Pastoral Care is at the heart of all we do. Lorraine Gasside has once again supported all of us in the pastoral care we give to each other and the team of people who help focus on pastoral care. It was good to come together in two training sessions on Loneliness and Mental Health. Pastoral care happens as we get to know each other and so the many occasions we have had for meals together, theatre trips and all sorts of informal gatherings all make a big difference.

As soon as we have a concern and a 'care' for others there is a problem. We cannot do all we would like to do. That's where our **Worship** becomes so important. At the heart of all we do are our main services on a Sunday. Not only do they give us the opportunity to praise God and make connections between what's going on in the world and God's word in the bible, they also give us the strength to draw on when we come face to face with the fact that we cannot do all we would like to do. This year we have added to our Sunday services a regular monthly Messy Church. It's a different way of doing worship that brings people together for a meal, to do things around a theme that is then brought together in a short time of celebration. While aimed at involving young families it is for everyone and has proved a great way of building up our worship. Our thanks to Shirley Fiddimore for her three years as Ministry Leader for Worship and ten years arranging visiting preachers. Thanks too to Sharon Wallington who is going to take this role forward.

What sustains us individually and together in the commitment we have to share God's love with people around us in every way possible is our prayer and the way we look out for God's word for us in the Bible. In our **Discipleship** programme we have had three focus points this year. First and foremost it has been a year with the Bible, making use of the IBRA notes, Fresh from the Word in Sunday Services and at Explore. Our Explore evenings give us the opportunity to hear each other's stories, see things from each other's perspective and focus on particular things. We ran three short courses on Reading the Bible Together, on the Persecuted Church and made a start on the GIFT course aimed at Growing in Faith Together. And each month we have had a craft evening. Judi Marsh has played a key part in this and is now joining our Ministry leadership team to focus on developing discipleship. We have introduced our Book Space this year to enable people to recommend and share books they have found helpful in their faith.

Mission and Outreach has once again involved us with other people and in our own local community. Our Community Café, monthly lunch, Hy-Speed, our digital scalextric club, our family film club, our work with schools and with the local community through the Fairview Community Association's firework party: their walk around the area began at Highbury when we hosted a great time together. Thanks to Jean Gregory for her work in co-ordinating this work.

Our work with **children** has developed in different ways. While the numbers at Film Club and at Messy Church have grown, there have been occasions when we haven't had as many children and young people on a Sunday morning. This reflects a need to explore different ways of reaching out to children and families. Regular monthly Messy Church has been an important development this year. Thanks to Andrea Lacey who continues to develop this work. We hosted music classes for St John's school and their Infant nativity play. Our Open the Book team takes assemblies in Oakwood School and our Minister, Richard, assemblies in St John's School, Charlton Kings infants school and Belmont school. We hosted Christmas services for Belmont, Pittville Year 7's and St John's.

Our work with **young people** continues to focus on Hy-Tec on Sunday evenings and Cooler on Sunday mornings. Mary Buchanan is our Youth Ministry Leader – we are indebted to the team of leaders and helpers who make it all work. A highlight of the year was the four months Faith Taylor shared with us at the beginning of the year.

Benefitting People in our Community

With the closure of most of the secular venues in Cheltenham Highbury is one of many churches who provide space for the use of the community: our rooms are extensively used by different community groups both on a regular and an occasional basis. This year we have invested a substantial legacy in enhancing our premises for use by the community, creating an attractive entrance and foyer for the hall, together with a large café space that in the summer will open on to a lawn.

A number of groups provide *care and support* to particular groups of people: the Highbury Club for those with visual impairments is currently looking for a new leader, Narcotics Anonymous, two Heart to Heart Exercise Groups, Slimming World an NHS motivational group and other occasional NHS groups. This year has seen the start of a Gamblers Anonymous group.

We host a number of *life-long learning* classes that enable people to study without working towards a qualification: with the University of the 3rd Age, two Bridge Classes, a Recorder Consort, an Art class and a History of Art class. We host a Lace-making class, the Carlton Lacemakers, and two upholstery classes. Two other Art classes continue to meet. For chidden and young people we host three music schools: Monkey Music for toddlers, another music school for Toddlers and a Rock School for young people. The Cheltenham Philharmonic Orchestra rehearses each week at Highbury and this year has seen the arrival of the Mid Life Choirsis Choir.

Among the *interest groups* that use our premises are the local NHS Retirement Group and the committee of Cheltenham's Horticultural Society. We are home to the 1st Cheltenham (Highbury) Scout Group, and the 11th Cheltenham Guide Group, and the 7th and 11th Cheltenham Brownie Groups. It was great to host the Beavers District Carol Service.

Benefitting People in the Local Community

Each week we collect two or three boxes of produce for County Community Projects' Foodshare foodbank. Each month we have a special collection for local charities, in 2016 supporting Gloucestershire Association for Refugees and Asylum Seekers, The Butterfly Garden a project for people of all ages dealing with disablement of every kind, Cheltenham Youth for Christ, Little Hearts Matter (the single ventricle heart condition charity), CreutzfeldtJacob Disease Support Network, Cheltenham Samaritans, St George's and St Vincent's Association providing care, support and independent living opportunities, Cheltenham Street Pastors, County Community Projects Hamper Scamper appeal putting together Christmas hampers in Cheltenham. Our Minister once again led the RNLI annual carol service on the GWR railway.

Benefitting People in the Wider World

To belong to one church is to belong to the one world-wide church of Jesus Christ. We continue to support work in the wider world too through prayer and through our giving. It has been the tenth year that we have supported Stefan and Birgit Küerle in their educational and care work in Brazil. We gave our Christmas collection to Children's Homes in Kerala State helping them to build up their self-sufficiency. At harvest we supported a Christian Aid partnership project in Ethiopia – healthier futures for women and girls, giving the proceeds from a visit of the Aber Valley Male Voice choir to that appeal. We continue to have links with churches in Israel and Palestine through the Kairos Palestine movement, a Scout group in Bethlehem and Embrace the Middle East. The Christingle Service when we welcome the Bethlehem Peace light is a highlight of the year and draws a lot of people, especially through Scouting and Guiding. This year we joined with Open Doors and Middle East Concern to support the persecuted church. We continued to support Moffatt, in prison in Zambia, and his daughter Cecilia in prayer and giving. We also supported the persecuted church through Middle East Concern. We have supported Operation Christmas-child's shoe-box appeal. We also gave support to other churches through the South West Midlands Area of the Congregational Federation, through the Congregational Federation's Ministry fund and through its Mission and Society Fund and the Council for World Mission. We once again supported the local response to the Syrian refugee crisis and have been involved in setting up Cheltenham Welcomes Refugees.

Our Vision and Aims for 2017

It is three years since we re-organised the life of our church, focusing on three main areas: *Renewal and Gifts, Personal Faith and Prayer, Mission and Outreach.* We have carried out a survey of those belonging to the

church at the beginning of 2017 which will form the basis for discussion at our Annual Meeting in March and help us shape our plans for the next three years. We plan to focus on *Giving for Growth* to build up the way we all give our talents, time and money in the work of the kingdom.

Independent Examiner's Report to the Trustees of Highbury Congregational Church
