117th Annual Report of the Council of the London Topographical Society for 2016

Our 116th Annual General Meeting was held on 6th July 2016 in the Great Hall of St. Bartholomew's Hospital, West Smithfield. It was well attended and after the formalities of the meeting there was a short talk by Society member Dorian Gerhold on his book *London Plotted: Plans of London buildings c.1450 - 1720*, the Society's 2016 publication.

Council meetings were held in January, April and September to discuss the Society's publications programme, membership, finances and general administration.

The Society's annual publication for 2016 (No. 178), as mentioned above, was *London Plotted: Plans of London buildings C. 1450 - 1720,* by Dorian Gerhold, in which he explains how and why London's tradition of ground plans arose, who the surveyors and their customers were and what the plans tell us about the buildings and their occupants. Most of the 197 plans had never previously been published and range from houses, large and small, to warehouses, wharves, industrial premises, markets, inns, company halls and so on.

During 2016 Council Members Denise Sylvester Carr and David Webb resigned for health reasons and three new members joined the Council: Dorian Gerhold, Peter Guillery and Dr Geoffrey Tyack. Sadly, Denise, a long-time member of the Society, died in September 2016.

The Society's total income for 2016 was £29,899 while expenditure came to £40,017. The deficit is the result of a decision by the Council to continue to reduce the size of the Society's reserves by making grants to suitable London-interest bodies

The Society made two grants this year: 1) £10,000 to the British Film Institute (BFI), the second of three annual grants, for digitisation and cataloguing of 15-20 short historical films about London which the BFI will produce, in conjunction with the LTS, as a DVD in 2017; and 2) £1756 to the London Metropolitan Archive (LMA) for assistance in conserving their Visscher 1616 Panorama.

During the year 57 new members joined the Society: at the end of 2016 there were 1237 paid-up members and four honorary members.

Our *Newsletter* was published in May (No 82) and November (No 83) and, for the first time, colour printing was used for illustrations which was well received by members.

Articles included: *Surveying the City: John Britton's London Topography 1820-40*, researched by Stephen Daniels reviewed by Aileen Reid; *London on Film at the British Film Institute* by Ellen McGuinnes and Mark Duguid; *Modern Living Framed by the Glory of Gas* by David Crawford; *Victuallers of White Street, Southwark* by David Elis-Williams; *The Park Villages and HS2* by Geoffrey Tyack; *The Survey of London in Whitechapel* by Peter Guillery, and; *Hidden in the corner of the map ... town vignettes on early maps and charts* by Peter Barber. There were several appeals for help with research, on topics ranging from medieval mayors to twentieth century film, testifying to the range of our interests and the high regard in which LTS members are held. As always, there were many excellent book reviews.
