# 2016 Report and Accounts for the Parochial Church Council of St Andrew's Church, Kinson

#### Aim and purposes

St Andrew's Parochial Church Council (PCC) has the responsibility of cooperating with the incumbent, the Reverend Lee Shirvill, in promoting in the ecclesiastical parish, the whole mission of the Church, pastoral, evangelistic, social and ecumenical. The PCC is also specifically responsible for the maintenance of the Church Centre complex of St Andrew's, Millhams Road, Bournemouth, BH10 7LN

#### **Objectives and Activities**

Towards the end of 2014, the PCC and members of the parish worked together to formulate a renewed mission and vision, which was launched in the Parish in February 2015:

#### Our Mission

We exist to worship, love and serve God; to be a generous church, sharing God's love with each other and the wider community, committed to prayer, fellowship and mission.

#### Our Vision:

#### We aim to be a Christ-centred, Spirit-led church, demonstrating the love of Jesus by:

- Growing and Nurturing disciples to become a worshipping community of 300 people by 2020
- Serving each other and the wider community
- Supporting Mission locally and globally

#### Our core biblical values:

- · We are committed to Prayer
- · We are committed to Biblical teaching
- We are committed to being God focused
- We are committed to Loving people and serving others
- We are committed to Meeting together as members of God's family
- We are committed to Forgiveness
- We are committed to Spiritual Growth
- · We are committed to Godly Servant Leadership
- We are committed to Stewardship
- We are committed to Evangelism

When planning our activities for the year, we have considered the Commission's guidance on public benefit and the supplementary guidance on charities for the advancement of religion. In particular, we try to enable ordinary people to live out their faith as part of our parish community through:

- Worship, prayer and small home groups; learning about the Gospel; and developing their knowledge and trust in Jesus.
- Provision of pastoral care for people living in the parish.
- Missionary and outreach work; including our commitment to our food bank, Lunch Club and Toddler Group
- Partnerships with local community groups, including the Kinson Business Forum and North Bournemouth Area Forum

To facilitate this work it is important that we maintain the fabric of the Church of St. Andrew's and the Church Centre Complex.

To that end, works are being planned, funding and faculties obtained and repairs carried out in a timely fashion - details outlined under heading *Church Building & Church Centre*.

#### Achievements and Performance

#### Team Rector's Report

Well even though our building works during 2016 were not on the same scale as the rebuilding of Jerusalem's walls, I am sure we are all thankful to God for the progress that has been made towards the restoration of St Andrew's Kinson.

Can I take this opportunity to thank the Churchwardens and members of our PCC for all they have done in supporting this work and for the generosity that came from within our own community that enabled the work to be completed.

Brian Phillips steps down as a Churchwarden in 2017. I am indebted to Brian for his diligence and, at times, patience (especially towards me) as we pushed forwards throughout 2016. In between weddings, funerals, baptisms, it took a great deal of organisation and persistence to keep thinks moving and I am very grateful to Brian for liaising with the various tradespeople along the way. Despite the occasional frazzled nerves, I was also incredibly grateful for the support and encouragement that came from the congregation and the wider community throughout the project.

With the final plastering being completed as I write this APCM report, I am feeling very confident that we will complete works on the church before our 2017 wedding season commences on 3 June. Our attention will then turn towards the Church Centre, so we can continue to offer a great facility for church and community use into the years ahead.

Despite the intensity of our focus towards the church building, last year was above all a wonderful year of celebrating together as the St Andrew's family. Rachel and I enjoyed attending the Lunch Club, Women's Fellowship and Toddler Group at certain key events throughout the year and what a wonderful day we enjoyed giving thanks for Her majesty Queen Elizabeth; wishing her as we did a very happy 90th birthday. The celebration service of thanksgiving on the 30th of November was a particular highlight for many of us I'm sure and a nice lead in to our Advent celebrations last year.

2016 was also an opportunity to start reflecting on our existing and potential ministries, with a view to entering a new year ready to embrace the God given opportunities ahead of us. Your PCC met for a Vision Day in January 2017, to discuss how we might keep a balance between maintaining our Trellis (buildings, structures, etc) and stepping out in faith; responding to the Great Commission and tending the Vine (focusing on those within the church family and those to whom God calls us to reach out).

As I said on Easter Sunday this year, Jesus wasn't just focused on converts when he gave his Great Commission - his exhortation was one of 'calling' and then 'nurturing' God's people that we might all grow in Christlikeness. Discipleship is not a time limited pursuit. Instead it is a lifelong journey of drawing closer to God and being open day by day to the work of the Holy Spirit in our lives. I hope that in seeking to be faithful in reaching the lost, we will never lose sight of our responsibility to love, nurture and grow those already in our church family as we Shepherd one another in Jesus name.

I recently attended a fantastic day hosted by the Diocese and our Patrons CPAS. The title of the day was *The Spiritual Life of the Leader*. It was an inspiring and uplifting day that gave me much to think about. I drove out to Dinton Hall on a beautiful Spring morning - if you take the back road the scenery is absolutely stunning - I really welcomed a day away, to reflect on how our spiritual disciplines can feed and underpin our leadership roles.

During the day, one quote from Henri Nouwen really spoke to me. He wrote:

It is not enough for leaders of the future to be moral people, well trained, eager to help their fellow human beings, and able to respond creatively to burning issues of their time. All of that is very valuable and important, but it is not the **heart** of Christian leadership.

The central question is: Are the leaders of the future truly men and women of God, people with an ardent desire to dwell in God's presence, to listen to God's voice, to look to God's beauty, to touch God's incarnate Word and to taste fully God's infinite goodness?

There's a part of me that agrees very strongly with leadership that is grounded in this way. The reality is however that I struggle to get a balance between the inner and outer life - 'doing' and 'achieving' is such a part of our Western Culture.

After spending time thinking about my own leadership I was also conscious how important Henri Nouwen's reminder is for all of us in the body of Christ. Though we may not realise it, we all exercise leadership through the way we influence one another.

So looking ahead to 2017, my prayer is that we will continue to discuss what it means to be a church in mission and as we seek to reach out to others in the Kinson and Northbourne areas, we will also be committed to encouraging one another in our spiritual life, as we grow together in the year ahead.

#### Team Vicar's Report

This time last year we were looking at the seeming unsurmountable prospect of having to raise £160,000 to replace the roof of the church centre but by God's grace and with a combination of local giving, grants from outside charities and our first ever Christmas Fair, we are only £7,000 short of the target having raised an amazing £153,550! The offer of a Diocesan loan whilst we raise the balance means that after years of waiting and unsuccessful repairs the church roof should be replaced this summer- Praise God!!! It's been truly amazing to see the way people from within the church community and beyond have all joined forces to make this a reality.

It has also been encouraging over this last year to see the relationships that are growing through the variety of groups that meet in the church centre and the transition of a small number to Sunday worship and our midweek life group. We continue to open the church centre to local community groups and the community café which had relocated here on a temporary basis last summer is now a regular fixture on a Wednesday morning.

We finished 2016 having once again having met our financial commitments, including our Parish share. We were also fortunate to have had some money in the Community Project so were able to employ a part time community worker. The position was on a year's contract which finished at the end of March '17. This has been a valuable time and we are truly grateful for the hard work from all involved. Many of the community project's activities have been running for a number of years and now seems like an ideal time for us to take stock of what we are doing as a church within the community, and to prayerfully discern how it fits into what we feel God calling us to do and be in the here and now with the people and resources that we have.

So as we look forward with anticipation to all that is yet to be and what God has planned for the future, we can look back with thanks for this past year. So much has been achieved in particular raising the profile of the church within our local community, getting on top of our finances and raising the money to fix the roof. I believe that all this is a stepping stone and foundational to where we go from here and what God has planned for the future at St. Philip's... and we can know that, with God, it's going to be good!

# Fabric (Buildings) Report

During the past year we have completed much, for which we truly thank our Lord God. Work in the church has progressed very well – we have now fitted replacement carpet in the chancel area, wood flooring in the nave and an alarm system. The organ had to be moved to allow the laying of the new floor so we used this opportunity to service and retune the organ. The final phase of the plastering (vestry, chancel and arch) has now started (March 2017); as has the window refurbishment, fitting of new security grilles to the windows, and supply and fitting of a replacement Church outer door. Externally the rainwater drains have been checked and cleared of roots, and external drainage trenches are being installed around the church building.

Work on refurbishment of the Centre has recently started. We have had the flat roof felt replaced with better material and added extra rainwater drainage ducts. Work is ongoing with the installation of the gents and ladies toilets.

Unfortunately we were the victims of two break-ins and theft from the garden store. We have now installed a steel reinforcing plate to the outside of the door.

As always, I am very grateful to members of the Building Committee who have given up their time throughout the year attending meetings and carrying out numerous behind-the-scenes work projects whenever the need arises. "Thank you" Dave, Colin, David and Richard, and, although not on the Committee, to John Hull for his assistance with a number of projects.

# Worship & Prayer

The PCC is keen to offer a range of services during the week and over the course of the year, that our community find both beneficial and spiritually fulfilling. For example, prayer days and mid-week Communion provide a quiet, intimate and reflective environment for worship whilst opportunities are provided for people to engage in more contemporary worship such as that provided by our corporate gatherings on Sunday at 9:30am.

This year we have been successful in welcoming more families into our church on Sunday mornings. In addition to our Sunday gatherings, Messy Church also enables us to welcome new families to St Andrew's every month that would not otherwise be part of our church community.

All are welcome to attend our regular services. At the time of writing this report there are 118 parishioners on the Church Electoral Roll, 37 of whom are not resident within the parish. 9 names were added during the year and 3 removed either through death or because they moved away from the parish. The average weekly Sunday attendance, counted during October, was 85, but this number increased at festivals over Easter (129) and Christmas services (329) across 24th & 25th of December.

As well as our regular services, we enable our community to celebrate and thank God at the milestones that mark our journey through life. Through baptism we thank God for the gift of life, in marriage public vows are exchanged with God's blessing and through funeral services friends and family express their grief and give thanks for the life which is now complete in this world and to commend the person into God's keeping. We have celebrated 7 baptisms, 9 weddings and held 16 funerals in our church this year and were responsible for conducting 5 services at a crematorium.

# **Pastoral Care**

Some members of our parish are unable to attend church due to sickness or infirmity. Reverend Lee, with the support of LLM Lesley Blythe and our team of LPA's have visited all church members who have requested it to offer prayer support and communion at their home or in hospital. St Andrew's is blessed to have 5 Lay Pastoral Assistants and 1 Licensed Lay Minister, who share in the pastoral care of members of the church family as needed.

Monthly Lay led Services continue to be held at Summerhayes residential home in Kinson and Templeman residential home in Northbourne.

### **Deanery Synod**

Two members of the PCC sit on the deanery synod. This provides the PCC with an important link between the parish and the wider structures of the church.

#### **Mission & Evangelism**

Helping those in need is a demonstration of our faith. To that end we continue to be committed to serving local members of our community experiencing financial hardship. Our Foodbank, operated in association with Trussell Trust continues to meet the needs of local families and has given out a total of 15,737 meals during 2016.

We are also committed to supporting those who a called to share the good news in places beyond our local community. From our funds raised in 2016, we have committed £1,000 to the CPAS 'Ventures' programme to assist them in their ministry to children aged 8-18. £500 to the Dorset Historic Churches Trust in lieu of us missing the Ride and Stride! We have also committed £2,000 to CMS in support of Alan and Lex, who commence their overseas assignment in the latter half of 2017.

#### The Church Building & Church Centre

We are very excited that we are now able to open our historic church throughout the week for private prayer and reflection. The church is also now used every Sunday for corporate worship, thanks to the generosity of church members, community supporters, Erskine Muton, the Dorset Historic Churches Trust and The Talbot Village Trust.

Restoration was conducted throughout the latter half of 2016 which has seen the majority of crumbling plastering restored, new oak flooring laid, complete re-installation of new central heating system including two new boilers, new electrics laid throughout and new audio and visual equipment installed.

Further funding and generous donations mean that we can complete the restoration process in 2017 with windows repaired, new external doors fitted and trenching to provide a dry zone around the perimeter of the church.

The kitchen in the Church Centre continues to meet stringent health and safety requirements and allows us to continue the weekly Lunch Club for over 55's. 66 people regularly attend at our luncheon club, 17 of whom are parishioners.

During the week the Centre is used by our toddlers group on Mondays and Wednesdays during school term. Up to 20 children and their carers have been regular attenders throughout 2015.

There is now funding in place to make good the Church Centre Complex roof in 2017 and attend to other improvements, including the upgrade of our public toilets and provision for more storage in meeting room two and the Venue.

#### **Financial Review**

The 2016 financial year for St Andrew's has been characterised by another year of significant blessing. I rejoice that God has continued to supply all of our monetary needs and has enabled us to do huge amounts in terms of ministry and in terms of building work, principally in the main church building. All of this work would not have been possible without the ongoing support of those who very generously give on a regular basis through our Sunday offerings, through payments direct to the bank and through the Gift Aid rebates that we receive from HMRC. Additionally, we have also been very generously supported by

various donations from external parties such as the Erskine Muton Fund, Talbot Village Trust and the Dorset Historic Churches Trust, to name but a few. To coin a phrase from St Paul, "Again I say, rejoice!"

The audited year-end accounts are contained within the wider report and they supply the high level picture of St Andrew's financial position. However, I would like to highlight a number of key points:

- 2016 year-end shows a deficit of £14,559 compared to a surplus of £14,136 for 2015. However, the 2016 figure has arisen as a result of some £30,000 of our own funds that we have spent on the church refurbishment project. All of these expenditures were discussed in detail at PCC and have contributed to the superb state that the building is now in.
- Overall income for 2016 from direct giving, our principal source, was £40,725, marginally up on the 2015 figure of £40,555 but in the current economic climate this is very encouraging.
- Overall expenditure for 2016 is virtually twice that in 2015, £242,397 against £121,552, however, when the church refurbishment costs are removed from these figures, the figure shows a reduction on 2015, this arises mainly from savings on administrative costs.
- Once again in 2016, St Andrew's paid its Parish share of £42,785 (up 21.2% from £35,290 in 2015) in full. We continue to pay this contribution to diocesan expenses monthly by direct debit, which is very good for the diocese's cash flow.

The PCC Finance Committee meets regularly to carefully monitor all financial matters facing the church and they diligently scrutinise the flow of funds into and out of the parish's bank accounts. The committee then reports monthly to PCC as to our financial position and highlights any matters for their consideration and oversight. New procedures have also been put in place to enable groups such as Lunch Club, Messy Church and the Food Bank to manage short term cash expenditure in an easy and controlled fashion.

Finally, in my first report as incoming Treasurer, I must firstly record, on behalf of the PCC and the church as whole, our debt of gratitude to Sarah Davis who stepped down as Treasurer at the end of 2016. She has worked tirelessly over the last few years to ensure that the finances of St Andrew's, over her time in the role, have been turned around from a very precarious state to one of stability and good health. This has not been an easy task and for this we should all be very grateful. Secondly, I must also record my thanks for the very hard work put in by two other stalwarts of the finance team; Terry Cockerill who dutifully counts and banks all the money that is paid in from the various sources and Janette Rich who diligently records every transaction we make as a church and who manages the payment of all of our bills. Their contribution to the successful management of our finances is immense and again we should all be very grateful.

My prayer is that our good and gracious Lord continues to bless us with the resources we need to meet our commitments and to continue to promote the work of the Kingdom in this community and in the wider world. I also pray that he will continue to give the finance team and the PCC the wisdom required to be good stewards of that which he has entrusted to us.

### **Reserving policy**

As at the end of 2016 our main bank accounts had the following balances:

Additionally, there is our reserve account at Lloyds bank which at the year-end had a balance of £4,691. As indicated in last year's Treasurer's report it is the PCC declared policy to hold a reserve balance of 3 times our parish share which, at 2017 share levels, would equate to £11,408. This means that currently we are £6,717 short of our intended level. The Finance committee and PCC are mindful of this and will work during 2017 to build this reserve to the intended level. However, during 2016 action on this has been made more difficult as we have been experiencing significant difficulties with Lloyds Bank accessing these funds. This issue is now nearly resolved and the reserve fund will be transferred to another provider in the near future.

It is not the PCC's intention to accumulate funds for accumulation's sake, that is not appropriate, however, as good stewards of God's resources, it is necessary to exercise a degree of prudence and this is the sole purpose of this reserving policy.

Sarah Davis stepped down as Treasurer at end of 2016 and we thank her so much for the leadership, professionalism and commitment to a mission shaped, Christ-centred approach to overseeing our financial commitments during her tenure.

In addition to those who exercise leadership on the PCC and those who volunteer in the parish office, it would be impossible to connect with our community as we do were it not for the many volunteers who give up their time each week. From leading Bible Study Groups, keeping the churchyard in good order, assisting in various ways during Sunday worship, on sub-committees, volunteering at the Lunch Club, conducting services in local nursing homes, helping at Toddler Group, offering Pastoral Care and supporting the work of the Foodbank are just a few areas that rely heavily on volunteers.

There are too many people to name individually, but on behalf of the PCC we say 'thank you' and 'God bless you' for all you do in supporting the mission and ministry of St Andrew's, Kinson.

#### Structure, Governance and Management

The method of appointment of PCC members is set out in the Church Representation Rules. At St Andrew's the membership of the PCC consists of the incumbent (Team Rector), churchwardens and members elected by those members of the congregation who are on the electoral roll of the church. All those who attend our services are encouraged to register on the Electoral Roll and stand for election to the PCC.

The PCC members are responsible for collaboratively deciding on matters of general concern and importance to the parish including deciding on how the funds of the PCC are spent to advance and sustain mission and ministry.

The full PCC met six times during 2016 with an average level of attendance of 87.5%. Given its wide responsibilities the PCC has a number of committees dealing with a particular aspect of parish life.

These committees are responsible to the PCC and report back with minutes, which are received by the full PCC and discussed as necessary, considering and approving recommendations submitted. Sub-Committees currently meeting in the parish are: Worship Team, Buildings Committee, Pastoral Care Team (including LPA's), Finance & Stewardship Team, Messy Church Team, Foodbank Steering Committee.

#### Administrative Information

St Andrew's Church is situated in Millhams Road, Kinson, Bournemouth. It is part of the Diocese of Salisbury within the Church of England. The correspondence address is Church Centre, St Andrew's Church, Millhams Road, Bournemouth, BH10 7LN. The PCC is a body corporate (PCC Powers Measure 1956, Church Representation Rules 2006) and a charity currently registered with the Charity Commission.
