

Financial Review – Year Ending 31 December 2016

Funds have been provided mainly through various grants, donations, room hire and fundraising with unrestricted receipts of £9,919 and restricted of £20,615. The Wine Tasting, Summer Fair, Easter Egg raffle and Christmas Draw raised £713.

The total expended in the year was £13,492 of which £11,530 was from restricted funds. Running costs were £7,281, various minor repairs including extending the food bank and new signage cost £1,847 and small equipment costs were £46. Purchases of larger items of equipment including projector screen, printer, debt advice laptop and microphone totalled £526.

Our costs for events held in the centre, volunteers and for the various faith based resources used were £1,192.

Director's expenses are being paid in agreement with Diocese of York and totalled £990.

Expenses incurred for debt advice, Talkthru and client support (including food bank and fuel vouchers) was £1,610, most of which came from restricted income.

There was a surplus of income over expenses of £17,041 resulting in year end balances of £41,778 of which £14,570 restricted and £27,208 is unrestricted.

We have received a grant from NYCC which will enable us to employ a part time Centre Coordinator from January 2017.

Reserves Policy

The charity has set a policy of ensuring balances equivalent to approximately six months basic costs will be retained. At 31 December 2016 this is set at £9,000 unrestricted balances.

Welcome from the Chair of Trustees

Welcome to our 2016 Annual Report. I am pleased to tell you of another successful and rewarding year for Westway Open Arms – 2016 has seen growth, development and enriching of our Services and our relationships with our clients and the community of Eastfield.

This year we have supported 3,346 client attendances at Westway Open Arms.

In addition we have been very encouraged by the interest of local schools, and the children and family centre nursery, both in our charity work at Westway Open Arms and in the activities of the Church, and what we can offer them. For example 30 preschoolers from the Children and Families centre came to church with harvest produce for the food bank, sang 'cauliflowers fluffy' and decorated a harvest display for church and then in groups walked over to the food bank to hear a story about where their food donation goes and who it helps. It was also good because the staff were educated about food bank, and myths about it dissolved and they went away with facts. They came back at Christmas and put on a nativity play for parents. Overdale Primary School had a Christingle service in Church for pupils and parents. We now have a regular link each week with St. Georges School going into school alternate weeks; and the head teachers are now referring families in need to Westway Open Arms.

In October we enjoyed a great Volunteer Away Day for over 25 volunteers at Wydale Hall - a day of renewal and refreshment with Jackie and Graham Cray. We hope now to hold something similar each year.

This year also saw us make the important decision to take on our first employee in the important role of Centre Coordinator - this new development, which should start in the New Year of 2017, will release some of us for even more involvement with clients, and to take the good news out and really link Westway Open Arms, church and community more.

As always a huge thank you to trustees, volunteers, funders, supporters, and all who use the Centre. We have so much to thank God for and lots to be excited about for the future.

Key Achievements in 2016

DROP-IN SERVICES, SUPPORT & ACTIVITIES

The Drop-In Service and associated Activities had over 3000 Client attendances in 2016.

Regular daily and weekly activities included:

- Tuesdays and Thursdays being very popular with clients attending our arts and crafts sessions
- Wednesday free Lunch provided by Yorkshire Coast Homes went very well. A regular group
 of people gather for company as well as something to eat.
- Garden Project a small team from Scarborough Borough Parks and Gardens are leading the garden project, along with our own volunteers, encouraging clients to get involved. We got a grant to develop the space and add some seating and encourage the growing of produce, things that are easy to grow and look after.
- A quiet and confidential listening ear to anyone needing it, and signposting to any relevant service that may be needed.

Occasional activities and projects included:

- We held fitness classes in January, not too many came along, but for the few that did attend it's life giving.
- We also have other Agencies coming in to the Drop-In to provide access for people to schemes such as housing advice, smoking cessation, the 'Warmer winter' heating grant initiative, credit union.
- There is a possibility of developing a 'Mens-Shed' type drop-in for 2017.

CLIENT ADVICE & SUPPORT

Over past the year client support have interviewed, advised and assisted with several types of issue including: assistance with train/bus fares for hospital appointments, making phone calls on behalf of clients to the benefits office, attending medical assessments, making phone calls to various statutory and non-statutory agencies, signposting to appropriate agencies, arranging appointments with the local MP, acting as general advocates when required, and we also assist with gas/electricity top-up for those who are in an emergency situation.

The number of clients currently on file is 383. This number includes a mix of regular and new clients. On average the client support team interview and assist 5 clients per day = on average 20 per week, some weeks are busier than others. The client support team volunteers work Monday to Thursday from 10.0am to 2.00pm. The team currently consists of 5 volunteers.

When appropriate we refer clients to Horton Housing who continue to provide a valuable "drop-in" service every Wednesday morning. Yorkshire Coast Homes also provide a valuable service and are available to assist with housing issues.

We are currently seeking more volunteers to join the Client Support Team and praying that God will send the right people.

There have been several requests for help via SALT (Scarborough And Locals Together) and ACTS435 and we continue to signpost clients to Rainbow Money. Our grateful thanks go to SALT and ACTS435 who have sponsored many clients and provided mainly household items which would have otherwise been unaffordable, typical items purchased – washing machines, cookers, fridge freezers, carpets, school uniform.

Future plans

The main objective for 2017 is to recruit a possible two volunteers to the client support team.

To network with the Salvation Army with a view to work with them on a joint venture.

FOOD BANK

Regular requests for food parcels are ongoing. Our grateful thanks go to Morrison's and Proudfoots for their continuing support in housing our collection bins and to all churches and others who regularly donate food. We have recently received a large donation of food from the Lions and we are so grateful for their ongoing support.

Our grateful thanks go to the Yorkshire Building Society who very kindly held a Christmas food bank collection for Westway Open Arms at their Scarborough branch. Christmas food bags were given out to regular clients and, of course, those who presented who were in real need. Our grateful thanks go to SALT who very kindly donated £1,000 of Iceland vouchers some of which were used to help clients for Christmas and the remainder will be used throughout the year. Thank you to Tesco and Yorkshire Coast Homes for the chocolate and selection boxes which they kindly donated.

The total number of food parcels given out to clients since the opening of Westway Open Arms is 1223.

As always, we continue to interview each client to assess needs before distributing food.

DEBT ADVICE

We assisted over 30 people in dealing with debt issues.

The service was available most of the year on Thursdays generally by appointment between 9:30am and 2pm. This allows for administration work to be done following the appointment. All appointments were at Westway House.

Issues for clients varied considerably as do outcomes, including delaying actions being sought against clients, obtaining Debt Relief Orders, arranging payments against debts.

Key Funders/Donors

Yorkshire Bank - £400 to provide additional laptop ACTS435 – has helped a number of clients

Other Key Agencies Involved

Referrals received from various places including Family Outreach Worker, Client Support, Rainbow Centre, Stonham, Citizens Advice Bureau, Family Protection, and other clients.

Annual Data

We assisted 32 clients of which 25 were new in the year.

238 appointments were made of which 134 were attended. 13 people were seen without appointment. Average of 4-5 meetings per client.

The service was available over 48 weeks on Thursdays with between 1 and 3 volunteers. Average of 5-6 appointments made per week of which about 3 were attended.

User Feedback

We have received grateful thanks from many of the clients for the help they receive.

"thanks", "weight off my mind", "grateful", "sorted out" would be the general response from clients.

Future

One of our key volunteers will leave us late January. She has been an excellent advisor and will be greatly missed. We need to find another volunteer debt advisor.

There are no plans to change the service offering.

CHRISTIAN FAITH & SPIRITUALITY

This year, Westway Open Arms has seen encouraging growth and development in Christian faith and spirituality, with many people being comforted, supported and enthused by Christianity and the Christian family.

There have been many well attended, regular activities both within the centre and out in the community. These have included:

- Our regular monthly Sunday @ 4 service, which has consistent attendance and a great team of people looking after the running of it each month.
- Christmas Labyrinth and services were very well attended. We tried new services this year and felt encouraged with the outcome.
- During Lent we offered a 'Faith Through Film' course, showing 'Nooma' short films which facilitated people being able to explore easter related themes.
- The Lent Labyrinth ran again at Moss Lea Farm, attracting people from across the town.
 Easter Sunday 'Rising of the Son' service on the North Bay beach attracted a congregation of 70 at 6am!
- Running the 'Grace' Course after Easter and the 'Just 10' DVD course with J.John gave further opportunity for people to explore aspects of the Christian faith related to God's grace and biblical promises
- Connections between clients at Westway Open Arms and Holy Nativity church have continued to thrive. Those who have accessed services at Westway Open Arms, such as the Yorkshire Coast Homes lunch, have been getting involved with church and centre activities. This fosters positive building of community relationships in terms of local residents with each other, the community and the church and the service of the church and centre to the community. For instance, the connections that we have with baptism families and local funerals to both activities in the centre and Church services.

We would very much like to thank all of the volunteers who have shown such commitment and involvement this year. We continue to be very grateful to Mike and Josie who generously donate the beautiful facilities at Moss Lea Farm for our Easter Labyrinth. We are faithfully supported by Rob and Helen in catering for various events, and very grateful to Morrisons, Tesco and Proudfoots for their generous donations of refreshments which support many community outreach events.

TALKTHRU PREGNANCY ADVICE & SUPPORT

Talkthru has successfully supported a number of young women this year in their coping with pregnancy, specifically in their need of special items for their new babies.

Thankyou goes to all the Team who continue to offer their time to Talkthru, and supported people so well.

As reported at the September Board Meeting this Service has now developed into one of practical support (baby supplies etc) rather than specific pregnancy crisis support, with some of the issues being more of family support and adequately dealt with already through our Client Support Service. Therefore the decision has been taken that the Talkthru Pregnancy Support Service will not be continuing at Westway Open Arms beyond 2016. We will continue to offer baby supplies to those who require them.

Thanks go to all the Advisors who over the years have given of their time and service.

RECEPTION & CENTRE SUPPORT

The Clients, Volunteers and Visitors to Westway Open Arms have all been given a warm welcome and hospitality by our team of Reception and Centre Support Volunteers.

In addition our maintenance and IT team continued to do an excellent job with maintaining the building and facilities and also supported our IT system and security.

This year also saw the creation of a new food bank room which was very much needed as we had outgrown the previous one.

PAT Testing was successfully carried out in December with no significant problems arising.

Purchases of larger items of equipment including projector screen, printer, debt advice laptop and microphone totalled £526.

Our costs for events held in the centre, volunteers and for the various faith based resources used were £1,192.

Director's expenses are being paid in agreement with Diocese of York and totalled £990.

Expenses incurred for debt advice, Talkthru and client support (including food bank and fuel vouchers) was £1,610, most of which came from restricted income.

There was a surplus of income over expenses of £17,041 resulting in year end balances of £41,778 of which £14,570 restricted and £27,208 is unrestricted.

We have received a grant from NYCC which will enable us to employ a part time Centre Coordinator from January 2017.

Reserves Policy

The charity has set a policy of ensuring balances equivalent to approximately six months basic costs will be retained. At 31 December 2016 this is set at £9,000 unrestricted balances.
