Preface:

- Ben Balaam appointed to the role of British Scouting Overseas - Area Treasurer on 5th September 2014.
- The accounts has been collated and recorded from income and expenditure which has been notified/received during the accounting year.
- All accounts are held in the one bank account and no cash or cheques are held outside of this
 - Active Account - British Scouting Overseas – Community Account with Barclays Bank.
- The fund holdings are split into five categories, however the fifth has no holdings thus only four main fund holdings:
 - Unrestricted Funds
 - Open for general operational usage
 - No account funds are currently held in cash, only within Bank Account
 - Designated Funds
 - Designated only in that they are funds held in BSO account for Middle East District, Rest of World District, future Jamboree support and potential expenses
 - There are no accountancy restrictions in the application of these funds and thus pending Executive agreement can be re-accounted, if necessary, unrestricted.
 - Reserved Funds for TSA Membership Fees
 - These are transfer funds only transferred through the BSO account for ease of The Scout Association's collection process and thus only recorded to agree with BSO bank statements.
 - These are The Scout Association's funds and would be referenced accordingly in TSA's accounts.
 - These cover Headquarters collected fund receipts for Capitation and Jamboree payments and do not contribute to or influence BSO primary accounting records, in accord.
 - Note: Within 2015/16 accounts funds are recorded collected and held over into 2016/17 accounts at which time when all collections complete, the portion for HQ Membership Fees will be transferred and the Member Fees for BSO & Relevant District (Middle East or Rest of The World) will be apportioned in accord.
 - Restricted Funds – POACHER 2017
 - BSO Account includes collection of attendance fees from participants and stage payment of funds at appropriate times to Poacher-2017 event organisers for BSO Unit attendance.
 - Endowment Funds
 - No funds held by BSO in this type of account.

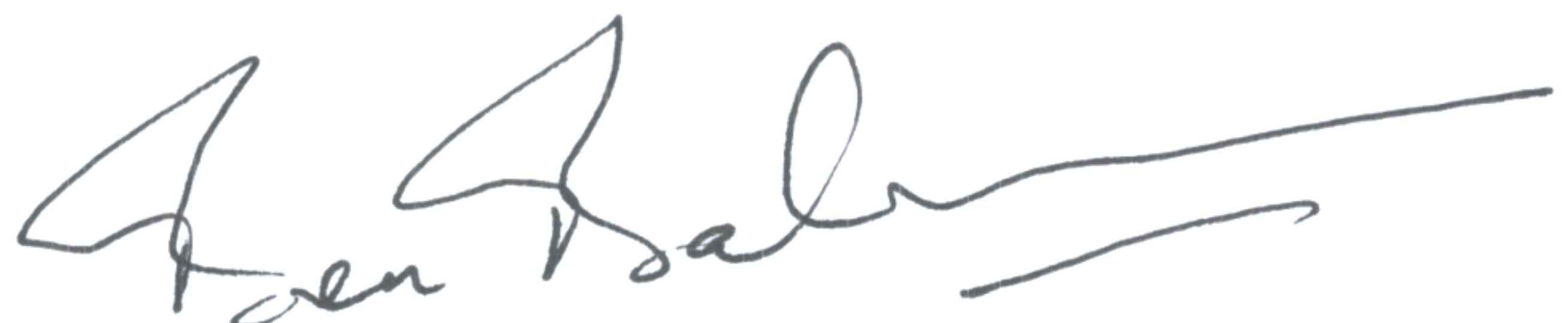

Independent Examiner's Report to the Trustees of the

BRITISH SCOUTING OVERSEAS AREA SCOUT COUNCIL

I report on the accounts of the Area for the year ended on 31st March 2016, which comprise the Statement of Financial Activities, the Balance Sheet and related notes set out on pages 3 to 5 of the BSO Accounts Report.

This report is made solely to the trustees in accordance with Section 145 of the Charities Act 2011. My work has been undertaken so that I might state to the charity's trustees those matters I am required to state to them in an Independent Examiner's report and for no other purpose. To the fullest extent permitted by law, I do not accept or assume responsibility to anyone other than the charity and the charity's trustees for my examination work.

Respective responsibilities of Trustees and Examiner

The Group's/District's trustees are responsible for the preparation of the accounts. They consider that an audit is not required for this year (under Section 144 of the Charities Act 2011 (the Charities Act)) and that an independent examination is needed.

It is my responsibility to:

- Examine the accounts (under Section 145 of the Charities Act);
- To follow the procedures laid down in the General Directions given by the Charity Commissioners (under Section 145(5)(b) of the Charities Act); and
- To state whether particular matters have come to my attention.

Basis of Independent Examiner's report

My examination was carried out in accordance with the General Directions given by the Charity Commissioners. An examination includes a review of the accounting records kept by the Group/District and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeking explanations from you as trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently no opinion is given as to whether the accounts present a 'true and fair' view and the report is limited to those matters set out in the statement below.

WELCOME TO THE ANNUAL REVIEW OF BRITISH SCOUTING OVERSEAS



British Scouting Overseas (BSO) provides the UK Scouting programme to young people (generally UK citizens) currently living outside the UK. We have around 3,500 members, of many different nationalities, in 53 Groups in 26 different countries throughout the world.

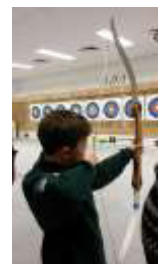
BSO enables a young person (or indeed adult) to begin a Scouting “career” in the UK, move overseas for a period of time and return to the UK (or indeed live for extended periods overseas) and have programme continuity towards their awards and training.

BSO is structured into four Districts (Northern Europe; France and Iberia; Middle East; and Rest of the World), supported by a small Area Team, the UK International Commissioner and the International Office of The UK Scout Association (TSA). BSO is part of TSA and provides the same 6-25 year programme and adult support as would any UK based Area or County. Being remote from UK Scouting brings a number of challenges but our leaders and adult supporters are committed and work hard to make sure young people are able to enjoy the very best that Scouting has to offer.



The Area continues to grow. BSO celebrated its fifth birthday in April 2017 and the growth in Groups and members has been impressive. As more people have become aware of BSO, the interest in setting up new Groups has increased and rarely a month goes by without a couple of enquiries. Of course, growth is largely down to the exciting and imaginative programmes enabled by our talented leaders.

Groups have expanded and new Groups and Sections have opened: more are planned, in some cases in new countries. We continue to develop good working relationships with host country national associations, to forge Scouting links and to work in partnership to develop programme initiatives. We also have regular discussion with our sister organisation Girlguiding BGIFC (British Guides in foreign countries) as we often face similar operating challenges and a shared approach is often helpful.



During 2016 a Communications Team was appointed to develop and improve BSO communications - Improving communications and the increasing use of social media are helping to develop awareness of BSO, and we are often contacted by people moving abroad to continue with their Scouting. Communication remains one of the biggest challenges for the Area – the use of technology is helping but we still need to work harder to engage with all of our members. Welcome to Branca Pegado - Communications Manager (Team Leader); Liam Mendes - Communication Manager (Engagement); and Eddie Aspden - Communications Manager (Technical).

Once again, many of our leaders have been recognised for their contribution to Scouting. All of these are thoroughly deserved and represent the great work our leaders do.

Young people continue to excel in what they do and congratulations to all who have achieved their Chief Scout's Awards, Queen's Scout Awards and Duke of Edinburgh's Awards – well done for your hard work. It is great to see all of our young people having a fantastic time, taking part in a wide range of activities in sometimes unusual locations. Well done and thank you also to all of the leaders who have guided and supported our young people in reaching their goals.



It has been notable this year that our young people and leaders have taken part in an increasing number of group camps and adventurous activities. Congratulations are due especially to each of the DCs and their teams for encouraging and organising a number of district-wide activities which have helped develop a sense of identity and enabled leaders to work together and learn from each other. Where groups are based is proving to be less of a barrier as events and competitions are coordinated to take place across the District and Area though not necessarily in the same time zone or on the same continent!

One of the big issues faced by BSO is being able to effectively deliver adult support and training. Not only are we challenged by geography but we also have to contend with around a 12 hour time difference across the BSO Area.

We have been developing the use of online delivery which is proving successful and over the year webinars have been delivered on Safeguarding by Debbie Philips (Deputy AC) and a number of training modules by Rikki Bilverstone (ATM).

In addition, the Programme Team at Gilwell delivered a BSO specific Programme Forum (which have been delivered regionally in the UK) looking at Quality Programme, Developing Skills, Inspiring World, Developing Peer Leadership in Beaver Scouts, Cub Scouts and Scouts, Outdoor and Adventure. Many BSO leaders across the world joined the webinars.



This is proving a highly effective way of engaging with leaders and young people and more use will be made of the technology.



A significant challenge for everyone this year has been developing and implementing a practical disclosure process for BSO. It is right and proper that all adults working with young people undertake the appropriate suitability checks but agreeing and making work a system with over 20 different processes and with a paper-based and online mixture of approaches it has been a huge effort to bring compliance up to acceptable levels. I am hugely grateful to David Bull, our Area Secretary; Rachel Davidson and Helen Church from the Membership Services Team at Gilwell for all their hard work in developing the processes, and to the DCs, who have been heroic in their efforts and endured endless emails from and conversations with me to manage the backlog.

The geographical spread of BSO means that extensive use is made of video conferencing. Whilst this is an excellent way to hold regular meetings, it is no substitute for meeting face to face and it was really exciting to be able to physically meet with all of the DCs together in March 2017.

BSO is a team effort. I am truly grateful for the support I have been given and my particular thanks to the District Commissioners, Area Team, Area Executive, Jack Maxton, International Commissioner, and the International Team at Gilwell Park.



Most of all I am especially grateful to and proud of all of the leaders and supporters in BSO – thank you for everything you do.

Development Plan 2017-2022

THEME: YOUTH SHAPED

The nature and demographics of BSO means that the age profile is skewed younger than the rest of TSA. However, it is appropriate that the emphasis of the ongoing national strategies is reflected in this strategy to better engage with young people to shape the delivery of BSO scouting. It is important to try to avoid "token" appointments; it will be essential that there are meaningful and outcome focused roles and programmes, and that appointed YCs are involved in key decision making processes. Every young person should be able to shape their Scouting experience and we empower our adult volunteers to make this a reality at every level; Scouting is for young people and they are our reason to be. If we empower young people to drive decision-making this will stimulate new thinking

THEME: COMMUNITY IMPACT

BSO Scouting aims to make a positive impact on the local communities in which we operate. It is important to have excellent, transparent working relationships with host country NSOs and host country local groups and to engage, wherever possible, with local communities.

THEME: ADULT SUPPORT

The geographical spread of BSO creates challenges to best support adults. Imaginative and flexible use of technology helps maintain contact to isolated leaders; this needs to be continually developed. It is right and proper that young people can enjoy exciting Scouting safely and Leader training is a key aspect to ensuring high quality activities.

THEME: INCLUSIVITY

Every young person deserves the opportunity to take part in Scouting and BSO is working to identify and, where necessary, remove barriers to participation. BSO membership will be reflective of the wider expatriate society regardless of their ability, faith, gender, background or financial circumstances. Although the broad principle of BSO is to provide the UK Scout Programme for UK ex-pats, membership is open to all nationalities (other than, with some exceptions, host country nationals). In some areas, local circumstances require care in providing co-educational scouting and in some cases it is more appropriate that arrangements are in place to support both BGIFC & BSO.

THEME: COMMUNICATION

Effective communication is a challenge for BSO. There are numerous communication channels which need to be used effectively to engage with BSO membership, to enable young people and supporters to have access to and be able to contribute to discussions and decisions which affect them.

THEME: ENGAGEMENT

Although BSO is an Area of the UK Scout Association and takes an active part in national programmes, it does have to operate in a flexible way in order to comply with UK based requirements and to provide the best opportunities for young people. There is, in some areas of TSA, limited awareness of BSO and it is important to engage with other parts of TSA to make sure BSO's needs are taken into account.

THEME: GROWTH

In many respects growth for BSO is opportunistic rather than something that is specifically sought. The global and national economies can significantly affect the presence & scale of ex-pat communities. In addition, the geographic spread makes the UK style approach of growth development & support impractical and there is limited capacity to support un-managed growth. Nevertheless, it is considered that there are opportunities for planned growth, in particular with International Schools.

THEME: GOVERNANCE

Because BSO operates throughout the world, local legislation and regulation means that a flexible approach to the management and administration of Groups and Districts is required. BSO needs to develop the Executive role across the whole Area and to understand where there are variations to POR and why these are in place. The role of the Executive is often overlooked but for BSO it is important to ensure that there is awareness and management of governance arrangements which differ from normal.

Also included here is data management. There is currently (Sept 2016) considerable lack of confidence in Compass data. It is important to try to rebuild faith in the system and to make sure the record data is correct.

AREA EXECUTIVE COMMITTEE

1. The purpose and objective of the Area Scout Council are those of The Scout Association, based on the Values of Scouting and using the Scout Method:

Scouting exists to actively engage and support young people in their personal development, empowering them to make a positive contribution to society

2. The Area meets the Charity Commission's public benefit criteria under both the advancement of education and the advancement of citizenship or community development headings.

3. The Area is a trust established under its rules which are common to all units of The Scout Association.

4. The Area Executive Committee exists to support the Area Commissioner in meeting the responsibilities of that appointment and to provide support for Scouting in British Scouting Overseas. More information is contained in the Area's governing documents: the Royal Charter, which gives authority to the Policy, Organisation and Rules of The Scout Association, and the Area Constitution (approved in 2012).

5. The members of the Executive Committee are the charity trustees of the Area Scout Council which is an educational charity. As charity trustees they are responsible for complying with legislation applicable to charities. This includes registration, keeping proper accounts and making returns to the Charity Commission as appropriate.

7. Advice and Consultation

The principal adviser to the Committee is the Area Commissioner, with his team. We are also advised by the Committee's officers and by staff at the UK Headquarters of The Scout Association.

The Committee secures professional advice when needed – none was used during 2016/17.

8. Finances

We regularly monitor the levels of bank balances and the interest rates received to ensure the District obtains maximum value and income from its banking arrangements.

The Area does not have sufficient funds to invest in longer term investments. The Area has therefore adopted a risk averse strategy to the investment of its funds. All funds are held in cash using Barclays Bank plc.

The Area is recognised as a charity by HM Revenue and Customs.

9. Risk Management

The Area has in place systems of internal controls that are designed to provide reasonable assurance against material mismanagement or loss, these include two signatories for all payments and insurance policies to ensure that insurable risks are covered.

The Committee maintains a risk register, which is under regular review; safety and risk management issues remain one of the Committee's priorities.

10. Reserves

The Area's policy on reserves is to hold sufficient resources to continue the charitable activities of the group should income and fundraising activities fall short. The Area Executive Committee considers that the Area should hold a sum equivalent to 6 months running costs, circa £3,000.

11. The Committee's Work in 2016/17

We have met regularly online and by telephone conference in order to review and direct the business affairs of the Area. Our thanks to all our members for taking on these duties. In particular, our thanks to Malcom White who served as Area Chair until business commitments prevented him from continuing.

During the year, BSO's Communications Team began its work and the members of the team published their plan of work. They have already set up Office 365 for BSO and renewed the BSO web site.

Other areas of particular concern for the Committee have been compliance with safeguarding regulations and the implementation of Compass (our membership database).
