## Treasurer's Report for the year to 31st December 2016

During the year under review the giving has been slightly down on last year, despite more people setting up standing orders and letting their Bank do the remembering for them. Gift Aid is slightly up thanks to the hard work of our Gift Aid officer. He has made an application to HMRC each quarter which has made it easier to make regular payments to the Leeds Board of Finance (Parish Share). There has been an increase in fund raising events. It has been evident that some of the people attending fund raising events are not regular worshipers at Church. The additional money has not come from the same source year after year.

During the past year your Church hast been used for non Church activities. Due to the closing of the Oakwell Motel, the Church has been able to welcome the Oakwell Art Group and the monthly Coffee Morning hosted by High Ridings, the travel agents. In addition the Church has been used for regular meetings by the Birstall and Birkenshaw Councillors. Again this is revenue which does not come from regular worshippers.

On the expenditure side, there have been modest increases in Insurance and electricity has been put on direct debit. The Architect recommended that the central heating be kept on for longer periods to preserve the fabric of the building. The longer period has not increased the gas usage a great deal and the increase in cost is quite modest.

The Church has once again been able to pay its obligation to the Diocese in full. The final payment was made in November. In closing I would like to thank Alan Graves for auditing the Accounts and the way he has handled the Gift Aid.

I am sorry to be stepping down as Treasurer, but the state of my eyes has made the job a bind rather than a challenge. I wish my successor well, doing a most satisfying and useful job.

# Independent Examiners Report to the PCC of Birstall Parish Church

This report on the Financial Statements of the PCC for the year ended 31st December, 2016, which are set out on the attached pages is in respect of an examination carried out in accordance with the Church Accounting Regulations 2006 ("the Regulations") and section 43 of the Charities Act 1993 ("the Act").

### Respective responsibilities of the PCC and the Examiner

As members of the PCC you are responsible for the preparation of the Financial Statements. You consider that the audit requirement of the Regulations and section 43(2) of the Act do not apply. It is my responsibility to issue this report on those Financial Statements in accordance with the terms of the Regulations.

#### Basis of this Report

My examination was carried out in accordance with the General Directions given by the Charity Commission under section 43(7)(b) of the Act and to be found in the *Church Guidance*, 2006 edition, issued by the Finance Division of the Archbishops' Council. That examination includes a review of the accounting records kept by the PCC and a comparison of the accounts with those records. It also includes considering any unusual items or disclosures in the Financial Statements and seeking explanations from you as trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

#### VICAR'S REPORT

Paul began his report by saying that it seeded amazing that a whole year since he presented the concept drawings for the renewal of the kitchen, toilet and entrance at the West end of the church as a project for our 2020 celebrations. During the year the PCC has agreed to pursue this.

Normal church life continued with a few special things thrown in: a Royal Tea Party on June 12<sup>th</sup> to celebrate the Queen's ninetieth birthday; the events of June 16<sup>th</sup> with the attack on, and death of, our MP, Jo Cox.; the inception of Community Carol Singing in the Market Place; a commemorative pageant and service to mark one hundred years since the Battle of the Somme; a Ringers Association Carol Service pioneed by Revd Cindy Sheard, who has since transferred to Heckmondwike and Liversedge.

Adrian Ellwood and Elaine Jackson enabled us to become a Dementia Friendly Church.

Paul attended the Leading Your Church into Growth Conference in November with Leif Wilks and Elaine Jackson.

Chris and Katharine Taylor led a START Course in the autumn and Paul prepared Adrian and Jayne Ellwood for their Confirmation in February.

We held another Murder Mystery Dinner and continued with other foodbased services and events.

The closure of Oakwell Motel led to the Fellowship Area being used by High Riding Travel for their monthly promotional mornings, and the Oakwell Art Group for their weekly sessions.

After months of preparation the presentation visuals were upgraded which was only possible because of the dedicated work of Fred Lister.

Ann has continued as sacristan and Solly has been an effective verger for our funerals and burials.

During the year we said a sad and final farewell to Betty Naylor, to Fred Spurr and to Margaret Johnson.

Paul thanked Miles and Denise; Leif and Wendy and all the Pastoral Ministers; church members who fulfil a wide variety of ministry roles; and his wife Annette for her love and support.

He looked forward to the coming year, to growth in faith and in numbers and in facilities as the church seeks to be effective in ministry and mission, and for God's blessing in it.

#### REPORT OF THE PROCEEDINGS OF THE PCC

We have had six meetings this year with an attendance of 82%. There have also been two Standing Committee meetings.

#### **CHURCHWARDENS' REPORT 2016/17**

#### **FABRIC**

- 1 Fire Extinguishers had been services with the resultant that the extinguisher near the north entrance had been replaced.
- 2 The compressor unit in the main boiler had been replaced.
- 3 External CCTV camera has been fitted on Tower Room roof.
- 4 Repairs had been carried out to the Merlin stones on the Chancel roof.
- 5 The existing bracket for the Womens' British Legion Standard had been modified to allow the display of the Mens' British Legion flag.
- 6 Replacement of the visual system in church. LED screen and five new monitors had been fitted.
- 7 Dead leaves removed for paths and drains.
- 8 Weeds poisoned on paths around church and manually cleared by the steps on Kirkgate.
- 9 Faculties received:- for LED Screen, felling of lime tree and Sycamore adjacent to Kirkgate, felling of two Horse Chestnut within the graveyard, partial demolition and rebuilding of the damaged cartilage wall to Kirkgate, repair of boundary wall next to dam, installation of an external CCTV camera and the modification of the bracket to allow display of second standard.
- 10 Bell bearings on the second and seventh bells were replaced
- 11 New ropes were installed for the bells
- 12 Access to the church CCTV in the ringing chamber means that the ringers can see Brides arriving and departing or services starting so we can stop and start the ringing accordingly.

#### On going works

The reordering of the West End to include- new kitchen, new entrance and two new toilets. One being easy access for disabled.

Plans are being drawn for Access for All into church.

Working towards the rebuilding of the boundary wall with Longbottom wall to be rebuilt.

New carpet has been donated to the ringers and is in the process of being laid down.

A faculty is being prepared for repairs to our stained glass including the very fragile one in the vestry where we have identified some small holes. The church architect has called for previous reports on the stained glass which have recently been identified and we are looking to complete the faculty in the coming weeks.

#### General

A big thank you to Ian Cromack and others who continue their efforts in the graveyard. Special thanks also to the people who maintain the gardens around church.

#### **Awards for All**

We applied to the Awards for All Lottery funds for the work on 9 above. We have just received confirmation that they have awarded us £5984 conditionally and we have met those conditions. Once the money is in our accounts, we will get the works started. We will need some volunteers to help bagging up logs to be sold to help cover costs.

#### **PLATE**

The church plate is correct. Thank you to the Sanctuary Guild for their constant care in cleaning the sliver and brasses.

#### **FURNITURE AND FURNISHINGS**

These are in good state with the exception of chairs in the fellowship area which sometimes need repair.

We are grateful for all the help given to us by the Duty Wardens-Margaret Bell, Sue Charlton, Eva Lockett, Dave Chapman, Jonathan Keer and Raymond Gallagher who is Warden Emeritus.

#### **SAFEGUARDING - CHILDREN AND VULENERABLE ADULTS**

Much of the focus of the past year has been about embedding the changes to National and Safeguarding policies and guidance as well as a more pro-active approach to raising awareness.

I have continued to work closely with Paul, our Vicar, the Churchwardens, and our Diocesan Safeguarding Advisor, to address and manage any concerns raised.

A number of confidential Self Declaration Forms have been completed by new volunteers in the Church. DBS checks have continued to be updated, with some new DBS checks processed for new "helpers". We have made use of the DBS Update Service so that individuals with an existing check can "transfer" it instead of having to complete a second application. This has saved a lot of time!

On 1<sup>st</sup> April, the Leeds Diocese switched to a new "umbrella"

organisation, CCPAS (the Churches' Child Protection Advisory Service) for processing DBS checks. CCPAS will also provide additional support, training and resources as well as a 24 hour helpline.

However, DBS checks are only part of the picture! In September 2016, following approval by the PCC, the first meeting of St Peter's Safeguarding Forum took place. The Forum brought together nominated individuals who represented different activities across our Church, including Youth Church, Bridge Project, Messy Church, Bell-ringing, Playgroup, as well as both Sunday services, and pastoral ministry. The goal was to share different perspectives and any specialist interests and knowledge and to act as "champions" to promote safeguarding awareness.

The Forum has resulted in a lot of discussion and activities, including the design of a family friendly St Peter's Safeguarding Logo and plaque (yet to be unveiled), raising dementia awareness and developing role descriptions and application forms for new volunteers with Youth Church. This is in line with Safer Recruitment Policy. The pictures and details of the "champions" are on display in the Fellowship Area. Thanks to all of them for having given their time and energy! It is appreciated! My details are also displayed in the Fellowship Area, alongside contact details of our Diocesan Safeguarding Advisors. Please feel free to get in touch if you have any questions or concerns.

#### **BELLRINGERS**

Work continues on the bells and this will continue into this year we managed to on the bell bearings. Last year we managed to complete the 2<sup>nd</sup> and 7<sup>th</sup> bearings. This year the plan is to progress the 5<sup>th</sup> and 6<sup>th</sup> bells bearing replacements. Alongside this we are looking to replace the sliders with nylon centres which should make the life of the slider rollers much longer.

This year we have lost Denise but gained Jonathan Gibbs as a new ringer. Nicola Keer also joined us and she is doing a really well and enjoying it so much. However we have lost Jonathan Rhodes as he is under great pressure from teacher training and school placements. Alexander Lister is coming on really well and are hopeful for Jake Kennedy going forward. So we are as ever on the lookout for new recruits.

We have received donations from visiting ringers of £54.55 which is in the donations box. We are looking at using this to buy paint for the ring room walls and ceiling and to put towards the Yorkshire Association of Change Ringers membership subscriptions. We have received a new carpet via the generosity of Stephen Lister that is half laid and we will share photos for folks to see what it all looks like up there now.

We had 2 peal bands visit, one of which was the 1000 peal for one of the ringers. This is quite an achievement for each peal averages 3 hours of ringing for each peal.

We had the Yorkshire Association of Change Ringers hold their Christmas Event at St Peter's for the first time with ringing before a service of Carols and Readings for Christmas.

Local ringers have attempted a Quarter Peal of Stedman Triples on our bells – a complex method which unfortunately defeated us on this occasion. But we will try again!
