The Charity Commission approved the application in August 2015 and the gave the new CIO the **Registered Charity Number : 1162999**.

The Charitable Objects of the Leeds Philharmonic Society (CIO) are

"to promote, improve, develop and maintain public education in and appreciation of the art and science of choral and orchestral music in all its aspects by the presentation of public choral and/or orchestral concerts and by such other means as the Society's Charity Trustees may determine from time to time."

The main purpose of establishing the Leeds Philharmonic Society (CIO) was to legally establish a new Charitable Incorporated Organisation into which all the assets of Leeds Philharmonic Society Charity No 506467 would be transferred. Upon completion of that process the existing Leeds Philharmonic Society Charity No 506467 would be Dissolved in accordance with the requirements of the Charity Act 2011 and the Constitution.

MEMBERSHIP DURING 2015/16 and 2016/17

Since Richard joined us as Chorus Master in September 2013, we have been fortunate in attracting additional singers. As a result our numbers have grown as shown on this Table. It is great that we are attracting new Members, and it is hoped that Members enjoy the rehearsals that Richard is leading. But there is a need to reinforce recruitment and there will more during next season.

Our challenge now is to build upon the growth in membership and through successful recruitment campaigns attract new singing membership. Our goal is the try to get to 150 Singing Members by our Anniversary Season. Trustees will discuss ways of incentivising membership and also further outreach to the community of Leeds and West Yorkshire.

ADMINSTRATIVE MATTERS

During the early part of the Season 2015/16 we undertook a survey of member's relating to possible changes to the Rehearsal Time start. This would have move rehearsals from 7.00pm to 6.30pm on a permanent basis.

Whilst over 70% of singing members were happy with the potential change, about 25 % were unhappy and would find the proposed change challenging to the extent that they may have left the Chorus.

Trustees considered the responses and to leave the rehearsal times as existing given the potential loss of Members that could have occurred. In the event, the Chorus Master has been working with the Opera North Children's Chorus during Thursday afternoons not finishing until 6.30pm so would have found it very difficult to accommodate Auditions, Voice Tests and other aspects of administration.

Our main focusses this year have been to continue working towards the CIO, consider the long term financial arrangements for the Society and try to get into a position where we can attract an external Chairman. The existing Charity 506467 now has no assets associated with it – but the formal closure (authorised by last year's AGM) cannot take place until the Financial Accounts have been completed and verified by our independent examiners. The formal closure notice for 506467 will be presented to the Charity Commission during the coming Season (2017-18), and Members will be informed when the Notice has been served.

The Trustees have thought long and hard over the financial future of the Society and during this year agreed to enter a fund raising arrangement with an external partner, Caroline Taylor. Caroline has been working hard on the information pack, and the Without significant boosting of the finances – we are potentially looking at the closure of the Society within 5 years. That is why we are being rigorous in concert planning and ensuring that we do not commit the Society to huge expenses without considering the financial implications in detail.

We also recognise the importance of ensuring the members of the Society are safe and protected and can expect the highest standards from everything that we do. As a result we have adopted a "Safeguarding Policy" relating to our relationships with young and vulnerable people, which is now in operation. We are grateful to Paul Hunt and Jo Simms in the First Sopranos for working on the additional protocols that are considered necessary which include Disclosure and Barring Service (BDS) consideration of various functionaries within the Society. The final details of the protocols are in preparation and will be approved by Trustees at a future meeting and Members informed. The Business Plan refresh is still in preparation and it is expected that this that together with the Rule Book will provide a sound basis provided for the management of the CIO.
