#### BEARSTED & THURNHAM WI ANNUAL REPORT APRIL 2017

As our Centenary will be in 2018 we began the year by establishing an ad-hoc group to plan events for 2018 and also to organise fund-raising events in 2017 to raise money for specific centenary items. This together with all the usual activities that go on in our WI has meant a really busy year. Our membership currently stands at 94 full members and 3 dual members and our average attendance is 60 excluding visitors who come along each month and we have had 16 new members this year. We were also delighted to recruit three new members on to our Committee.

We have continued to support the Federation activities with members attending Craft Days, ACWW Lunch, Autumn Days, Winter Event and Taste of South America. We joined with Detling WI for their Fashion Show and had a really lovely outing to Windsor organised by them. We rose to the District £10 Challenge for Denman and ACWW and members were asked to donate to Denman each month. This year the Craft Group were asked to provide items for the Display Cabinet at Ethel Hunt Lodge on behalf of North Downs District which was displayed there for three months. Several of our members helped with teas at the Old Thyme Musical Hall in October organised by the Bearsted Parish Council for older people in the area and our Craft Group have made 63 dementia muffs for Maidstone Hospital to help people with dementia feel less agitated. Once again we had a stall at Bearsted & Thurnham Fayre and won second prize for the best dressed stall. We have raised the money via Kent County Council to install a Defibrillator in WI Hall and training has been given to members and other hirers.

In order to help New Members find out more about the activities in our WI we set aside part of our July meeting where all the group leaders were available to talk about their activity. The outings this year have been to Brighton Pavilion, an evening at the Hazlitt Theatre to see "Sweet Charity", and the Gardening Group have visited Hyde Hall, and Hadlow College garden. In November we organised a Cookery Demonstration by Julia Davis to get us in the mood for Christmas and were please that so many of the WIs in the District came. Our Christmas Party organised by our new members on the Committee was a huge success and much enjoyed by all.

Our Speakers have been wide ranging and varied. A talk by the Weald of Kent Hospice was very informative, My life as a Tiller Girl was great fun, and others have included Age UK Befriending, Mudlarking in the Thames and Antonia Gallop entertained us with her tales of "Travelling round India on a Motor Bike". The Art Group organised two Watercolour workshops and we were all delighted at what we produced. The Gardening Group has organised trips to gardens, garden centres and plant sales. The Walking Group continues each month finding ever more interesting paths around our area. The Mah-Jong and Whist groups continue to keep people's brains active. The three book groups have continued to provide us with entertaining and challenging reading. Members now take it in turns to organise the Lunch Club and Pudding Club. Once again our Drama Group entertained us at our Annual meeting with synchronised swimming and again at our social time in November with a Murder, Mystery play. More recently one of our members has produced a "Take Away" sheet each month which includes recipes, tips, crossword puzzle and word search for members to take home and read. All of these activities would not be possible without the members who kindly volunteer to organise them for which we say a big thank you.
