Summary of the main Activities undertaken For the public benefit In relation to these objects WAVE offers outdoor activity, teambuilding, confidence building, leadership, mentoring & volunteer training opportunities to those who are most disadvantaged in the Lancashire/ Greater Manchester Regions.

WAVE's main objectives are:

- To offer the most disadvantaged in our local communities opportunities to take part in activities which are healthy for the mind & body.
- To enable those experiencing social harm to make a positive contribution to their community.
- To work in partnership with relevant organisations with a clear focus on the well-being of a wide range of individuals.



Review of activities and achievements

WAVE has had its busiest year to date. 600+ people, including 200 vulnerable young people have benefitted from our programmes. A number of participants have found their involvement with our organisation to be lifechanging.

Beneficiaries have included:

- Those in recovery from substance misuse.
- Those who have experienced domestic abuse.
- Those with a physical disability
- Those with mental health issues
- Individuals from very disadvantaged backgrounds have moved on to volunteer within their communities, and a number have volunteered for WAVE and other organisations, for example Bolton College.
- Others have gone on to enrol on College courses.

Our aims for 2017

WAVE will develop its provision and increase the number of beneficiaries significantly in the forthcoming year.

Plans include:

- Increase participation in sport/activities for those living in the most deprived communities.
- Increase numbers of participants to 700+
- Increase numbers of young people accessing our service to 300+
- Increasing income generated through funding applications and more contracts.
- Employing a project manager on at least a part time basis.
